The Franklin Parish Police Jury met in Regular Session on Thursday, November 9, 2023, at 5:00 P.M. in the Police Jury Meeting Room, Courthouse Building, located at 6558 Main Street, Winnsboro, LA 71295 with the following present: President James Harris, Vice President Leodis Norman (5:03), Chaplain Gary Peters, Juror Howie Robinson, Juror Ricky Campbell, and Juror David DeBlieux. Juror Keiona Wesby was unable to attend.

President Harris called the meeting to order, followed by roll call.
Chaplain Peters led the assembly in prayer and the pledge of allegiance.
The motion to approve the agenda and supplemental agenda was offered by Campbell, seconded by Peters, and passed.
Campbell offered the motion to approve the minutes of the October 17, 2023, regular meeting and October 17, 2023, and October 30, 2023, special meetings. Peters seconded with all voting in agreement.
The jury discussed entering into a cooperative endeavor agreement with Mr. Billy Beach for concrete material. The material available is in sizes too large for the public works department to use without having to crush. DeBlieux offered the motion to deny entering into a cooperative endeavor agreement with Mr. Beach for the concrete material.
Mr. McManus advised the jury that the Riley Rd. project will be submitted to facility control this upcoming Monday and the bid opening for the Abe Lincoln/ Horace White Sewer System Improvement is set for November 14th.
Mrs. Carol Pinnell Allison provided the jury with the monthly LSU Ag Center

update including information about the status of agricultural crops throughout the parish.

The motion to approve Resolution 810 – Regarding an installment purchase agreement for the purpose of financing a “cat dozer” was offered by Campbell, seconded by Peters, and was unanimously passed.
DeBlieux offered the motion to approve the beer permit renewal for Jonesy's Trak. Campbell seconded with all voting in agreement.
The motion to approve Resolution 811 – in support of the Southern Spirit Transmission Project was offered by Peters, seconded by Robinson, and was passed unanimously.

Resolution 812 – Canvassing process for the October 14, 2023, election was approved by motion of Campbell, second by Peters and was passed.
By motion of Norman and second by Peters, the jury voted to use the remaining funds from the payback of the material taken off Cooter's Point Rd. to fog seal for dust control the area of Cooter's Point Rd. as requested by President Harris. Motion passed. Yes: Harris, Norman, Peters, Campbell Nay: Robinson, DeBlieux.
The motion to approve the dust control for Mr. Horace Robinson at 185 Williams Rd. was offered by Peters, seconded by DeBlieux, and passed.
The motion to have Jimmie Spears, Bobby Arnold and Stephen Smith attend Chemical Response Training November 28th at the Hampton Inn West Monroe 8am. – 5pm. Was offered by Peters, seconded by Campbell, and passed.
The motion to approve Spears, Erskin, Ross and Guthrie attending the Heavy Equipment Safety and Maintenance Course on December 14th at Cheniere Lake Lodge in West Monroe was offered by Campbell, seconded by Peters, and passed.
Peters offered the motion to approve advertising for a full-time laborer. Campbell seconded with all voting in agreement.
The motion to table a decision about advertising for the pay roll/HR position was offered by Campbell, seconded by Peters, and passed.
By motion of Campbell and second by Peters, the jury unanimously voted to approve fog sealing Clyde Weems Lp., LD Knox Rd., Lawson Rd., Pine Prairie Lp., Roberts Rd., Calhoun Rd., and Ellis Ln. in the order they were chip sealed. Pending the availability of materials.

The motion to purchase the chassis from Bunker Truck Sales (only quote received) in the amount of \$92,659.00 was offered by Peters, seconded by Campbell, and passed.
Campbell offered the motion to approve applying for the purchase of bush hogs and tractors through LGAP for 2024. Robinson seconded with all voting in agreement.
The motion to approve the following verbiage to the existing Culvert Permit was offered by Peters seconded by Norman and unanimously passed.

The replacement of residential culverts exceeding 30ft. and non-residential culverts exceeding 40 ft. will be the responsibility of the property owner to replace when the parish is performing road and/or drainage maintenance improvements in the location of the existing culvert(s).
Mr. Hodges spoke to the jury about not taking the eastern end of Low Water Bridge Lp. out of the parish road system due to non-maintenance. Campbell offered the motion to approve holding a public hearing for the consideration of removing 1929 ft. of Low Water Bridge Loop from the parish road system. DeBlieux seconded the motion. The motion passed unanimously.

By motion of Campbell and second by Robinson the jury unanimously approved for the drainage crew to complete the needed ditching of the entire North Central Church Rd. and it is to be scheduled ASAP.
By motion of Robinson and second by Peters, the jury unanimously approved the dust control request of Ms. Mary Robinson at 462 Heath Rd.
By motion of Peters and second by Campbell, the jury unanimously approved the dust control request of Ms. Bessie Harrison at 292 Jericho Rd.
By motion of Campbell and second by Robinson, the jury unanimously approved the dust control request of Ms. Barbara Underwood at 242 Underwood Rd.
Approval to send right of way obstruction ordinance violation to ADA Kramer for the enforcement of penalty fees for noncompliance was offered by Peters, seconded by Campbell, and passed.
The superintendent provided the jury with his monthly Superintendent's Report including Superintendent's notes and Road Repair List. Campbell offered the motion to approve the Superintendent's Report as presented. Peters seconded with all voting in agreement.
The treasurer provided the jury with her monthly Treasurer's Report including the Profit and Loss vs Actual for all budgets and proposed budget amendments. Peters offered the motion to approve the Treasurer's Report and proposed amendments as presented. Campbell seconded with all voting in agreement.
The jury asked that the treasurer budget for next year to purchase a 55-gallon drum of Delta Foremost's weed killer.
Peters offered the motion to approve the letter of interest to DOTD for its Thriving Communities Program. Campbell seconded the motion. The motion passed.
With there being no further business to discuss, Norman offered the motion to adjourn. Peters seconded. The meeting was adjourned.
