BUSINESS MANAGER REPORT

Mrs. Bouquet reported to the board that at this time the business office is in the process of updating the salary schedule. This will be done to correspond to the 4-day week and to add the increase in pay given by the governor. The Robinette firm is finishing on the schools’ audit report. They will be here August 3rd, meeting with the principals and going over their audit reports. It will be around October, November before we get the printed copy of the audit report. Postlethwaite and Netterville will be here in the office in September. Before that time, we will upload required documents for their review. We are working at this time finishing up on journal entries, closing out the previous year. I am predicting the year will close out in the positive.

SUPERINTENDENT’S REPORT

Superintendent John Gullatt reported to the Board that since summer school has finished we are now playing catchup on waxing the floors and cleaning the campuses. As of now, the CDC has not sent out any guidelines for opening the schools. I think it will be similar to summer school. The students will be required to wear masks on the bus. We are starting to put up a 10 ft. fence between the high school and the school board office. it will stay locked, so students will not be able to go through the area as a shortcut. During summer school we had over 600 students, with that we had one case of the virus.

PRESIDENT’S REPORT

The school board president, Mr. Richard Kelly, expressed his excitement on the coming year and reminded everyone to be mindful of your surroundings. Mr. Davis thanked Mrs. Sheppard for coming to the board meeting. Dr. Johnson announced that there are new programs that will be available this year at Delta. This will be a win for our students. The next meeting will be as follows: July 26th will be the agenda meeting and the regular board meeting will be August 3rd.
