# Rogers named SEC top player

**SEC Players of the Week'**  
**CO-OFFENSIVE**

Will Rogers, QB, Mississippi State  
Threw for 395 yards with 31 completions and three touchdowns to help lead State to a dominant win over No. 25 Arkansas.

Broke the SEC career record with 946 completions in just 28 career games (Previously held by Aaron Murray, who had 921 completions in 52 career games).

Posted the highest passing grade among SEC quarterbacks according to PFF (81.7)

Had no turnovers for the third straight week.

It marked the fifth time in six games this season he has passed for more than 300 yards.

Jonathan Mingo, WR, Ole Miss  
Broke the Ole Miss single-game record for receiving yards in leading the Rebels past Vanderbilt.

Hauled in nine passes, including two TDs, for 247 yards, which broke Elijah Moore's 2020 record of 238 yards also at Vanderbilt.

The 247-yard performance stands as the 13th-best single-game performance in SEC history and most in the FBS this season.

With 72 and 71-yard touchdown catches, he is the first Rebel receiver to record multiple TD receptions of 70 or more yards in the same game since A.J. Brown collected scoring grabs of 77 and 71 yards against South Alabama in 2017.

**DEFENSIVE**  
Jaydon Hill, CB, Florida

In his second game back from injury, Jaydon Hill recorded two interceptions, including a 49-yard interception return touchdown in the first quarter and an interception to halt Missouri's drive deep in Florida territory.

They were Hill's first-career interceptions and first-career touchdown.

Chase McGrath, PK, Tennessee  
McGrath drilled 4-of-5 field goals and converted all four of his extra points in a stellar special teams effort as No. 8 Tennessee beat No. 25 LSU for the first time since 2005 by a score of 40-13.

### VILLAGE OF RIDGECREST COUNCIL MEETING (MINUTES) SEPTEMBER 13, 2022

- 1)Mayor Veller Ray Carroll called the meeting to order at 6:00 pm.
- 2)The Invocation was led by Alderwoman Mitzi Bolyer.
- 3)Mayor Carroll led the Pledge of Allegiance
- 4)Roll call was conducted. Present: Alderwoman Deb Barrett, Alderwoman Mitzi Bolyer, Alderwoman Darlene Humphries and Mayor Veller Ray Carroll.
- 5)Mayor Carroll opened the meeting for public comments on the agenda items. No public comments, Mayor Carroll closed the floor.
- 6)A motion was made by Alderwoman Mitzi Bolyer seconded by Alderwoman Darlene Humphries to approve the minutes for the August 9, 2022. Motion passed and carried unanimously.
- 7)A motion was made by Alderwoman Darlene Humphries seconded by Alderwoman Deb Barrett to approve the CPA Report for July 2022. Motion passed and carried unanimously.
- 8)A motion was made by Alderwoman Mitzi Bolyer seconded by Alderwoman

Darlene Humphries to approve the Clerks Report for August 2022. Motion passed and carried unanimously.

9)Mayors Report: The dump, we are getting a lot of trash back there so we went and got cameras to catch them. We will put up signs saying that they are being videoed and will be prosecuted. Alderwoman Barrett asked, "what are they dumping back there" the mayor replied, the first load was boxed stuff and I have an idea of where it came from but I cannot prove it and it did come out of Ridgecrest. The second load is boards from an old wooden fence. A big load, a lot of it is gone cause people picked it up and hauled it off. Charlie Brown got a bunch of boards out of there, it was good boards that people dumped, but they cannot dump it back there its going to cost to shut it down and if I shut it down, I will have to put gates up there. Alderwoman Barrett asked "but it's actually limbs aren't it," Mayor replied, "limbs only got a big sign that says limbs only and I hope to get the cameras up this week. We got to do a budget next month, October on the fiscal year 2022 last quarter. Will have that on the agenda for next month. Next month is October-November 8th being election date and our council meeting. I need to make a motion to move to Thursday 10th at 6pm instead of Tuesday 8th. Do I have a motion to move from Tuesday to Thursday or do you ladies need to think about it. We can look at it again next month. Ok we will table it until next month and put it on the agenda. Alderwoman Bolyer stated she would make the motion, Motions been made-first and second all in favor. Motion passed

10) New Business  
A) Change pay period to bi-weekly instead of current weekly pay period: Mayor stated he wanted to go to every two weeks, it will reduce some of the check signing, be a lot easier on the clerk, we will just pay out every two weeks except for the first of the month checks, they will be issued on the first still. Regular checks, paying employees and vendors. Alderwoman Bolyer stated, we only have two employees that only eliminates two checks. Alderwoman Barrett, well I do not think that two employees will make a difference and they are used to getting their checks. Mayor states, "we have an employee here let us ask her opinion. What do you think about it I am asking you? Clerk replied, "to get paid every two weeks? The mayor stated, "yes every two weeks," Alderwoman Bolyer asked, "what do you want," Clerk replied, "every week is fine with me," Mayor stated, "you want every week, that is not what you told me! Clerk replied, "no what I told you was if you guys voted it, I did not have an opinion. Alderwoman Humphries replied, "well he is asking your opinion now! Clerk replied, "and I just gave it to him." Mayor stated alright, Alderwoman Barrett asked if we are going to leave it at every week, mayor replied we are going to leave it alone.

B) Quote from Wesley Douglas for repair of the roof and sides of Police building: Wesley Douglas lives here in town and he is a carpenter, he is going to go down there and fix the police department building up, take the roof off, replace all rot boards and put new galvanized tin up. Alderwoman Bolyer states, she makes a motion on the stipulation that he gets a business license. In order to do business with us he needs a business license. He has one for the parish states the mayor. Alderwoman Bolyer makes a motion, mayor asked if seconded, Alderwoman Barrett second, mayor states all in favor. Motion passed unanimously.

C) Fire Department contract (per contract-service firetruck-keep lawn cut): I had a long talk with the chief and I got the contract right here in front of us. The contract reads, "as long as they have a full-time employee there, they will keep the grass up and things, but they do not have a full-time employee there. We got two choices, continue going like we going or rewrite it. Alderwoman Bolyer asks where does it state that they are to come and do. Do they flush the lines? Mayor replied yes. Mayor reads part of the contract, "the building will be maintained and grass cut, etc. by on-duty man. I am not going to argue, I understand where you are coming from. Alderwoman Humphries replied, it also says here on number 5, states that someone should be there. Mayor states, right if they can afford it. Alderwoman Bolyer states, we are paying \$8k, and now they do not want our truck and our equipment and we are still expected to pay eight thousand dollars. They are not doing what they say so I say we renegotiate with them. I just do not get it. Mayor, if we renegotiate, I cannot quote what he told me. If we pull out it can cost more for a new contract, we end up having to cut the grass, maintain the truck and they still will get up on the price \$10k-\$12k. I want you to weigh the facts. You are all asking these questions, I can call a mandatory meeting next month and he can answer then. Alderwoman Barrett asked to have number two explained (2. By donating trucks and equipment, relieves town of cost of insuring apparatus, maintenance of apparatus and associated equipment such as SCBA, SCBA bottles, and any other expendables associated with maintaining the equipment), the Mayor stated number 2 on the last page. Alderwoman Barrett replied, yes and are we donating the truck and equipment, Mayor states, yeah. It still belongs to Ridgecrest but is donated for them to use. In other words, they can come and get something from it and use it on one of their trucks and bring it back. They also pay the insurance on that truck every month. We pay the light bill and cut the grass.

11) There being no further matters to discuss, a motion was made by Alderwoman Bolyer, seconded by Alderwoman Barrett to adjourn. Motion carried unanimously.
