LSU releases men's basketball schedule

BATON ROUGE – The Southeastern Conference and its television partners announced the 18-game league schedule for the 2019-20 season on Tuesday.

In total, with nine home conference games, the LSU Tigers will play 17 times at the Pete Maravich Assembly Center.

Season ticket information for the defending Southeastern Conference champions can be found online at www.LSUtix.net.

LSU will face 14 teams in the regular season that advanced to post-season play a year ago.

The Tigers will open conference play on the road in their only regular-season meeting with Tennessee in Knoxville in a game televised on ESPN2 or ESPNU at 11 a.m. CT on Saturday, Jan. 4.

LSU's first SEC games for 2020 at the Maravich Center will be when the Tigers host back-toback contests against Arkansas on Abdul-Rauf in halftime cere-Wednesday, Jan. 8, at 8 p.m. (ESPN2/U) and Mississippi State (Saturday, Jan. 11, 7 p.m. ESPN/2/U).

There will be two special events at the Maravich Center in February. LSU will celebrate the 50th anniversary of Pete Maravich breaking the NCAA career scoring record on Saturday, Feb. 1, against the team Maravich broke the record against, Ole Miss. The game will be at 11 a.m. on ESPN/2/U.

On Jan. 31, 1970, Maravich broke the NCAA career scoring record of Oscar Robertson and on Feb. 2, 1970, became the first player in NCAA history to pass 3,000 career points.

Then in LSU's next-to-last home game on Feb. 29, at 11 a.m. against Texas A&M, LSU will retire the jersey of Mahmoud

monies. Abdul-Rauf under the name Chris Jackson had a spectacular two-year career at LSU (1988-90), setting an NCAA freshman scoring record of 30.2 points a game during the 1988-89 season. The 50-year-old, who was named SEC Player of the Year in both LSU seasons, is continuing to play basketball successfully professionally in the BIG 3 league.

LSU's other league home games include games against Florida (Jan. 21), Alabama (Jan. 29), Missouri (Feb. 11), Kentucky (Feb. 18) and Georgia (March 7).

LSU will play Alabama, Arkansas and Texas A&M as usual both home and away, in addition to Ole Miss and Florida.

In addition to these five opponents and LSU's league opener at Tennessee, the Tigers are scheduled to travel to Vanderbilt (Feb. 5), Auburn (Feb. 8) and South Carolina (Feb. 22). LSU was a perfect 9-0 on the road in league play last year.

The Tigers, winners of 28 games a season ago and advancing to the NCAA Sweet 16, will open the third season of Coach Will Wade's tenure at LSU on Friday, Nov. 8, at 7 p.m. against Bowling Green in the Maravich Center. LSU will have eight home games in the month of November and December prior to conference play.

LSU and Louisiana Tech will play a special NCAA-approved exhibition game in Ruston at the Thomas Assembly Center on Saturday, Nov. 2, to benefit the recovery efforts in Ruston and on the Louisiana Tech campus from a tornado that struck the area in April of this year. Tickets for that exhibition are available on the Louisiana Tech website.

The Tigers will also have important road non-conference games at VCU (Nov. 13, 5 p.m., ESPN2) and in Los Angeles at the Staples Center (against USC) on

Saints win thriller in opening game

leans Saints

Love the win. Love the drama.

But it wasn't unconditional love that the New Orleans Saints had for their 30-28 victory over the Houston Texans on Monday night, a last-second thriller in the Mercedes-Benz Superdome that was decided when Wil Lutz's 58yard field goal sailed through the uprights as time expired.

There were a few glaring deficiencies for New Orleans in its season opener, some areas of concern that partly were attributable to playing a quality opponent, and partly were due to some physical and mental lapses by the Saints.

There's work to do, and an abbreviated week in which to do it. OFFENSE: The final numbers are exactly where you'd want them to be: 510 yards, 7 of 11 on third down, 148 rushing yards and a touchdown on seven yards per carry, 74 percent completion percentage for 370 yards and two touchdowns. But New Orleans was 0 for 2 in the red zone in the first half, including an uncharacteristic interception by Drew Brees inside the Houston 5-yard line, and the running game was stuck (21 yards on six carries). The tale of two halves looked like this for the second half: 329 yards, three touchdowns, two field goals, 2 for 2 in the red zone, 127 rushing yards and a game-winning drive. You figured the unit would rise to the occasion, and it did, but it'll want to better take advantage of early red zone opportunities. DEFENSE: Houston put up three consecutive touchdown drives, spread over the second and third quarters, which traveled 94, 75 and 75 yards. Then, with the Saints protecting a 27-21 lead with 50 seconds left, New Or- out of his system.

Michael C. Hebert/New Or- leans surrendered a two-play, 75yard touchdown drive that lasted 13 seconds. The Texans had a stretch of four conversions in five third-down attempts, and they moved the chains on third-and-6. third-and-8 (defensive holding), third-and-11, third-and-8, and third-and-10. Collectively, those scenarios should tilt in the defense's favor, and New Orleans absolutely has to be better at getting defensive stops in those kinds of down-and-distance situations. The 13-second, 75-yard touchdown particularly was disturbing. The positives were that New Orleans punished Texans quarterback Deshaun Watson (six sacks, 11 quarterback hits and an interception) even while Watson was completing 20 of 30 passes for 268 yards and three touchdowns. The run defense was too leaky (Houston had 180 yards about 100 more than the Saints allowed per game last year - and a touchdown on 23 carries) but Marcus Williams' interception proved to be huge for the Saints. New Orleans simply wasn't able to make Houston one-dimensional, and that was problematic for the defense.

> SPECIAL TEAMS: Wil Lutz missed a 56-yarder to end the first half, but all is forgiven when you nail a 58-yard game-winner. Thomas Morstead is elite; two punts for a 44-yard average, including a 53-yard, coffin-corner job in the fourth quarter that went out of bounds at the 4-yard line and should have brought a smile to Ray Guy's face. Deonte Harris showed his inexperience. He got his 4-yard line when Houston and later gave an invalid fair catch signal the next time he fielded a punt, to push the offense back inside its 10-yard line. The Saints are hoping that he experienced a couple of months of growing pains on Monday night and that those kinds of plays are

ULM opens the season with back-to-back home games, hosting Louisiana College in the season opener on Nov. 5. Four days later, the Warhawks host Alcorn State for an 11 a.m. tip-off on Nov. 9, ahead of an afternoon kickoff for ULM football vs. Georgia State.

Brushy Bayou: A meeting is scheduled for Tuesday, August 27, 2019 with the Fifth Levee District to review and revise the Cooperative Endeavor Agreement. This is needed for USACE to approve the 408 permit and continue to work on the process to approve the 404 permit. Mr. Lipsey with the DA's office is working with Brant Jones of JKS on revised right of ways and easements to execute.

Courtroom Renovations: Bids were opened and Wilmar Construction has been awarded the bid based on approval by the State. The "Request for Concurrence" to award the bid has been submitted to the FP&C department of the Division of Administration for a review and approval. Once this step is complete a "Notice to Proceed" will be issued. This should take about thirty days. The goal is start on the project by October 1st and will have 120 days to complete.

Washington Heights: Bid opening was held on August 13th. The bids came in slightly higher than the allocated funds. The Parish has 45 days to award the bid. Ms. Burley has reached out to the Delta Regional Authority on the status of a grant that would help offset the funds needed in which to award the bid. Per DRA, the Parish would know more by the end of September if a grant was awarded to the help with the project.

Vidalia Canal: Mr. Guillory updated the Jurors that spraying has begun. The barn staff will be moving the long stick to start clearing out the ditches again.
