TOWN OF CLAYTON
Town Of Clayton Water System is currently in violation of the maximum contaminant level (MCL) for total trihalomethanes as set forth by the State [Part XII of the Louisiana State Sanitary Code (LAC 51:XII)] and the Federal Primary Drinking Water Regulations (40 CFR Part 141).

The United States Environmental Protection Agency (EPA) and the Louisiana Department of Health (LDH) set drinking water standards and requires the disinfection of drinking water. Where disinfection is used in the treatment of drinking water, disinfectants combine with naturally occurring organic and inorganic matter present in 'water to form chemicals called disinfection byproducts (DBPs). EPA and LDH set standards for controlling the levels of disinfectants and DBPs in drinking water, including trihalomethanes (THMs) and haloacetic acid (HAAs). Some people who drink water containing THMs in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer.

In December 1998, EPA set enforceable drinking water standards for TTHMs at 80 parts per billion (ppb) and for HAA5 at 60 parts per billion (ppb) to reduce the risk of cancer or other adverse health effects. Compliance with the TTHMs and HAA5 standard for public water systems serving less than 10,000 individuals initially became effective and enforceable on January 1, 2004. Compliance with the TTHMs standard is determined by calculating a locational running annual average (LRAA) of quarterly TTHMs sample results. Compliance calculations performed for the second quarter of 2021 show that the system's current TTHMs LRAAs are 142 ppb at DBP02- 154 CARTER and 84 ppb at DBP03- LOOMIS ST; Thus, the system is currently in violation of the TTHMs standard.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

This is not an emergency. If it had been, you would have been notified immediately. EPA and LDH do not consider this violation to have any serious adverse health effects on human health as a result of short-term exposure; however, continued long-term exposure to TTH.Ms and HAA5 levels above the standard (e.g., 20 years of exposure) has the potential to have serious adverse effects on human health.

Alderwoman Barrett - I need to add something to Agenda Dress Code I like what I have on, these stretch pants and little shirts don't get it. We need to set up a dress code. All in favor, motion passes. Mayor , add it to new agenda.

Public Comments- None
Approval for minutes for February 9, 2021 motion been made. All in favor, motion passes.

Clerk's financial report for February, 2021. I have a question what is the \$50 under Rents. Mayor said it for chlorine balls. Mayor, I had a question on the phone bill. The phone bill is getting ridiculous it's \$1000.00. Where is that at? It's on page 1. We will be looking into getting a new company. John's phone is cut off right now. Jamie - AT&T keeps raising the rates and it's every 6 months. They don't say anything then it's over \$500.00. Is that just for the phones.Mayor yes that is for the bill here and John's. Mayor- It's 922.63. How much was it running last year do you remember? Jamie- It went up to that I called them and got a discount and it was almost \$300.00. So that is includes 3 lines? Jamie - Yes Mayor No we only have one line, fax, and internet. So,John don't have a phone? Mayor- It's been cut off and she (Jamie) paid it. They say it paid and he said it been cut off and I tried to get a hold of him several time today and couldn't. I have Swift Connect and it's \$50.00 a month. Jamie - John was saying something about them and they are not like the Media 3 was. It's same as Media 3 and I only pay \$50.00 a month. Get one line for fax machine and get the Clerk a cell phone. Get a cell phone its cheaper than it is to pay this. We have to have a line for the fax. Well yeah that is what I said one line for the fax. Mayor - I called Hughes Net. Hughes Net is ridiculous. Mayor-That was just a company and he gave me some options. They done have a fax line at Hughes Net but this other companies out there. I thank ya'll or some needs to check into it and see if we can get a better deal. I'll check with Swift Connect. Mayor - If ya'll got somebody maybe ya'll can check. Jamie Maybe ya'll can look with AT&T for another reduced rate. Can't you just have one line for town and if you hear it was a fax you just hang it up. That's what I use to do. Jamie - Ma'am? Mayor-we trying to keep it under a \$100.00. Jamie - Keep changing it and you have a business package. They won't keep the contract but for 6 months. Then you have to rev and they then offer a lot of free stuff for you to get. The last time it was like a T.V. package.For me to get it that cheap I agreed to the package. Are we under contract now?Jamie - No we are not. We are out

now.Mayor -Are you going to handle it Ms. Bolyer? Alderwoman Bolyer - I can handle it or Deb said she could handle it. Mayor-ya'll two. I can call Swift I have nothing to do. Cellular Consumer or Cellular has a phone for \$23 flat rate I just got one.That includes your gigabytes and everything. On a flat rate. Mayor - I have two phone and internet and email for \$80.00 a month. I can get the 3rd one for a \$100.00 a month. You will have to have your dedicated line for a \$100.00 a month. How much do we fax? Jamie - Not as much as we use to. So, if we had one line you can use the fax when you need it and we can have one line rollover. Jamie -yes Deb was talking about that it would work. We don't get as many so that would do. Mayor-Ok Ms. Deb you look into that and Ms. Bolyer you look into the other part. What do you want me to look at? Jamie - the Swift. On ok. Yeah, that is fine.

Mayor- is there anything we need to talk about. Yes, I have something. On the outside services for \$400.00 what is that? Mayor - We got Dennis to come up here and clean the roads to get to the store. Ya'll can see what he done. Also, for the emergency vehicles Yeah that was good Dennis. Dennis-Thank you ma'am. Mayor- a lot of vehicles come in and whatever we need he cleans them. I also have a question about the garbage and things. Do you know about how much longer we have on the contract Jamie? Jamie - I think this is the last year. They do nothing and they leave as much trash as they pick up. If you get this other company that just came in to Natchez. They pick up toilets and anything by the road. It might cost you a little more on your bill. Jamie - Instead of paying \$4.50 you might have to pay a little more the town may have to up it a little bit. You may have to up it to get a better service or what. For instance, the trash tech this morning across the street 4 cans of stuff fell out of there dumpster. They didn't bother to pick up. They will not pick it up, the refuse to pick it up. Jamie, you don't know what month do you? I think it's the middle of the year. Mayor- No talking No talking. Jamie I have the contracts in there in the top drawer. They still had it listed as Waste Management so just kept it in it. Do you know the company or how much they charge? Jamie - It's Arrow disposal Inc.

Mayor- what we can do is get a bid. Jamie - what they will do is come out and do a package. We need to call and come out and see what they offer. Mayor-We need to see when he can come over and talk to the board. Jamie - I think is name is Wayne. He is really nice. He did a whole proposal and brought before the board saying what he would and wouldn't do and how much. You will have to request him for that part. I need someone to pick up everything. If Waste Pro would have came in it would have cost an arm and a leg. Jamie - Waste Pro came in and undercut everyone so pretty much everyone has gone with Waste Pro. I know Ferriday did and the PoliceJury did. Righ t now, the Police Jury is not liking them and I told them beforehand they were not going to like them. The Police Jury is holding back some of there money because they are not getting what they pay for. Jamie, they have completely gotten worse when they got everybody. Arrow Disposal is from Jackson they are around here. They got Natchez contract. That is why he comes to see you. They are in the area and they have a dump aroundhere. His proposals were-good for Ferriday. Mayor - We need to get back with them and have them on the agenda for next month and present a proposal for next month. I know they can't do it until the contact runs out. I called Waste Pro and they told me No we are not coming to pick up limbs all over the place unless we paid somewhere between \$1800.00 to \$2000.00 or something like that. Mayor - I have two proposals sitting here but we not going to get into that right now. I don't want to give it out right now. Is that all the Financing? So. the professional fee its \$3183.60. Jamie - That is sewer and water. That is both. I make a motion. Mayor - motion has been made. Do I have 2nd? I will 2nd , all in favor motion passes.

Mayors Report - Winter Storm. The winter storm was tuff we had 3 bad weeks and two weeks was really bad and one bad it was terrible. Everyone went trough the same thing. We had a lot of limbs down through town. We had a man to come in a donate 8 hours with a grabble. We worked on Apple, Carter and Vidalia Dr. I got a proposal from Waste Pro for \$340.00 per ton to pick it up and that is everything. I am going to give you an example. In front a mans house a big tree that fell that tree is 6 or 7 tons right there. Dennis come in and show us your proposal. Along with the financial status of Ridgecrest yard. Dennis Cooper donated that grabble. We tried to do as much free as we could to help the Village out. Alderwoman Bolyer -we appreciate it. With that being said I put another proposal through . I will pick up all the limbs and pick up everything and haul them to your dump site. We not going to haul to Mississippi because we on a time restriction to get as much done for \$1200.00 a day. Alderwoman - How many days do you think that will take? Dennis- I figuring a day after that it will be \$150.00 an hour I'm guessing. Alderwoman - a day Dennis -yes,a day. Alderwoman -for \$1200.00. The town won't have to touch it. No one will be involved no volunteers no will be involved. I might have to get the Police Chief for a little bit of a road blockage. That is everything I can as long it's on the road. We not going into people's residence. Alderwoman - I got mine right here and here is the ditch. Dennis - we are not going in yards. Mayor - Can I get a motion to get D& M to pick up limbs for minimum of 2 days. Alderwoman ,Bolyer-I make a motion for 2 days or less. Alderwoman Humpries - I will 2nd

Mayor - if its not at the road and on your property, you will miss out. He can't cross that ditch. Mayor - I'm going to read this letter. The Village of Ridgecrest will like to thank all the citizens who help during the storm. Special Thanks to Jimmy Wilkerson, for getting us the generator. Mr. Barnhill and his son for working on It and getting It up and running. Concordia Parish Jury for lawing with the help of homeland security. Dennis with D&M along with Dennis Vanyard for the Road grader. Lonnie Graham, Kevin Graham for cutting limbs and cleaning the trees so we could get up and down the road. Keiser Electric for coming out and helping, Connie and Jennifer Adair for delivering water. Tab Harris for keeping everyone informed of what I asked to put on her website. Dennis Cooper, Big B sales for donating a tracker and grabber and Dennis Mulvihill for coming with equipment and cleaning the Village. Special Thanks to JCP, Matt Parker, James Cockerham and also John Smith for a great job and the work and time he has put in to. It was a group effort.

Thursday and Friday, we got intermission coming In to rate us again. We are a 6 now we are hoping to get to a 5. We may have to open a couple of water hydrants. We are hoping not to. Just be prepared for your water to be a little brown. We will do that the 12th and the13th• Alderwoman -that is for the fire rating? Mayor-Yes that is for the fire ratings. Next year we will flow every hydrant and we should get down to a 4 with the new water system being in place. Alderwoman - what if your water is still brown and have not cleared up yet. Alderwoman- That's Thursday and Friday? Mayor-Yes that is Thursday and Friday. Mayor-you had that leak and it may have tore something in your house. No, it's been like that since the water came back on. It never cleared up and my bath tub is like pee. I'm waiting for It to finally work its way through. Mayor-I'll come check it.

Mayor-Request for release of funds on the grant. The grant are ya'll aware its \$960,000 and \$225,000 from the EPA. Now we posted this last week and the 22nd it comes off. Then we go to bid. All this is up to date and its environmental studies is what it is. Yes Connie. Connie - I thought the grant was for more than that. Mayor- No the grant is for \$960,000 am I correct? The other grant is for \$225,000. Connie- I thought we was approved for 990 something. Mayor - No that was the Loan we were borrowing. Connie - That was the Loan? Mayor- I need you to write what you want up and present It to the board for next months meeting in the mean time I will tell the clerks to wear something decent I just have to do it in the right way. One time we had clerks up here wearing shorts. I say leggings. Yes, you can have leggings and boots. Although there are certain kind of leggings. You are talking about the one with the sheer down the side. That type of stuff. Mayor- We will put on the agenda.

FEMA you have it in your folder. FEMA is going to reimburse us. Total bill was \$8,714.15 paper DR 4590. They are going to reimburse us 75% which is \$6535.61 and 25% taken off that 8,714.15 is 2,178.54. We have to pay the cost of getting all this done to the Parish Police Jury out of the \$6,535.61 that amount is \$435.71. Alderwoman Bolyer- I think that is great. That is money spent during the Ice Storm and that is that break down. At the bottom is the Categories and each category like labor and different things. We did a zoom call and got it all straight. We will get most of our money back. Alderwoman Deborah Barrett- What Is the number F contract? We paid JCP 36 something for setting up all night for 4 nights with me.We getting that money back we picked up the limbs we getting that money back. It was 27 something on limb pick up. The other was like 2,000 something over the cost of what they done that month. The paper you have is the American Rescue Plan Act of 2021. If you look on the last page, it says Ridgecrest town that amount says \$222,342.00, they plan on giving us. I talked to the Parish Clerk, Ms. Sandy Burley. today or I had Hiedi reach out to her because I could not get her..I did want to call her on her cell but she did. The money has not made it to the State. They are still coming down on how we are able to spend the money. We don't know what we can do with it yet. That package I gave you says on the 4th page says what you can spend it on. You can read a lot into that. Alderwoman Bolyer-what page Mayor-4th page. It looks like this. That's what they said when they passed this out on what you could spend the money on. Different things you could do with it in the departments. As far as water, sewer, infrastructure, we can give a certain amount to the people. We got a couple Ideas and if we can I would like to give the people of it back on their water bill..I would like to buy a tractor and a grabber. If we ever have weather like this, we are set up to do it ourselves. Alderwoman Deborah Barrett- When you say the people do you mean the people who did think they didn't have to pay their water bill during this time?

Mayor-no they have to pay their water bill. What they will do with will be a board decision. We will have to vote on it. Different towns are doing it different ways. I spoke with different town that are going to rebate back to their bill not directly to the people. Let just say If we do \$100.00 a house that's \$25,000.00. That will be paid on their bill. Each home owner that was here during the ice storm will get, a \$100.00 credit. That could be a month or a month and a quarter or a \$100.00 on what they owe. So, there are different ways we can spend it. There are rules and regulations we are going to have to check into. That's coming we have not gotten anything as of today. The Grant is also coming. The time limits from the Government. I made calls and can't get anyone on the phone so we just waiting on email to say go out for bids. We get that hopefully this week. Joe as soon I get it, I'll let you know. That's where we are on that. Alderwoman Rita Bolyer- I'm excited. Mayor-on the grant it's \$960,000.00 and it's \$225,000.00 on the second grant. That is going to tie into the 1st grant. That replaces all the meters to be changed out. The first thing we have to do is tie into the line and build a new sewer tank and all that. Then this extra \$222,000.00 will be what we can spend it on. We applied for a \$25,000 grant for a sewer lift station to buy new parts for It and rebuild the one on Ferriday Dr. like we did on Vidalia Dr. Alderwoman Rita Bolyer - Sounds good. Mayor-That's my report.

Old Business - Dress Code. Ms. Deb, I think you are head of that one. Alderwoman Debbie Barrett. The person that sits at that desk is the 1st person anyone comes in and sees. Mayor's Report- The Garbage proposal we asked for a couple. We only got one so there is no use to go into that. We can talk about it if y'all want to discuss it a little bit.Mayor-Sir (Wolf Representee) would you like to step to the podium and talk to us just a little bit. We still have a year left on the contract we currently have. We all have not had a chance to study it and go into detail about it. I do have a question. Wolf Representee -Yes sir. Mayor - Is there any way you can come off 'the price some? I guess you and I need to sat down in the office and I am not ready to put it out in public right now. I think I said that price is a little more than what we are paying. I would like for you to come by and maybe sit down and talk with me. I can pass it the information to the alderwomen or if they are able, we can all meet with us we can look at it a little closer. Would you agree to that? Wolf Representee-Yes sir you can give me a call and we can schedule a day. Mayor-Any day you want to come we are available. Alderwoman - is there any way when you come by you can get the garbage and not have to charge us for picking up toilets. Wolf Representee-Yes ma'am that is what we were going to discuss about the grapple coming by and picking up debris. Mayor - Most towns, if I'm not mistaken, the house hold garbage went to one dump site and white goods went to another dump site. That's why they pick it up in two different trucks. Wolf Representee - Yes you are correct. Mayor - They won't let you put some goods in certain palls.

That is why he has to have two prices. If you would come back, I'm available tomorrow or Thursday or any time. It will be next month before we meet again. Wolf Representee - Ok, I will give you a call.

Grant Update -The money we have received and are waiting while we have a board after we all had the election. \$960,000.00 Grant for the water improvement to tie in with Ferriday. EPA Grant \$225,000.00 for the replacement of the water meters and that helps us on the \$260,000.00. We got 223,000.00 and \$25,000.00 for sewer lift station and\$15,000.00 CWEF Grant also what I don't have in here is the \$25,000.00 we got last year from the previous administration for the Vidalia Dr. lift station and had work done to it. Total with the LGAP Grant being \$1,454,000.00. That is not including the - \$6,000.00 for the reimbursement on the FEMA for the storm. We got an email stating the money has not being release due to the EPA assessment still going on. EPA is doing the environmental study now went they get it done the money should be released and they will let us know when that may be. We have not got a penny of this money yet, but once it comes it will come. The Park is cleaned up with the help of Sheriff Hedrick's inmates. I think it was13 inmates. I think it was 14 loads of limbs. The Police Jury came and pushed the limbs again. It's clean right this minute. If people don't quite dumping white goods back there, I'm going to have to shut it down. We can not have refrigerators, stoves, and screen doors.

Alderwoman Bolyer - So they have been dumping stuff like that? Mayor - Yes it was done Saturday. Trash bags and loads of bags. They might shut us down if it's things like that being put back there and I just may do it. Alderwoman Bolyer - I don't blame you. Mayor - It's been too much of a help. The Parish is going to start using it as soon as they get their boom truck in,they going to start hauling their limb and they are going to keep it pushed. Alderwoman Bolyer- they're going to haul their limbs back their, too?

Alderwoman Humphries-yes but they are going to keep it pushed though. Alderwoman Bolyer - Do we have enough room to keep pushing back? Mayor - We got about 8 acres back there in that corner. We got some more willow trees we can push down to make it bigger. Alderwoman Bolyer- Shouldn't we (suggestion) It is open to Rldicecrest to take our limbs back there. Mayor - Yes Alderwoman Bolyer - Before it gets out of hand, we can gate it up at night then we would have to open it up during the day. Mayor - We can gate it and I talked about gating it. Alderwoman Bolyer-Or Chain it. Mayor - Well you would have to put from the bridge all-round the curve. We might have to gate it or shut it down. Then they would dump it outside the fence and it would be on side of the road. Alderwoman Humphries - would

it help if we put a sign up. Mayor - I have a big sign up now that says dump all the way to the back and put on their limbs only four times limbs only. The deal I made with Mr. Wilkerson when he was board President if they kept it pushed as we need it at least once a quarter they could dump limbs when they need to back there. Alderwoman Bolyer- For the whole Parish? Mayor - No just the surrounding area. Between here and Ferriday and Cowan St. places like that. They keep it pushed. All I got to do is make a work order and they get it done. Alderwoman Bolyer- Unless we put a sign that says only limbs and anything else you will be fined or something to that extent. Mayor - Limbs only anything else you will be fined. I'll work on that tomorrow. Alderwoman Barrett - I'm going to start burning some of mine tomorrow or as soon as it stops raining. Mayor - John caught a couple back there and made them come pick it up. That's all I got on the Mayor's Report.

Mayor-New Business Alderwoman Humphries- We don't have any because we moved it up. Mayor - Old Business we have nothing.

Just as far as we can go with hopefully doing all the side streets in

Ridgecrest Alderwoman Rita Bolyer - Let me ask you a question do you think the streets take priority of the sewer treatment? Mayor - The sewer treatment we don't have it anymore. That would be the sewer pumps. The sewer collections that would be pin pointing and fixing and a million dollars will not last long of that. Alderwoman Bolyer - I was just wondering if that is something that would take priority over the streets? Mayor - The existing sewer collection rehab that is lining pipes and stuff like that. A million dollars will not go far on rehab and pipes. In July I got Louisiana Rural Water to come in and do a smoke survey and see what we got. We will do that July or first of August. The portable water we have the grant going withit now. I suggest the Street Grant unless you have a different idea. It is a \$800,000.00 Grant. Alderwoman Bolyer- Will that do the streets? Mayor - According to what we spend. We are spending \$42,000.00 on it now. That's going to help us towards the grant amount and getting more done. We have not been able to get on before now because of the weather . We got it cut just not dug out. Alderwoman Bolyer - I was wondering if any of the other need done or having problems. Our streets are totaled and one hundred percent need done. At this time the main on here is the streets. I don't know what is going to happen tonight. One leak or cave could cost a million dollars and that is gone. Alderwoman Bolyer- they have the government working on the infrastructure and we got someone applying for it. So let go for it. Mayor - It's \$800,000.00 to fix as many streets as we can. I'm going to need a motion. Alderwoman Bolyer-I make a motion. Alderwoman Humphries - I second the motion.
