

#### Monroe to discuss 'master plan' Thursday

Peterson has served in the Legislature since 1999.

"I am hopeful that my decades of service have had a positive impact on the lives of those for whom I have fought. I truly believe I have helped to advance our beloved state forward. I am proud of my years of service in Baton Rouge and sincerely thank my constituents for giving me the opportunity to represent their interests. I am also very grateful for all of the personal and professional support I have received from my colleagues, legislative staff, advocates, friends and family."

#### Monroe man gets 16 years in prison for conspiracy to distribute meth

Jeremy Michael Davis, 37, of Monroe, was sentenced by U.S. District Judge Terry A. Doughty to 196 months (16 years, 4 months) in prison, followed by five years supervised release, for conspiracy to possess with intent to distribute methamphetamine.

Agents with the U.S. Drug Enforcement Administration (DEA) began an investigation into the drug trafficking activities of Davis and his co-defendants. Through their investigation, they learned that beginning in October 2018 and continuing through March 2020, Davis conspired with three other individuals to possess methamphetamine with the intent to distribute it. On November 7, 2019, agents were able to intercept a phone call with Davis wherein he discussed the purchase price and sale of methamphetamine. Agents then conducted surveillance and confirmed Davis' participation in the sale of methamphetamine. Agents ultimately seized the narcotics, and it was tested and confirmed to contain 88.6 grams of actual methamphetamine.

The case was investigated by the DEA and prosecuted by Assistant U.S. Attorney Brian C. Flanagan.

This case is part of an Organized Crime Drug Enforcement Task Force (OCDETF) operation. OCDETF identifies, disrupts, and dismantles the highest-level criminal organizations that threaten the United States using a prosecutor-led, intelligence-driven, multi-agency approach.


