ment Auditing Standards that have been audited, in accordance with the auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States of financial statements of the governmental activities, each major fund, and the aggregate remaining fund information of Ouachita Parish School Board as of and for the year ended June 30, 2021, which collectively comprise the School Board's basic financial statements, and have issued their report thereon dated January 31, 2022. Ms. Williamson reported there were no modifications in preparing the Financial Statement, referencing Page 4. Following Mr. Manley's verification with President Hicks that no cards were submitted requesting to speak to this Item 5, Dabo Graves motioned, seconded by Tommy Comeaux, that the Board approve the Comprehensive Annual Financial Report for the Year Ended June 30, 2021 as presented by Margie Williamson with Allen, Green & Williamson, LLP, Certified Public Accountants. Motion unanimously carried by all members present.

After confirming with Mr. Manley that no cards were submitted requesting to speak to Business Item 6 of the Agenda, President Hicks asked Business Director Regina Mekus to come forward and present her 2021-22 Interim Financial Report for Period ended February 28, 2022. Ms. Mekus reported a fund balance of \$45.6 million in the General Fund and \$24.7 million in the District #1 M&O (1/2 cent tax) account. There was a little increase in sales tax collections last month; but had dropped to 4% increase that had been running 8 - 10% increase last month. These are our main two operating funds districtwide and represent the money that it takes, looking at our entire budget of \$250.0 million fund balance that we have to have on hand in case the sales tax revenues decrease so as not to hold up our operations or put on hold with a reimbursement of a federal program. This is money that we use to meet payroll. We try to make sure we are in a strong fiscal position to operate each month and to make sure our employees are paid, which is our main expenditure we have in the district. There was a decrease in sales tax collections last month percentage wise as compared to prior year. This year it is not quite up to what it was last month when it dropped to a 4% increase compared to the prior year. Remember we were running about 12-16% increase. This year it's gone up to about 8% compared to last year. As we get into the spring season, maybe we will see some increases to go back up to where they were. Ms. Mekus reminded the Board that we were far above where we were three years ago with our sales tax collections that were unprecedented increases we must be very mindful of when we go forward trying not to spend money that we don't have in hand and not budget money we are not certain we are going to bring in. The more we see this increase, means the longer we are out when looking at sales tax collections. She commented that she is not just looking at last year's figures, but at three, four and five years back to make sure when we budget those sales taxes, that we have good solid numbers to go by. Ms. Mekus referred the Board to Page 1 of her report under West Ouachita Sales Tax (1-cent) in the last column and noted that Other Sources & Other Uses identify a transfer of funds budgeted to go out directly into the Debt Services Funds for West Ouachita to pay those funds off in that district before we can spend any of those dollars. She pointed out that there is only \$54,775 of insurance money left in the 2019 Storm Damage Construction column on Page 3 of her report from the Boley project. She stated that the Board needs to know where that money is being spent. Ms. Mekus referred the Board to the last two pages of the report that reflect revenue, expenditures and fund balances giving a comparison in the General Fund and the M&O Sales Tax accounts for a 3-year period month by month to give a better idea of how the activity tracts in these funds from year to year on our revenues and expenditures to date and our fund balances. Concluding her report, Ms. Mekus offered to answer questions from the Board regarding her financial report presentation. Whereby, Scotty Waggoner moved, seconded by Shere May, that the Board approve the 2021-22 Interim Financial Report for the Period ended February 28, 2022 as presented by

Ms. Mekus. Motion unanimously carried by all members present. Greg Manley announced that there were no cards issued to address the following Business Item 7 on the Agenda. Business Director Regina Mekus presented the Ouachita Parish School Board with a Notice of Non-Compliance received from the Louisiana Economic Development Board regarding a violation committed by Neighbors, LLC on their (ITEP) Industrial Tax Exemption Program Agreement (Exhibit "A") that was approved in 2020. The Exhibit "A" Agreement between Louisiana Department of Economic Development and Neighbors, LLC ("Company"), was entered into for the Industrial Tax Exemption Program ("ITEP") to obtain the above-referenced exemption from ad valorem taxes in Ouachita Parish. Pursuant to Exhibit A, notice is hereby given that the Company failed to satisfy the requirements of Exhibit A, which is the reason for the notification to the School Board. Ms. Nugent recommended that Policy DIBA be deleted because it is no longer relevant and that Policy JBCE needs additional definition and verification of "Capacity" included in its contents and recommends it be considered later. Ms. Nugent will bring both these policies back for approval at a future meeting.

Greg Manley announced that Byron McCoy submitted a card requesting to address the Board on Business Item 9 of the Agenda. He will be allowed to speak after Kaitlin Ross completes her time addressing the Board. Whereby, Mrs. Ross provided the Board members with information regarding her topic of Surety Bonds. She claims her children have been abused and neglected at school and intends to file claims for violations on Surety Bonds against Ouachita Parish School Board's liability insurance policy. The Board was accused by Mrs. Ross of failing to uphold their oath of office that they signed saying they did. She also provided the Board members with a copy of her petition so they can be aware of what is going on and what their attorney may not have advised them about. She stated she would like for them to come back into compliance with the constitution if they have failed. She reported that her children had been abused and neglected at their school, but they (the Board) do not have kids at the school. So, she told them first hand, "You don't understand that." "You've been dishonest with me and this community and I'm going to file a claim against that if you cannot come to an understanding and fix some of these policies that you have that are causing harm to my children." She told the Board that there was a list of the demands (included in their packets) and this is just some of them because the list is so long she couldn't put everything on there of the violations they have done. So this is just most of them. She asked the Board members to let her know if they had any questions. She told them the packet contains everything they need to know about the Surety Bonds and everything they should be fully informed and aware of. Mrs. Ross concluded her presentation by asking the Board, "Is there anything you want to ask me? No one asked Mrs. Ross any questions; however, Mr. Manley asked for a copy of the same material Ms. Ross provided the Board earlier for our Board attorney.

At this time, Mr. Byron McCoy was allowed to speak to the Board regarding Business Item No. 9.

Mr. Manley responded with a "no" answer to President Hick's question when asked if any cards were issued to address the Board regarding Business Item 10. Whereby, Safety/Construction Supervisor Ken Slusher proceeded with his construction report stating that there was a construction meeting held this morning at the new Boley Elementary School beginning at 9:00 a.m. He pointed out that there are several things that need work, such as; flooring in the classrooms, putting ceilings up in the classrooms according to their colors and parking lot. The completion date is about the middle of May, but couldn't confirm. If they could get finished with the project in the middle of May, then our teachers could be moved into the classrooms after school is out. West Ouachita High School construction workers are finally moving along very well. They've got most of the walls up in the new classrooms and counselor's office. A meeting is scheduled next Tuesday at the school at 9:00 a.m. and anyone interested in coming

is welcome. Mr. Slusher concluded his report with an announcement that the pad has been poured on almost every classroom and administrative area at the new Sterlington Middle School. They will start next week forming it up to lay the concrete. In a short time, they have made a lot of headway. The first Wednesday of every month there will be a construction meeting at the new SMS at 1:30 p.m. beginning in May. The Board will be notified when the first meeting is set.

Upon the recommendation of Safety/Construction Supervisor Ken Slusher, Scotty Waggoner moved, seconded by Shere May, that the Board accept the low bid from Mann's Construction in the amount of \$498,000 for the base bid (for new construction restroom remodel at Riser Elem.), of which includes Add Alternate in the amount of \$25,000 (To Install Air-Conditioning/Heat in 2 existing outside restrooms that are now inside and include with new restroom remodel, combining these 2 separate BR sets with both bids) for a total bid of \$523,000 and funded with West Side Sales Tax funds and having a budget of \$400,000 [Bid No. 40-22]. Motion carried unanimously.

Upon the recommendation of Safety/Construction Supervisor Ken Slusher, Scotty Waggoner moved, seconded by Tommy Comeaux, that the Board REJECT [Bid No. 39-22] for the Pinecrest Canopy Addition because the bids were so far over the budgeted amount of \$375,000. The project is funded with West Side Sales Tax money. Motion carried unanimously by all members present.

Upon the recommendation of Interim Purchasing Agent Waylon Mc-Cormick, motion by Shere May, seconded by Greg Manley, that the Board accept the bid of Jackson Paper Company for Copy Paper [Bid No. 42-22] funded through all funds with various budgets. Motion carried unanimously by all members present.

Upon the recommendation of Interim Purchasing Agent Waylon Mc-Cormick, Dabo Graves moved, seconded by Shere May, that the Board grant permission to extend the Liquidated Damages Clause on bidder's HVAC contract to June 15, 2022 from April 15, 2022 due to bidder's difficulty in getting parts for their HVAC Chiller Equipment [Bid No. 9-22] for installation at Lakeshore and Swartz Lower Elementary Schools, which made it impossible to meet the deadline. This bid was awarded in October, 2021, and extending the Liquidated Damages deadline date will not change the bid price because in this case, the delay was not caused by the bidder, but by not being able to get the needed HVAC parts for their equipment from the manufacturer timely. Motion carried unanimously.

Upon the recommendation of Interim Purchasing Agent Waylon Mc-Cormick, Tommy Comeaux motioned, seconded by Shere May, that the Board grant permission to bid the following items: (1) Water Bottle Filling Stations (Bid No. 50-22) paid with ESSER Funds; (2) Floor Renovations for (8 Schools--Carpet/Vinyl) [Bid No. 51-22] paid with ESSER Funds; (3) Wood Chips for (14 Elementary Playgrounds) [Bid No. 52-22] paid from various funds. Motion unanimously carried by all members present.

Under his Superintendent's Report, Dr. Coker reminded the Board that High School Graduation is coming up next month and all graduation ceremonies will be held at their prospective school stadiums except Sterlington High graduation will be held at North Monroe Baptist Church.

President Hicks set the next meeting for May 10, 2022 at 12:00 p.m. There being no further business to discuss, Mr. Graves moved, seconded Mr. Manley, that the meeting adjourn. Motion carried unanimously.

Notice of Violation Chlorine treatment technique Cadeville Water District PWS ID# LA1073060

The Cadeville Water District is currently in violation of the treatment technique requirements for minimum residual disinfectant level as set forth by the State (Part XII of the Louisiana State Sanitary Code). Although this incident is not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation. The Louisiana Department of Health (LDH) has determined that the presence of microbiological contaminants is a health concern at certain levels of exposure and requires the disinfection of drinking water to kill disease causing organisms. Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses, and parasites which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches. These symptoms, however, are not just associated with diseasecausing organisms in drinking water, but also may be caused by a number of factors other than your drinking water. LDH has set enforceable requirements for treating drinking water to reduce the risk of these adverse health effects. Treatment such as filtering and disinfecting the water removes and destroys microbiological contaminants. Drinking water which is treated to meet LDH requirements is associated with little to none of this risk and should be considered safe. We are required to monitor none of this risk and should be considered safe. We are required to monitor your water for the residual disinfectant level. This tells us whther we are effectively treating the water supply. The violation occurred because the treated water chlorine residual was less than 0.5 milligrams per liter in over five percent of the samples collected in the water system in two consecutive months. Corrective action was taken, the lines were flushed and the chlorine residual returned to the required level. You do not need to boil your water or take other corrective actions.
