Evans, Harper chosen for Saints Hall of Fame

The media selection committee of the Saints Hall of Fame has selected offensive guard Jahri Evans and safety Roman Harper for induction in 2020, while longtime New Orleans Saints Spanish radio broadcaster Marco Garcia has been chosen to re-

ceive the Joe Gemelli "Fleur de Lis" award for his vast contributions to the New Orleans Saints organization.

Evans, 6-4, 318, is one of the most decorated offensive linemen in franchise history. He played 11 seasons with the Saints from 2006-16 after being drafted in the fourth round in the 2006 NFL Draft out of Bloomsburg. Among his accolades were five consecutive selections to the Associated Press All-Pro teams, including four consecutive first-team honors from 2009-2012. Evans was also selected

to six consecutive Pro Bowls from 2009-2014, was awarded the Madden Most Valuable Protectors Award in 2009 and 2011 along with the other members of the Saints' offensive line, and was a member of the NFL 2010s All-Decade Team.

The Philadelphia, Pa. native started all 169 regular season games he appeared in and ten postseason contests in a Black and Gold uniform, the 11th most in club record books.

Evans was selected to the club's All-50th team in 2016.

A valve pit and 4" meter will be installed across the Highway 425/84 in Ridgecrest to gather flow information utilized for billing purposes. From the valve pit, a 4" waterline will be used to fill the now 87,000 gallon ground storage tank in Ridgecrest. From the replaced ground storage tank, Ridgecrest will replace the existing booster pumps with new pumps with vfd's and provide them with a weatherproof shelter. These pumps will pump water up into the existing 100,000 gallon elevated tank, which would be cleaned and painted. In essence, this project will tie in a new transmission line to the existing Ridgecrest distribution system at the approximate location of where the Ridgecrest water plant ties in now. New automatic read residential and commercial meters would be installed to insure that water loss is kept to a minimum by being able to readily compare gallons sold by the supplier versus gallons sold to the residents. Ridgecrest is under an Administrative Order for consistent violation of the limits of THM's and HAA5's.
