

Saints defense ready

Demario Davis signed with the New Orleans Saints as an unrestricted free agent in 2018 in large part because quarterback Drew Brees helmed one of the most prolific offenses in NFL history, and Davis never had played with a quarterback and offense that had been as accomplished and effective, one that ranked in the top nine in yards per game for 14 straight seasons, from 2006-19.

Five seasons later it wouldn't at all be a surprise if, in large part, the reason free agents signed up to join the Saints is because of the resume Davis and the defense have constructed under Coach Dennis Allen, who served as defensive coordinator from 2015-21.

Of course, New Orleans expects its offense to produce, beginning with Sunday's regular-season opener against the Falcons in Atlanta.

Quarterback Jameis Winston is healthy after tearing his left ACL in the seventh game last season. Receiver Michael Thomas, the NFL's Offensive Player of the Year in 2019, expect to be ready and healthy for the first time since that season, and he'll be joined by newcomers Jarvis Landry and Chris Olave at the position. The offensive line appears settled, despite the injury to rookie left

tackle Trevor Penning. And running back Alvin Kamara is prepared to make everything right if everything is wrong, or even better if it's operating at peak efficiency.

But the identity of the team currently is linked to the unit charged with stopping the opponent, the one that led New Orleans to a 9-8 record last season, when the team went through four starters at quarterback, four kickers, no snaps from Thomas (ankle surgery and rehab) and an NFL-record 58 starters.

"I wouldn't say I foresaw that time coming," Davis said. "I'm kind of a one-day-at-a-time type of guy. I do like to think down the road, but I wasn't looking for a day where the defense was the mainstay.

"I felt like I could add a lot of value to this team and play a role that would help us ascend, as I saw it was a high-powered offense and it needed kind of a boost on defense. And coming in doing my job, we've had a ton of success, me just being a component of a much larger picture. That has lent itself to us becoming a dominant force.

"So now, I don't look at us necessarily as a defensive-led team, because it's always been three components. That was the first thing I learned when I came here. It was a high-pow-

ered offense, but you've got to play the game in front of you. Sometimes the game is going to require the offense to have a great day, sometimes it's going to require the defense to have a great day. Sometimes it's going to be even and you need the special teams to make the difference. I still believe in that now. That was something I learned when I arrived.

"(But) it's fortunate that we've been able to put together a dominant force, a dominant unit. But we have to play like that each and every week. That's our responsibility."

The responsibility, in the Saints' first season without Brees since 2005, looked like this: 19.7 points per game allowed (fourth fewest in the NFL); 318.2 yards per game allowed (seventh); 18 interceptions (tied for fifth most); 46 sacks (eighth); and 93.5 rushing yards allowed, fourth fewest and aligned with the work from previous seasons (80.2 in 2018, 91.4 in '19 and 93.9 in '20).

"We're just an energy and effort type of defense," Davis said. "We're going to play with a ton of energy, swagger, whatever you want to call it – we're going to play with a ton of excitement and we're going to put every effort toward studying our opponent."

Lions still ranked after loss

The Southeastern Louisiana University football team continued its streak of consecutive weeks ranked in the Stats Perform FCS Top 25 which was released Monday.

The Lions dropped four spots from the pre-season to No. 21 after Saturday's 24-7 loss to UL Lafayette in the season opener. Southeastern has been ranked for 27 consecutive weeks – the fifth-longest current streak in FCS.

Southeastern could not overcome an early 17-0 hole due to a pair of turnovers and eight penalties for 60 yards. On the first play of the final quarter, SLU seemingly cut the lead to three points versus a Ragin' Cajun team that boasts FBS' longest active winning streak at 14. How-

ever, Cephus Johnson III's 48-yard touchdown pass to CJ Turner was overturned due to a penalty and the Lions would get no closer.

SLU is one of two ranked teams in the Southland Conference. UIW moved up to No. 8 after a 64-29 home win over then-No. 9 Southern Illinois.

Southeastern will play its second straight game versus FBS competition to start the season this coming Saturday. The Lions will travel to Boca Raton, Florida to face FAU in a 5 p.m. (CDT) contest. The game will be televised on ESPN+ and can be heard on the Southeastern Sports Radio Network (Kajun 107.1 FM, The Highway 104.7 FM, The Boss 103.7 FM/1400 AM)

Notice is hereby given, out of an abundance of caution and pursuant to Article IV, Section 21(D)(1) of the Louisiana Constitution, that on August 30, 2022, Entergy Louisiana, LLC ("ELL"), a public utility providing retail electric and gas service throughout the State of Louisiana, filed with the Louisiana Public Service Commission ("LPSC") its Formula Rate Plan ("FRP") Rider Schedule FRP Compliance Update for Test Year 2021.

The filing reflects an earned return on common equity ("EROE") for the 2021 Evaluation Period/Test Year of 8.33%, which is below the approved FRP dead band and results in an increase to Base Rider FRP Revenue of approximately \$65.1 million. Other changes in FRP Revenue driven by reduction in the amount of TCJA-related credits, additions to Transmission and Distribution plant in service reflected through the Transmission Recovery Mechanism ("TRM") and Distribution Recovery Mechanism ("DRM") offset by an increase in net MISO revenues leads to a net increase in FRP Revenue of \$152.7 million. The resulting FRP factors to be applied to the respective ELL rate classes (including Legacy ELL and Legacy EGSL rate classes) effective for customer bills rendered on and after the first billing cycle of September 2022, are as follows:

It is estimated that the proposed adjustment in rates will have the following effects upon applicable Legacy ELL customers' typical monthly bills: for a Residential customer using 1,000 kWh the bill would change by approximately 5.77; for a Small General Service customer using 50 kW and 12,500 kWh the bill would change by approximately \$71.43; for a Large General Service customer using 1,000 kW and 500,000 kWh the bill would change by approximately \$1,652.24.

FEMA PUBLIC NOTICE OF AVAILABILITY FOR THE DRAFT ENVIRONMENTAL ASSESSMENT AND DRAFT FINDING OF NO SIGNIFICANT IMPACT FOR THE PROPOSED CONCORDIA PARISH POLICE JURY NORTHERN CONCORDIA PARISH ENHANCED FLOOD REDUCTION THROUGH BRUSHY BAYOU DRAINAGE BASIN IMPROVEMENTS AT FROGMORE AND LUKE MARTIN ROAD IN CONCORDIA PARISH, LOUISIANA

Interested parties are hereby notified that the Federal Emergency Management Agency (FEMA) has prepared a draft Environmental Assessment (EA) and draft Finding of No Significant Impact (FONSI) in compliance with the National Environmental Policy Act (NEPA). The purpose of the draft EA is to assess the effects of the human and natural environment from improvements to the capacity of Brush Bayou in Concordia Parish, Louisiana.

The Concordia Parish Police Jury (Subrecipient), through the Louisiana Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP) (Recipient), applied for funding under FEMA's Hazard Mitigation Grant Program (HMGP) to reduce flooding in the upper reaches of the Parish due to restrictive and backwater flooding in primary drainage arteries and tributaries during and after storm events. The HMGP provides grants to states and local governments to implement long-term hazard mitigation measures after a major disaster declaration. The purpose of the HMGP is to reduce the loss of life and property due to natural disasters and to enable mitigation measures to be implemented during immediate recovery from a disaster. In accordance with the HMGP, the Subrecipient proposes to reduce the impacts of flooding during rain events in the proposed project areas by implementing hazard mitigation measures.

The purpose and need for the project are defined by the reoccurring flood issues experienced in the Bayou Cocodrie drainage system including the Concordia Park, Belle Grove/Vail Acres, Ridgecrest, Levens Addition, Doty Road, ar Washington Heights areas within the communities of Clayton, Ferriday, Ridgecrest, Vidalia, and other surrounding areas within the Parish. These areas have experienced major flooding due to the restriction of Bayou Cocodrie and backed up stormwater, resulting in a loss of the drainage capacity for the Parish. Adequate drainage capacity is critical to expeditiously move stormwater from flood-prone areas in the drainage basin, its tributaries, and the surrounding floodplains. To address these issues, the Subrecipient proposes to improve existing drainage by diverting the entire flow handled by Brushy Bayou into the Tensas River and by expanding the capacity of the inadequate and ineffective culverts at the intersection of Luke Martin Road and Brushy Bayou to allow better drainage and reduce the negative impacts from stormwater backup. The proposed project is essential to the mitigation of the ongoing flooding of residences and property served by the drainage system. The flood control structure would be engineered and designed to convey during and up to the 25-year storm event.

The purpose of the draft EA is to analyze the potential environmental impacts associated with the Preferred Action. The draft EA evaluates a No Action Alternative and the Preferred Action Alternative, which would divert the entire flow being handled by Brushy Bayou into the Tensas River by installing a box culvert and weir at Brushy Bayou and the Tensas River and replacing the existing culvert under Luke Martin Road with a new bridge at the intersection of Luke Martin Road and Brushy Bayou and realign the roadway to mitigate the flood damage to residences, businesses, schools, public buildings and facilities, and streets affected by the flooding in the upper reaches of the Parish. The draft FONSI is FEMA's finding that the Preferred Action would not have a significant effect on the human and natural environment.

Request for Qualifications was received from three firms for engineering projects related to ARPA allocations. These will need to be reviewed and scored.

LCDBG FY 22 -The Parish received the award letter for \$1.2 million from LCD-BG Funds toward the rehabilitation and renovation of the Concordia Sewer plant. These funds will be paired with local match funds by the Concordia Sewer District and CPPJ's ARPA allocation. Additional funds in the amount of \$400,000 have been request from DRA for potential cost overruns.

LGAP 19-20 - Confirmation of the closeout of s project has been received.

PJAL/LMA Procurement Agreement -The PJAL and LMA fought to obtain state funding for LITAC in HB 592, the supplemental appropriations bill. In the Senate Finance committee, the bill was amended to provide \$5 million to establish LITAC and fund the technical grant assistance, and \$20 million for local government match requirements. The creation of LITAC will allow smaller municipalities and parishes to gain assistance in applying for funding through the state and the IJJA funding at no cost.

Bid documents for reconstructing the asphalt roads are in progress. A uniform scope of work to standardize the work needed has been challenging. Meetings with GOHSEP, Rostan, and Shuler Consulting are being scheduled.

HM 4590 - Working with public entities for mitigation needs from the winter storm. So far, generators are the biggest key component needed to keep operations running. An extension for the application has been given statewide.

Broadband - No updates on awards have been received.

ARPA - The second round of funding has not yet been received. A request from Monterey Rural Water System was received for additional components in the amount of \$91,438.95.

A motion was made by Mr. Probst seconded by Ms. Allen to approve the distribution. Motion carried unanimously.

Request for Qualifications was received from three firms for engineering projects related to ARPA allocations. These will need to be reviewed and scored.

LCDBG FY 22 - The Parish received the award letter for \$1.2 million from LCD-BG Funds toward the rehabilitation and renovation of the Concordia Sewer plant. These funds will be paired with local match funds by the Concordia Sewer District and CPPJ's ARPA allocation. Additional funds in the amount of \$400,000 have been request from DRA for potential cost overruns.

LCDBG FY 23 - An announcement has been by the Office of Community Development for future LCDBG projects. The application for FY 23 funding will be for road renovations only. The criteria has changed and details are forthcoming. An

administrator and engineer will need to be properly procured as required by the LCDBG rules and regulations. A motion was made by Mr. Parker, seconded by Ms. Allen and carried unanimously to approve advertising for RFP for an Administrator and RFQ for Engineering.

The Lake St John Waterworks District 1 is currently in violation of the **maximum contaminant level (MCL) for haloacetic acids** as set forth by the State [Part XII of the Louisiana State Sanitary Code (LAC51:XII)]and the Federal Primary Drinking Water Regulations (40 CFR Part 141).

The United States Environmental Protection Agency (EPA) and the Louisiana Department of Health (LDH) set drinking water standards and requires the disinfection of drinking water. Where disinfection is used in the treatment of drinking water, disinfectants combine with naturally occurring organic and inorganic matter present in water to form chemicals called disinfection by product., (DBPs). EPA and LDH set standards for controlling the levels of disinfectants and DBPs in drinking water, including trihalomethanes (THMs) and haloacetic acid (HAAs). Some people who drink water containing THMs in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous system, and may have an increased risk of getting cancer. Some people who drink water containing HAAs in excess of the MCL over many years may have an increased risk of getting cancer.

In December 1998, EPA set enforceable drinking water standards for TTHMs at 80 parts per billion (ppb) and for HAA5 at 60 parts per billion (ppb) to reduce the risk of cancer or other adverse health effects. Compliance with the TTHMs and HAA5 standards are determined by calculating a locational running annual average (LRAA) of quarterly TTHMs and HAA5 sample results. Compliance calculations performed for the second quarter of 2022 shows that the system's current HAAs LRAA is 66 ppb at DBP02-5861 HWY 568; thus, the system is currently in violation of the HAA5 standard.


Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses).

This is not an emergency. If it had been you, would have been notified immediately. EPA and LDH do not consider violation to have any serious adverse health effects on human health as a result of short-tenn exposure; however, continued long-tenn exoosure to TTHMs and HAA5 levels above the standard (e.g., 20 years of exposure) has the potential to have serious adverse effects on human health.
