Tommy Comeaux moved, seconded by Scotty Waggoner, that the Board approve the 2021-22 Interim Financial Report for the period ended August 31, 2021 as presented by Business Director Regina Mekus and to ratify the action of the Board regarding this matter previously taken at the October 19, 2021 meeting. President Hicks offered public comments and motion unanimously carried.

Local citizen Aaron Hoyle presented the Board with his suggested "Funding Acceptance Policy" for their consideration. Following Mr. Hoyle's presentation, the Board took no action on his proposed policy. President Hicks invited public comments and several members from the audience came forward and expressed their opinions regarding Mr. Hoyle's proposed policy.

Title I Supervisor Jennifer Nugent presented eight (8) policies for the Board's consideration of approval that have been reviewed and approved in advance by district personal, Board attorney Elmer Noah and the Board's policy provider, Forethought Consultants, Inc. as follows: (1) **Policy: BE** (*School Board Ethics*); (2) **Policy: ID** (*Curriculum*); (3) **Policy: IDCC** (*Kindergarten*); (4) **Policy: IDDF** (*Education of Students with Exceptionalities*); (5) **Policy: JBA** (*Compulsory School Attendance Ages*); (6) **Policy: JBC** (*School Admission*); (7) **Policy: JBCE** (*Public School Choice*); (8) **Policy: JR** (*Student Privacy and Education Records*). Whereby, Harold McCoy moved, seconded by Dabo Graves, that the Board approve the above eight (8) policies as presented by Jennifer Nugent. Following public comments from the audience allowed by President Hicks, motion carried unanimously.

Clint Miller Director of Information Technology and Superintendent Don Coker presented an update on the *Elementary and Secondary School Emergency Relief Fund* (ESSER) made up of a group of Acts signed by presidents that have been passed by Congress to address the impact of COVID-19 on elementary and secondary schools. Mr. Miller explained that the ESSER funding is made up of the following three different Acts: (1: Coronavirus Aid, Relief and Economic Security (CARES) – March 2020

(2: Coronavirus Response and Relief Supplemental (CRRSA) – December 2020

(3: American Rescue Plan (ARP) – March 2021

The primary uses of these Acts were to respond to the social, emotional, mental health, and academic needs of students that have resulted from the COVID-19 pandemic. Mr. Miller continued explaining that these funds can also be used for educational technology to support in-person, hybrid, and virtual learning and maintain school facility repairs and improvements to reduce virus transmission and environmental health hazards. These are reimbursement grants, so; we are allocated money by the federal government through the state. Then, as we submit budgets, budgets get approved, we expend dollars. As dollars are expended, we submit quarterly reimbursement requests through the state and the money transfers back to us. ESSER I represents \$6.8 million, ESSER II represents \$20.2 million and ESSER III \$45.4 million, for a total of \$72.4 million. This is how the grant process works. He pointed out that Dr. Coker and he refer to these as "Living Grants" as these grants have a two-year period to spend them. ESSER I goes through September 2022, ESSER II goes through 2023 and ESSER III goes through September 2024. Mr. Miller announced that budgets will be reevaluated every 6-12 months and amended as needed while Parent / Community Survey coming soon and as needed during life of grants. He is presently working on getting some ESSER information on the website hopefully by the end of this week or sometime next week. A visual ESSER budget chart was placed on the screen for public viewing while Mr. Miller explained how the money was spent. The four colors represent four years of budgeting. It was explained that each column represents a particular focus area where we are planning to spend the funds.

Dr. Coker spoke at this time regarding the ESSER guidelines that have been handed down to our school system and announced for the first time to the Board members that a pandemic pay for our employees has been authorized in the Ouachita Parish School System and included in the ESSER III budget. It will be a **one-time** pay of \$1,500 for all **full-time employees**

that have been hired by the Board set to go out March 24, 2022 two days prior to Spring Break. The \$1,500 will not be divided into Certified and Support Employees. Every full-time employee will be receiving the same amount (\$1,500). (This item will be presented to the Finance Committee for further review. Whereby, qualifications for receiving this money will be determined and a recommendation will be presented to the Board for their approval).

Mr. Miller continued his ESSER report while explaining plans to use ESSER funds to improve the air quality of our schools. Some of the cooling/heating systems in our schools will be replaced that are in need and will be networking the system so that the maintenance crew can better monitor them remotely to control temperature and humidity for a better environment for our faculty and students. We are replacing and steam cleaning carpet for air filtration. We are trying to spend as much as we can up front right now so that we can get the maximum impact as quickly as possible on the improvement of air quality. He touched on other budgeted items that include school safety; cleaning surfaces, provide outdoor seating areas, touchless water bottle filters in all the schools, technology infrastructure, fuel costs for buses for tutoring/summer programs, and buying box trucks to minimize delivery problems.

Mr. Miller concluded his report by providing a visual ESSER Grant Fund Status Report that included allocations for expending the funds. ES-SER allocations for 2020-21 expenditures were \$5.7 million and ESSER allocations for 2021-22 expenditures were \$1.9 million for a total of \$7.6 million ESSER expenditures through 2020-2022. At this point, Dr. Coker gave an update on programs the system developed for advanced learning to help the students like school better and get them back in school. One program designed to make kids very relaxed to get kids liking school again and doing fun things with them was the SOAR (Summer Opportunities to Achieve) Program. There were no testing, no accountability for them but they were wanted there just so that they could have additional 21 days of learning experiences. In doing this, it was found that it was very successful at the elementary level but not so much at the middle school level. It was found that middle school kids much rather be able to earn that failed class back that they did not get. So, for this next school year, we are actually going to have part of our summer program for students who had failed where they can come in and can actually reclaim those credits back that they previously failed and be able to pass to the next grade. Credit recovery is also available for high school kids. Students Lost Learning was a big part of this entire plan. This is a one-time opportunity and is not sustainable because of the expense of the program after this funding ends. Dr. Coker mentioned that it is a waiting game with the State, waiting to see if our grant submissions are approved or not approved. It has been back and forth on where we are and what we are doing with this money right now. This money was issued to students based on their free/reduced status in this parish. The OPSB gets \$72.0 million but Monroe City Schools also gets \$72.0 million having a third less students but they have more students that qualify. Dr. Coker concluded his report stating that he thinks our plan meets the needs of our students, our employees and our community right now. It is a work in action with budget revisions and things that will not stay in the entire budget but can be added somewhere else. Whereby, President Hicks called for a motion and Greg Manley moved, seconded by Dabo Graves that the Board approve the ESSER Fund Report as presented by Clint Miller Director of Information Technology and Superintendent Coker. Following an offer for public comments, motion carried unanimously.

Business Director Regina Mekus announced that the Board has recently received two Industrial Tax Exemption Program applications; one from Delta Packaging, Inc. and another from Mid South Extrusion, Inc. Both of these applications have been approved by the Louisiana Economic Development Board and as such we have received notice. Delta Packaging, Inc. is requesting a 10 year exemption of all total \$85,536 that is in turn for a \$675,000 investment in Ouachita Parish manufacturing. Mid South Extrusion, Inc. is requesting a 10 year exemption of \$536,000 tax savings over 10 years with a \$4.3 million investment in Ouachita Parish manufacturing. The way this typically works is a business can apply for a tax exemption by documenting applying with Louisiana Economic Development Board that they have put a significant economic stimulus into their manufacturing business in Ouachita Parish. As a board, there are three (3) options: (1) The Board can approve these exemptions as they are presented; (2) The Board can disapprove these exceptions as they are presented; or (3) The Board can take no action in which case it would revert back to the Board of Commerce and Industry. Whereby, Tommy Comeaux moved, seconded by Greg Manley, that the Board take no action on the above tax exemption program applications. Following an offer from President Hicks for public comments, motion carried unanimously.

Business Director Regina Mekus presented the monthly 2021-2022 Interim Financial Report for the Period ended September 30, 2021 ar nouncing that this is the third month of the fiscal year and actually the second full month of operations fiscal year as school generally starts up in August. Looking at our current expenditures compared to fund balance, we are running about what is to be expected. In the General Fund we are running about 16% of our budget for operations, which would be true to our budget for the operating period. We are at 100% of the prior year fund balance in the General Fund and in the District 1 M&O we are up about 116%. What we have seen so far this fiscal year is our sales tax collections primarily being up about 16% over the collections from last year, which last year they were up 13%. So, our sales tax collections continue to increase as our money is spent in the parish. She directed the Board to look on the first page where we have the General Fund, which Ms. Mekus mentioned is right at 100% of prior year where we have the M&O which is at 116% of prior year as our ½ cent sales tax. We have the 1968 Sales Tax at 116% fund balance of the prior year and the 1995 Sales Tax is at 135% of the prior year. The 1968 Sales Tax is our 13<sup>th</sup> check and the 1995 Sales Tax is our 14th check. The West Ouachita Sales Tax is up about 135% fund balance over the prior year. The West Ouachita Sales Tax project we are currently funding, we are looking at the end of the Boley project as we approach the end of construction, and we have construction that is finishing up Woodlawn and construction that is beginning at West Ouachita. The second page reveals the Child Nutrition Fund details along with all our Grant Funds together and those are cost reimbursement grants. So you will notice that our revenues are not quite what our expenditures are for the year because we spend the money then we request to get reimbursed. Ms. Mekus referred the Board to the last 2 pages of the report which gives the breakdown of the comparison of revenues and expenditures for the prior 3 years for the General Fund and the M&O Sales Tax Fund. For the 2021-2022 School Year, sales taxes have started this month to be collected. We actually do not start to see sales tax collections each year until the month of September. Ms. Mekus concluded her report and invited questions from the Board and Scotty Waggoner moved, seconded by Shere May, that the Board approve the 2021-2022 Interim Financial Report for Period ended September 30, 2021 as presented by Business Director Regina Mekus. Following a brief moment for public comments offered by President Hicks, motion carried unanimously. In the absence of Purchasing Agent Bobby Jones, Director of Business Regina Mekus presented the following bid item for consideration and Tommy Comeaux moved, seconded by Shere May, that the Board accept the low responsive bid from Mechanical Cooling Services in the amount of \$279,000 for HVAC Equipment for the WMHS Fieldhouse [Bid No. 9-22]. Following an offer by President Hicks for public comments, motion (This bid was brought to the Board for conunanimously carried. sideration by mistake and needs to be reconsidered. It should be [Bid No. 21-22] for replacing a 20 year old chiller at \$50,000 at WMHS Fieldhouse. This bid was corrected below in these Minutes when Ms. Mekus announced she discovered the error. Please find the corrected Business Item No. 10 on Page 6, Paragraph 4 of these Minutes and [Bid No. 9-21] for HVAC Equip. on Pg. 6-7, Paragraph 5).

and everything looks good. There are still some electrical problems in the Home Economic Dept. area they are trying to correct. At West Ouachita there was a pre-construction meeting conducted and just now getting all set up. They are ready to start working and he doesn't have a report on this project yet.

#### Correction of Business Item No. 10:

Business Director Regina Mekus announced that she had mistakenly asked for approval of the wrong bid item under her presentation of Business item #10 [Bid No. 21-22] and needed to correct it. There being no further business to discuss, Tommy Comeaux moved, seconded by Greg Manley, that the meeting adjourn. Motion carried unanimously.

President Hicks called the meeting to order and welcomed visitors and guests to the meeting.

The roll was called and the following members were present: Tommy Comeaux, Shere May, Scotty Waggoner, Jerry R. Hicks, Harold McCoy, Dabo Graves and Greg Manley. There were none absent.

The Pledge of Allegiance to the American Flag was led by Board member Harold McCoy.

The Invocation was given by Board member Greg Manley.

On motion by Tommy Comeaux, seconded by Shere May, the Board approved the Agenda as presented.

President Hicks introduced Mr. Doug Mitchell from North Delta Regional Planning and Development and Mr. Mitchell announced that he has created three (3) redistricting plans for the Board's review and consideration. He noted that Ouachita Parish gained population for the year 2020 and is now at 160,368, an increase of 6,648 citizens since the year 2010. He explained that when considering the current plan, which he displayed, it throws a few of the districts out of deviation. He stated that he has attempted to bring the plans into deviation by moving census blocks around when one cannot use whole precincts. He has three (3) plans for the Board to review and offered to answer questions as he presented the plans. He explained that District "C" was at 6.87% deviation, District "E" 4.42% deviation and these are the two (2) districts that the high and low range are taken and when added together we get the overall deviation. To get the optimum number is to take the total population, divide it by the total number of members to get the optimum number, multiply it by 5% to get the high range, add it to the optimum number to get the high range, subtract it from the optimum number to get the low range. We then try to get them in balance where they are referred to as deviations. In these plans, to accomplish this without splitting a whole lot of precincts, it creates more expense for the parish. He referred to the district map "C" stating it is at 6.87% and District "E" is at 7.43%. The population of the City of Monroe is 47,702, which is down slightly from 2010. Mr. Mitchell mentioned that every other parish in Louisiana that his company represents lost population. The following three (3) plans were offered for consideration by Doug Mitchell:

They had their last meeting there last week **Plan 1** – Mr. Mitchell stated that he tried to move the numbers around just a little in District "E" just trying to balance the rest of the districts but didn't do anything to District "E". The numbers changed slightly. The numbers are still at 6% and a negative -6% and he was trying to accomplish this by moving whole precincts around. The whole precincts were not going to work after talking to the demographer for the Secretary of State and told him we were going to have to split precincts, which the state asked that we do not split precincts if we can help it. Therefore, he had to develop Plan 2 from here.

**Plan 2** – Mr. Mitchell discussed Plan 2 with the Board referring them to the second page of the handout charts and continued in balancing District "B" and District "D" as he took a whole precinct just west of Vancil Road and was able to bring District "D" into deviation by using a whole precinct so we don't have that expense we have to bear by splitting the precinct. He balanced the districts on the east side between District "G" & "F" but had to split a couple of precincts. He had to cross over the old district existing lines to make the numbers work. Also in District "E" he moved across the district line to cross into District "A" to address the minority population. Because it was on the low side, below a negative -5%, he moved just far enough North into District "A" to balance the numbers and get it just under -5% low range. He didn't go any further to avoid messing up District "A" too much. There were minor changes to bring the districts into line in his opinion. These are the three (3) changes for Plan 2.

Plan 3 -- Mr. Mitchell discussed Plan 3 with the Board referring them to Page 3 of his charts discussing the different changes on this plan. Districts "G" and "F" are unchanged from Plan 2. District "E" is opposed to going up further north like we did on Plan 2 going into District "D" and we went into District "C" to balance those numbers. Just another way to look at it to see what the numbers would be and it takes in that area that Mr. Hicks was just referring to and takes two whole precincts (48 & split 31) to try and keep the minority numbers at the previous range currently with the 2010 data. District "B" took in the whole Precinct (52A) and Precinct 52 & 54 are split going down LA 546 in a creek that goes across Caples Road and back up to LA 151 and 144. This would bring District "B" into deviation at 4.31 and District "C" at 3.42. District "D" is probably where the biggest change is and in an attempt to look at the numbers there just to see if we could do some things with representation on the west side District "D" there would be a black representation of 32.5% and a 56.83% white representation. This would lose those two districts on the south side, which would lower the numbers there from 69% to 55% and would split more precincts with this plan.

Mr. Doug Mitchell concluded his presentation of the three (3) redistricting plans and President Hicks called for questions from the Board and invited questions and comments from the audience.

Mr. Mitchell will bring his plans back to the Board for a vote at the next Board meeting on Tuesday, December 14, 2021 at 12:00 noon when they will select one of the three plans.

The next meeting will be held on Tuesday, December 14, 2021 at twelve 12:00 noon.



## **Elderly woman dies in Wisner house fire**

State Fire Marshal (SFM) deputies continue investigating the circumstances surrounding a house fire in Wisner that claimed the life of an elderly female resident.

Around 6:15 a.m. on Monday, January 10, Franklin Parish Fire District #4 responded to a report of a residential fire located in the 100 block of Jones Street in Wisner with

assistance from Wisner Fire Department, Winnsboro Fire Department and Franklin Parish Fire District #2. Firefighters later located the body of an elderly female in the home's living room just feet from the front door.

While official identification and cause of death are pending with the Coroner's Office, 80-year-old tenant.

Following an assessment of the scene, deputies determined the fire began in a bedroom. While the official cause of this fire remains undetermined at this time, SFM investigators are unable to rule out the possibility of electrical malfunction or unattended heating sources in an area where both the victim is believed to be the a propane-fueled heater and hot plate were located.

Deputies learned the home was not equipped with central heating and that the tenant was known to use multiple heating sources around the home including the stove and portable, electric heaters in every room.

Deputies were unable to locate working smoke alarms in the home.

The Morehouse Parish Communications District (the "District") met in a REGULAR SESSION on July 13, 2021, at 4:30 p.m. at the Police Jury Annex. The meeting was called to order by Chairman Brian Shoemaker with the following board members present: Ted Parker, Billy Shepherd, Timothy Williams and Leondrio Reed. Also present was the Board's secretary-treasurer, Deb Williams and Mr. James Cunningham. The meeting opened with the pledge of allegiance.

Each member was mailed a copy of the minutes from the April 13, 2021, regular meeting for review. Motion was made by Mr. Parker to accept the minutes as written. Motion passed following a second by Mr. Shepherd.

Mr. Parker made a motion to dismiss Mr. Daniel Harris from the board as he had moved out of the state earlier in the year. Motion passed following a second by Mr. Williams.

Mr. James Cunningham was introduced to the board as a potential replacement for Mr. Harris. Mr. Shepherd made a motion that Mr. Cunningham be appointed to the board upon approval by the Morehouse Parish Police Jury. Motion passed following a second by Mr. Reed. Mrs. Williams will send a letter to the Police Jury requesting their approval.

Mr. Shoemaker notified the board that the Morehouse Parish Sheriff's Department ("MPSO") has been making a monthly payment of approximately \$2,000 to AT&T for a T1 line for many years. The T1 line is used by the District to connect the 911 Viper equipment between the MPSO and the Bastrop Police Department ("BPD"). Mr. Shoemaker has been in contact with AT&T and this connection can now be provided with an upgraded ethernet line at a cost of approximately \$600 per month. Upon a motion by Mr. Parker, seconded by Mr. Williams, the decision was made to upgrade the line and have the District begin to make the monthly payment for this line.

Mr. Shoemaker notified the board that another official journal would need to be selected as the Bastrop Daily Enterprise has been discontinued. Upon motion by Mr. Shepherd and second by Mr. Reed, the Ouachita Citizen was selected as the official journal.

Mr. Shoemaker notified the board that he has been in contact with Equature regarding the replacement of the 911 recording software at the MPSO and the BPD. According to the documentation handed out by Mr. Shoemaker the upgraded recording equipment is fully NG911 compliant and has a text to 911 capture engine. The annual cost of the new equipment is \$8,924 with a one-time fee of \$3,000, and includes training on the equipment. Upon motion by Mr. Williams and second by Mr. Parker, the board voted to purchase the new equipment.

Mr. Shoemaker handed out a quote from AT&T for updated Viper Power 911 equipment for both the MPSO and the BPD. After discussion the board decided that a meeting with AT&T would be beneficial before a decision is made on upgrading the Viper equipment. Mr. Shoemaker will contact Ms. Pam Cowen at AT&T to arrange a meeting between AT&T and the board to discuss the quote and the equipment.

Mr. Shoemaker briefly discussed the work Messinger does for the district and said he plans to get Mr. Messinger to attend a meeting of the board to review their work for the district.

There being no further business to discuss, Mr. Parker made a motion that the meeting be adjourned. Motion passed following a second by Mr. Williams.
