Club discovers Almonester/Pontalba’s NOLA contributions

Members of the Potpourri Book Club met recently at the beautiful home of Kelley Oakley to hear the final book review of the Club year. Joining Oakley as hostesses for the meeting were LaVerne Bodron and Carol Ransom. All three ladies made everyone feel welcome.

The theme for the books reviewed this year was “Love the Boot” and each one featured some aspect of Louisiana’s rich culture and heritage. It seemed fitting that the final book would concern New Orleans, Louisiana’s premier city.

Kathy Hart, Potpourri president, conducted a business meeting prior to the book review. The members heard and approved Club minutes and then did the same for the treasurer’s report. Wendy Gray announced that a number of new members will be introduced at the Club’s luncheon picnic at Bayou De Siard Country Club on May 23rd.

Hart then introduced member Georgiann Potts to review Dr. Christina Vella’s historical novel, Intimate Enemies: The Two Worlds of the Baroness Pontalba. Potts began her presentation by asking the members to describe a “strong woman”.

She then introduced the heroine of Intimate Enemies, Michaela Almonester Pontalba, and suggested that Michaela was a very strong woman. Potts supplemented her review with a slide presentation to showcase both Michaela’s timeline of life-changing events as well as the amazing buildings that first Michaela’s father built (St. Charles Cathedral, the Cabildo, and the Presbytere — architectural jewels of the City) and those that she later added (Upper Pontalba, Lower Pontalba, and Jackson Square — also jewels of the City). Altogether these create one of the most photographed areas anywhere and form the nucleus of what most refer to when they speak of New Orleans.

Potts used these buildings and the square to form the backdrop for her discussion of Michaela’s almost unbelievably difficult marriage. “When Michaela’s mother arranged the marriage of her rich daughter to a distant cousin from cash-strapped French nobility, she had no idea what she was setting in motion for her daughter,” Potts explained. “The beauty of this book is that it is a compelling, beautifully written story of a very strong woman who survived against horrific circumstances.”

STAMP OUT HUNGER

Area residents can donate food via mail carrier on May 13

The National Association of Letter Carriers (NALC) planned to conduct its 31st annual Stamp Out Hunger food drive benefiting the Food Bank of Northeast Louisiana on May 13.

Stamp Out Hunger is the largest one-day food drive event in the country and could provide residents

with a convenient way to donate food to the Food Bank.

This year’s drive is expected to feature the new addition of donation bags. The bags would be provided to residents and could be filled with food they want to donate to the Food Bank. NALC is expected to start

distributing bags to residents in the region beginning on May 6.

Members of the community could participate in the event by filling the empty bag with nonperishable food items and placing it near their mailboxes before the delivery of mail on May 13, to be collected by a let-

ter carrier. The Food Bank would distribute the donations to people struggling with hunger in the region.

“The Stamp Out Hunger food drive gives us a chance to help those in need of a meal in our community,” said Jimmie Drummer, a letter carrier with the U.S. Postal Service. “This is an

opportunity for us to give back to the communities that we serve daily.”

Residents who do not receive a bag could still donate food by dropping donations off at the Food Bank’s office in Monroe during its regular business hours.

“We’re asking people to participate in this drive this

year so that our neighbors can continue to have access to the nutritious food they need,” said Jean Toth, the executive director of the Food Bank. “We are grateful to the community members who donate food items and to the letter carriers who take the time to collect them.”
