ORDINANCE NO. 22-4267

AN ORDINANCE ADOPTING A PLAN OF REAPPORTIONMENT FOR THE BOARD OF ALDERMEN OF THE CITY OF BASTROP, LOUISIANA BASED ON THE 2020 DECENNIAL CENSUS COUNT

WHEREAS, the United States Bureau of the Census completed an official decennial count of the number of citizens residing in the City of Bastrop, Louisiana in 2020; and

WHEREAS, the Mayor and Board of Aldermen of the City of Bastrop, Louisiana, based on a change in the official population of the City of Bastrop revealed by the decennial count for the ten year period ending 2020, find that a redistricting of the five aldermanic districts within the City is necessary and proper, to adjust and equalize the population makeup of the five electoral districts that comprise the Board of Aldermen, to preserve the legal principal of one man, one vote applicable to representative government in the City of Bastrop, Louisiana.

Section 1: BE IT ORDAINED that in accordance with Federal and State Law, the boundaries of the Bastrop Board of Alderman districts are hereby redistricted so as to provide for population equality among the districts as near as reasonably practicable by the adoption and ratification of the document attached hereto and made a part thereof.

Section 2: BE IT FURTHER ORDAINED that the Bastrop Board of Aldermen Districts as redistricted in Section 1 above shall become effective for the qualification and election of candidates for the Bastrop Board of Aldermen in the 2023 election, and for all purposes upon the assumption of office by the members elected to the Bastrop Board of Aldermen.

Section 3: BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4: BE IT FURTHER ORDAINED that this reapportionment plan be sent to the United States Department of Justice “DOJ”, the Secretary of State Louisiana Department of Elections, and the Morehouse Parish Registrar of Voters.

Section 5: This ordinance was introduced at the November 10, 2022 meeting of the Mayor and Board of Aldermen.

Section 6: A public hearing was held on December 15, 2022, at 5:00 P.M. prior to the adoption of this ordinance.

Section 7: After the adoption of this ordinance, it shall be published once per week during three consecutive weeks in the official journal of the City of Bastrop and shall become effective ten (10) days following the final date of publication.

Business owner pleads guilty to money laundering

Michael Tolliver, 57, of Monroe, pleaded guilty last week to one count of money laundering. Tolliver was the owner of Tolliver Oil & Gas, an oil refinery in Monroe.

According to evidence presented in court, Tolliver devised a scheme to defraud the Small Business Administration (SBA) and various financial institutions by falsifying the Paycheck Protection Program (PPP) and Economic Injury Disaster Loans (EIDL) Program loan applications and other documents to fraudulently obtain funds through these programs.

Tolliver submitted these documents in the name of Tolliver Oil & Gas and provided false and fraudulent information specifically related to the number of employees and average monthly payroll of the company.

In March 2020, Congress enacted the Coronavirus Aid, Relief and Economic Security (CARES) Act which was designed to provide emergency financial assistance to the millions of Americans who were suffering the economic effects caused by the pandemic.

As part of the CARES Act, the SBA provided EIDL, which were low-interest fi-

nancing to small businesses, renters and homeowners in regions affected by declared disasters.

The CARES Act also provided authorization of up to \$349 billion in forgivable loans to small businesses for job retention and certain other expenses, through a program referred to as the PPP.

In May 2020, Tolliver electronically submitted a false and fraudulent PPP application to “Bank 3” in the name of Tolliver Oil & Gas seeking about \$664,724 in PPP funds.

In the application, Tolliver certified that the funds would be used “to retain workers and maintain payroll.”

Tolliver falsely represented that the company had 108 employees and that its average monthly payroll was \$265,889 and even submitted a fake Internal Revenue Service (IRS) Form 940 for 2019.

Tolliver signed the PPP application and certified that the application and all information provided in it were true and accurate. In reality, Tolliver Oil & Gas had no employees or monthly payroll expenses.

Later that month, Bank 3 disbursed about \$664,724

in loan benefits to an account held by Tolliver at “Bank 1.” Using these and other funds, Tolliver made payments on vehicles and other items, including a 2020 Cadillac CT5, 2021 GMC Sierra 1500, two Tissot watches, two Tag Heuer watches, two 2021 Honda Rubicon ATVs and one 2021 Honda Pioneer ATV.

After receiving the \$664,724 in fraudulent acquired PPP loan benefits, Tolliver withdrew about \$500,065 of those funds in the form of a cashier's check on June 25, 2020, knowing that the funds were derived from unlawful activity, and deposited them into an account at yet another bank held by Tolliver.

Tolliver faces a maximum sentence of 10 years in prison, three years of supervised release, and a fine of up to \$250,000. Sentencing has been scheduled for May 2, 2023.

The case was investigated by the IRS and SBA. The case is being prosecuted by Assistant U.S. Attorney Seth Reeg of the U.S. Attorney's Office for the Western District of Louisiana and Assistant Chief Justin Woodard of the Criminal Division's Fraud Section of the Department of Justice.

The city of Monroe plans to be closed Jan. 2 for the New Year's holiday. Any garbage normally collected on Jan. 2 will instead be collected on Jan. 4. The Monroe Transit System will also be closed Jan. 2 and will resume services on Jan. 3.

Monroe PD investigates shooting

Monroe police are investigating a shooting that occurred last week.

Officers responded on Dec. 22 to a shooting on Millhaven Road.

The initial investigation showed that one person had been shot during the incident. Officers found and arrested the suspect, Q'Juanisha Benson, 28, of 1012 Joe Bill St., West Monroe, on Pecanland Road.

During questioning, Benson admitted to shooting at the victim several times and said it was self defense.

Ruston nurse faces 24 years for drug charges

Bonnie Jennifer Sherrard, 46, of Ruston, was indicted by a federal grand jury in Shreveport for illegally dispensing and distributing controlled substances.

The indictment alleges that Sherrard was a nurse prac-

itioner licensed to practice in the state and worked with a physician in Ruston. Count one of the indictment charges Sherrard with the use of a Drug Enforcement Administration (DEA) Registration Number issued to another person. Counts two through 41 charge Sherrard with illegal dispensation and distribution of controlled substances outside the bounds of professional medical practice. In addition, the indictment seeks forfeiture of Sherrard's license to practice as a nurse practitioner in Louisiana.

It is alleged in the indictment that Sherrard was authorized to distribute and dispense controlled substances so long as these acts were in accordance with the collaborative practice agreement between she and the physician.

Sherrard had a DEA Registration Number issued to her for use in distributing and dispensing controlled substances but she was not authorized to prescribe controlled substances in connection with treatment for chronic pain or in connection with the treatment of family members.

The indictment further alleges that from around Jan. 11, 2020, through Nov. 27, 2020, Sherrard knowingly and intentionally distributed and dispensed controlled substances without a legitimate medical purpose and outside the usual course of professional practice to members of her family.

These controlled substances included Hydrocodone, Adderall, Xanax and Clonazepam.

If convicted, Sherrard faces a sentence of up to 20 years in prison, three years of supervised release and a fine of up to \$250,000 on the counts involving illegal dispensation and distribution. Sherrard would also face another sentence of up to four years in prison, three years of supervised release and a fine of up to \$250,000 on the count involving illegal use of a DEA Registration Number issued to another person.

The case is being investigated by the DEA and is being prosecuted by Assistant U.S. Attorney Brian Flanagan.

Kelly woman killed in two-vehicle crash

Louisiana State Police Troop F responded to a two-vehicle crash last week that killed 73-year-old Sherry Bates of Kelly.

The crash happened on Dec. 22 while Bates was driving north Hwy. 165 and Cody Culpepper, 30, of Columbia, was driving behind Bates. Culpepper's vehicle hit Bates' and caused both vehicles to run off the road.

Bates was wearing a seatbelt and Culpepper was not. Impairment is not a suspected factor, according to a statement released by state police.

Culpepper sustained non-life-threatening injuries and Bates was pronounced dead at the scene.

The Application requests LPSC approval, and issuance of a public interest finding regarding, the Entergy Future Ready Resilience Plan (the “Resilience Plan”), which is ELL's proposed course of action to improve the resilience of its electric system through accelerated infrastructure hardening and vegetation management over the 10-year period from 2024 to 2033. In the Application, ELL seeks specific approval of Phase I of the Resilience Plan, which includes approximately \$5.0 billion in projects proposed to be implemented in the first five years (2024 to 2028) (“Phase I”). ELL's Resilience Plan will not result in a change in rates unless approved by the LPSC and implemented by ELL.

ELL also seeks approval of a new rider, the Future Ready Resilience Plan Cost Recovery Rider (the “Rider”), to permit timely recovery of the Resilience Plan's revenue requirement. The proposed Rider would accomplish contemporaneous recovery of Resilience Plan costs through a forward-looking rate that would also include a true-up after a prudence review.

ELL also requests authorization to create a regulatory asset for addressing recovery of (and on, if applicable), the remaining net book value of assets that are replaced through the Resilience Plan, at the level currently reflected in ELL's rates. With this approved ratemaking treatment, customers would not see an incremental increase in rates associated with ELL's recovery of assets prudently retired in connection with the Resilience Plan.

Finally, ELL requests LPSC acknowledgment of ELL's seeking a waiver from the Federal Energy Regulatory Commission to allow ELL to capitalize conductor handling costs incurred through the Resilience Plan, which would lower the Resilience Plan's immediate bill effects.
