LSU Super streak at 25

LSU's streak of former players reaching the Super Bowl will stretch to 25 consecutive years as six former Tigers have advanced to this year's game in Santa Clara, Calif.

The 25-year stretch with a former Tiger in the Super Bowl is the longest active streak in all of college football.

Kickoff for the contest between New England and Seattle is scheduled for 5:30 p.m. on Sunday, Feb. 8. The game will be televised on NBC.

Five former Tigers are on the Patriots roster, while Anthony Bradford is a starting guard for the Seahawks. The Patriots roster features three LSU starters in rookie offensive tackle Will Campbell, wide receiver Kayshon Boutte, and linebacker K'Lavon Chaisson along with rookie linebacker Bradyn Swinson.

A fifth former Tiger – Jaquelin Roy – is on New England's injured reserve list.

LSU has had at least one player on the roster of teams competing in the Super Bowl for 25 consecutive years. LSU's streak dates back to

February of 2002 when running back Kevin Faulk made the first of five Super Bowl appearances with the Patriots.

In program history, 50 former Tigers have combined to win 61 Super Bowl rings. Faulk has three Super Bowl rings to lead all former LSU players. Last year, running back Ty Davis-Price and defensive back Andre Sam won the Super Bowl with the Philadelphia Eagles.

Nine former LSU players have won two Super Bowl titles with Clyde Edwards-Helaire being the most recent, winning championships with the Chiefs in 2022 and 2023.

Other Tigers with a pair of Super Bowl rings include Rohan Davey, Randall Gay, Jarvis Green, Tory James, Leonard Marshall, Booger McFarland, Spencer Ware and Corey Webster.

Faulk's five Super Bowl appearances are the most of any former Tiger, followed by linebacker Roy "Moonie" Winston, who played in the game four times with the Vikings in the 1970s.

Head football coach Sonny Cumbie announced the hiring of Dexter McCoil Sr., who will coach safeties for the Bulldogs in 2026.

McCoil, a Louisiana native, comes to Ruston after a three-year stint at Texas State in San Marcos, Texas, including the



LSU track team shines at home

The LSU track and field team closed their second meet of the indoor season on Friday at Carl Maddox Field House.

The day started off with yet another impressive field performance in back-to-back weeks.

Senior Jevan Parara earned his second weight throw of the season just two meets in with a personal-best toss of 20.84 meters (67-10.25). The mark moved him from No. 10 to No. 9 on the all-time LSU performance list, swapping places with alum David Collins.

The top from the sprints possibly came from freshman Athaleyha Hinckson, taking her first 60-meter win as a Tiger in 7.33 seconds. Hinckson's time of 7.33 improves on her Guy-

ane-national record, which was previously at 7.39.

Joshua Caleb clocked back-to-back wins to open his career with the Tigers, this week clocking 6.66 seconds for the win. He is fresh off a win last week where he clocked 6.67.

Freshman Zoe Peacock has already left her mark in LSU record book in just her second meet in the purple and gold. The Australian jumper cleared a height of 1.81 meters (5-11.25) to insert herself at No. 9 in LSU PL history, tied with alum Keisha Spencer.

In the men's high jump junior Justin Jimoh cleared a season best of 2.18 meters (7-1.75) to take the win with ease. Jimoh's SB puts him at No. 9 in

The Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, met, in regular session, in the Town Hall Meeting Room on Tuesday, January 13, 2026, at 6:00 p.m.

There were present: Mayor Buz Craft, Aldermen Jon Betts, Triand "Tron" McCoy, Brent Smith, and Tommy Probst. There were absent: Alderman Robert Gardner

There were also present: Piara Wilson, Municipal Clerk; Debra Moak, Municipal Accountant; Brad Burget representative of Smith, Taliaferro & Purvis Law Firm., Municipal Attorney; Jay LaSoyne, Municipal Manager; and members of the press.

The meeting was opened by the Mayor and the Pledge of Allegiance was recited by those present, followed by the invocation given by Alderman Probst.

A quorum being present, the Mayor declared the Mayor and Board of Aldermen of the Town of Vidalia, Louisiana, to be duly convened, in regular session, as the governing authority of said municipality, and opened the meeting for the conduct of business.

After being reviewed, the typed minutes of the regular town meeting of December 9, 2025, were approved with no changes. The motion for the approval of the minutes was made by Alderman Betts, seconded by Alderman McCoy, and unanimously carried.

The Mayor then asked if anyone had any comments on current agenda items. Being no comments from the public, the Mayor moved on with the Agenda.

The Mayor then announced that Agenda Item No. 1 is the presentation of the financial statement for November 2025 by Debra Moak, CPA, and Municipal Accountant. Ms. Moak began by explaining the various fund balances, which summaries included a comparison of actual expenses to budget expenses. Following that, the summary sheets, previously given to the Aldermen, were reviewed in detail, including a report on the positive and negative fund balances and indicated the net changes in the various funds. She then reported on which revenues are under budget and which are over budget at this time. Following that, she brought the Aldermen up to date on several items of interest, which items included: cash in the bank; investments; total assets and liabilities; combined revenues and expenses. She explained that the reason for the large negative net position is due to the Hydro rebate expense paid in November. She concluded by advising that the Auditors have requested an extension from the Legislative Auditors due to an additional audit procedure they must perform on compliance. There being no questions or comments, the Mayor thanked Mrs. Moak for her usual thorough presentation.

Agenda Item No. 2 was Board discussion and approval to advertise for bids on a bucket truck. The Mayor called on Cornell Lewis to discuss this matter. Mr. Lewis stated that the truck is an old 2007 International Bucket Truck that is a spare that has been replaced and is in the way. The Mayor advised that the Town did reach

out to sister cities for any interest, however, there was no response. A motion to approve advertising was made by Alderman Smith, seconded by Alderman Betts, and unanimously carried.

Agenda Item No. 3 was Board discussion and approval on a resolution of support of the Local Government Assistance Program (LGAP) for fiscal year 2025-2026. A motion was made by Alderman Probst, seconded by Alderman Betts and unanimously carried.
