#### AN ORDINANCE ADOPTING A PLAN OF REAPPORTIONMENT FOR THE BOARD OF ALDERMEN OF THE CITY OF BASTROP, LOUISIANA BASED ON THE 2020 DECENNIAL CENSUS COUNT

WHEREAS, the United States Bureau of the Census completed an official decennial count of the number of citizens residing in the City of Bastrop, Louisiana in 2020; and

WHEREAS, the Mayor and Board of Aldermen of the City of Bastrop, Louisiana, based on a change in the official population of the City of Bastrop revealed by the decennial count for the ten year period ending 2020, find that a redistricting of the five aldermanic districts within the City is necessary and proper, to adjust and equalize the population makeup of the five electoral districts that comprise the Board of Aldermen, to preserve the legal principal of one man, one vote applicable to representative government in the City of Bastrop, Louisiana.

Section 1: BE IT ORDAINED that in accordance with Federal and State Law, the boundaries of the Bastrop Board of Alderman districts are hereby redistricted so as to provide for population equality among the districts as near as reasonably practicable by the adoption and ratification of the document attached hereto and made a part thereof.

Section 2: BE IT FURTHER ORDAINED that the Bastrop Board of Aldermen Districts as redistricted in Section 1 above shall become effective for the qualification and election of candidates for the Bastrop Board of Aldermen in the 2023 election, and for all purposes upon the assumption of office by the members elected to the Bastrop Board of Aldermen

Section 3: BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4: BE IT FURTHER ORDAINED that this reapportionment plan be sent to the United States Department of Justice "DOJ", the Secretary of State Louisiana Department of Elections, and the Morehouse Parish Registrar of Voters.

Section 5: This ordinance was introduced at the November 10, 2022 meeting of the Mayor and Board of Aldermen.

# **TRAFFIC REPORT Safety Commission** reports spike in fatalities

In 2021, there were 315 fatal crashes in Louisiana that involved at least one driver who had been drinking, according to data from the Center for Analytics and Research in Transportation Safety (CARTS) at Louisiana State University.

That number accounted for the most alcohol-related crashes reported in 13 years.

"Since the pandemic, we have seen an alarming increase in traffic deaths, mostly because of driver behavior," said Lisa Freeman, executive director of the Louisiana Highway Commission. "Speeding, distractions, impaired driving—these are the leading causes of crashes, and they are a direct result of poor decision-making by drivers."

CARTS records also show people used mobile phones while they were driving and caused 850 crashes that injured or killed someone.

That number was the highest it has ever been in Louisiana and officials were likely low because drivers in safer Louisiana."

crashes are not likely to self-report mobile phone usage just before the crash.

"Distracted driving is one of those things in which people believe that everyone else is the problem," Freeman said. "It doesn't matter how good a driver actually is. If drivers are looking at or handling their phones while driving, they cease to be good drivers and that's how crashes happen."

While not strictly a driver behavior, the lack of seat belt usage continues to be a major contributor to injuries and deaths in crashes.

Last year, 52.8 percent of all people who died in crashes either were not wearing a seat belt or were not wearing it properly.

"Just having good driving habits on your mind is key to being a better driver," Freeman said.

"We too often take driving for granted, as though it were an automated task. By focusing on our driving, we are more aware of what's going on have repeatedly said those numbers around us and help contribute to a

(Consider appeal from student expulsion hearing) and add Item X. Evaluation of Bids, Item No. 6. [Bid No. 27-23] - (WMHS Baseball Scoreboard). Motion unanimously carried by all members present.

Upon motion by Shere May, seconded by Scotty Waggoner, the Board approved the amended Agenda as presented. Motion unanimously carried by all members present.

At this time. Dr. Coker made an official announcement to the Board that he plans to retire at the end of his contract on July 3, 2023 and will officially retire as the Ouachita Parish School Board Superintendent on July 4, 2023. He stated that he is trying to give the Board plenty of time to prepare a procedure in going forth in selecting the next superintendent. Dr. Coker took this time to congratulate the re-election of all the Board members who are returning to serve another term. Scotty Waggoner is the only member that did not seek re-election and will be replaced by Michael Brady in District C as of January 1, 2023. Plans for the superintendent search will begin sometime in December. Dr. Coker unexpectedly received praises of appreciation and accomplishments from individual Board members acknowledging his leadership abilities throughout his tenure as the Superintendent of the Ouachita Parish School System.

Before going forward with the Agenda Business Item No. 1, President Hicks inquired of Vice President Manley if any comment cards were turned in to address Business Item No. 1 and he responded there were not.

On the recommendation of Business Director Regina Mekus, Greg Manley moved, seconded by Dabo Graves, that the Board approve the Amendment to Application L21-306 RE: General Obligation Bonds (East Ouachita Parish School District) State Bond Commission - Financial Disclosure Form as presented by Business Director Regina Mekus. Motion carried unanimously by all members present.

Mr. Manley responded "no" when asked by President Hicks if anybody submitted comment cards to address Business Item No. 2.

Business Director Regina Mekus presented her monthly 2022-2023 Interim Financial Report for the Period ended September 30, 2022. Ms. Mekus reported that we are into the third month of operation in the current fiscal year ending June 30, 2023. The General fund is ending the period with 97% of the fund balance of where we were last year which is considered to be right on task with our budget as we begin the year with 29.9 million in the General Fund. In the District  $1\,M\&O$  we have 27.6million in fund balance which is a little above where we were last year at this time or 116% of our fund balance of where we were this time last year. She noted that on the next to last page that we do not have \$148.0 million in revenues. She corrected that number on her copy to \$31,690,211 which puts it at 20.96% of our revenues for the year which is exactly where we should be according to our budget in the General fund. The Board was referred to look at the third page on the East Ouachita Bond Construction where she reported a Fund Balance of \$35,314,426 for the month ending September 30, 2022. We are underway and that money is committed in ongoing construction projects, so we will be looking at issuing the remaining \$20 million over the next several months. Probably before the end of this fiscal year, we will be coming to you asking you to issue the remainder of those bonds as we plan additional construction projects and get them underway so that we have money to pay for the contracts as we commit to them. Under the 2019 Storm Damage Construction Projects you will see that it has a negative balance of \$314,000 that represents just those items that we have had completing the cleanup of the 2019 storm damage mainly completing Boley Elementary in the current year. Those costs will ultimately be covered by the West Ouachita Sales Tax that are being collected for those costs and to have them all together in one place under the storm damage construction account. We had other storm damage accounts but Boley has taken the longest time. What remains is just finishing up the Boley project which will eventually zero itself out as we recover those funds from the West Ouachita Sales Tax. Ms. Mekus completed her report and Shere May moved, seconded by Tommy Comeaux,

Brandon was in the audience to answer any questions from the Board.

Mr. Manley announced that Mr. Bryan Belles turned in a comment card to address the Board on behalf of Amber Levins under IX Business Item No. 5. However, Ms. Levins was not present to address the Board and Mr. Belles asked permission to represent her. Before permitting him to speak, Attorney Elmer Noah spoke to Mr. Belles' acknowledging his request and reminding him of the Board's legal position in a pending litigation matter with Ms. Levins and the Ouachita Parish School Board before he was allowed to speak.

No action was taken following Mr. Belles' comments.

No comment cards were turned in to address items under X. Evaluation of Bids, XI. Permission to Bid or Items XII. - XIV. (Remainder of meeting).

Upon the recommendation of Interim Purchasing Agent Waylon McCormick, Scotty Waggoner moved, seconded by Dabo Graves, that the Board accept the only bid from Trane US, Inc. in the amount of \$947,250.00, with a budget of \$900,000 and paid with ESSER funds for Trane Controllers [Bid No. 25-23]. Motion carried unanimously by all members present.

After much discussion and upon the recommendation of Interim Purchasing Agent Waylon McCormick, Harold McCoy moved, seconded by Dabo Graves, that the Board accept the lowest responsible bid after hearing from the architect and Mr. McCormick regarding the omitted amendment left out of the original bid and awarding it to the lowest bidder with the amendment to be included in the attachment so that the change can be adjusted in the bid by the contractor accordingly on the Richwood High School multi-purpose room project, funded with Eastside Bonds and having a budget of \$2,000,000 [Bid No. 23-23]. Motion unanimously carried by all members present.

Upon the recommendation of Interim Purchasing Agent Waylon Mc-Cormick, Greg Manley moved, seconded by Dabo Graves, that the Board accept the lowest responsive bid from Mann's Construction in the amount of \$958,000.00 for the construction of Pavilions at Sterlington High School, Robinson Elementary School and Richwood High School, funded with ESSER funds and having a budget of \$400,000 each [Bid No. 22-23]. Whereby, Greg Manley and Dabo Graves amended their motion to include 1st Add Alternates to each pavilion as presented. Motion carried unanimously by all members present.

According to Interim Purchasing Agent Waylon McCormick, there were no responsive bidders for Item No. 4 (2) Box Trucks, with a budget of \$125,000 each and funded with ESSER funds [Bid No. 12-23]. Mr. McCormick will seek other options.

According to Interim Purchasing Agent Waylon McCormick, there were no responsive bidders for Item No. 5 Refrigerated Truck, with a budget of \$150,000 each and funded by the Child Nutrition Program [Bid No. 13-23].

Upon the recommendation of Interim Purchasing Agent Waylon Mc-Cormick, Tommy Comeaux moved, seconded by Sherri May, that the Board grant Mr. McCormick permission to pre-approve the lowest responsive bidder and architect recommendations before the next Board meeting as the bid opens on November 29, 2022 for the West Monroe High School baseball scoreboard replacement [Bid No. 27-23]. There is a timeline problem in that West Monroe High School baseball needs the scoreboard working before the spring season baseball games start. It has a budget of \$100,000 and is funded with \$30,000 from the West Ouachita Sales Tax and \$70,000 from the West Monroe High School Baseball Program. Motion carried unanimously.

There were no Permissions to Bid offered.

The next Board meeting will be held on December 13, 2022 at twelve (12:00) p.m.

There being no further business to discuss, Greg Manley motioned, seconded by Dabo Graves, that the meeting adjourn. Motion unanimously carried.


