#### "Sec. 11-2003.3. Misdemeanor sexual battery

- A. Misdemeanor sexual battery is the intentional touching of the breasts or buttocks of the victim by the offender using any instrumentality or any part of the body of the offender, directly or through clothing, or the intentional touching of the breasts or buttocks of the offender by the victim using any instrumentality or any part of the body of the victim, directly or through clothing, when the offender acts without the consent of the victim.
- B. Whoever commits the crime of misdemeanor sexual battery shall be fined not more than one thousand dollars, or imprisoned for not more than six months, or both.
- C. The offender shall not be eligible to have his conviction set aside and his prosecution dismissed in accordance with Code of Criminal Procedure Article 894.
- D. The offender shall not be subject to any provisions of law that are applicable to sex offenders, including but not limited to any provision that requires the registration of the offender and notice to the public."

AN ORDINANCE TO AMEND SECTION 8-5001 OF THE CODE OF ORDINANCES, CITY OF WEST MONROE, LOUISIANA, TO MODIFY THE PROVISIONS, PROHIBITIONS, EXEMPTIONS, FINES AND ENFORCEMENT; TO ESTABLISH AN EFFECTIVE DATE; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

SECTION 1. BE IT ORDAINED by the Mayor and Board of Aldermen of the City of West Monroe, Louisiana, in regular and legal session convened, that Section 8-5001 of the Code of Ordinances, City of West Monroe, Louisiana, is hereby amended, to provide as follows:

# "Sec. 8-5001. - Prohibition on smoking.

- a. Prohibition: Smoking shall be prohibited within the municipal limits of the city to the full extent now provided by R.S. 40:1291.1, et seq. (as from time to time hereafter amended), and particularly by R.S. 40:1291.11.A. The exemptions provided by R.S. 40:1291.11.B shall likewise be exemptions under this section, except that the following exceptions shall not be applicable within the city:
  - 1. R.S. 40:1291.11.B(5) [any bar]
  - 2. R.S. 40:1291.11.B(8) [gaming operations, including bingo halls]
  - R.S. 40:1291.11.B(13) [any outdoor patio where food or beverages are served]

For the purposes of this section, the definition of "smoking" shall also include use of any electronic oral device, such as one composed of a heating element, battery, and/or electronic circuit, which provides vapor of nicotine or any other substances, and the use or inhalation of which simulates smoking. This term shall include any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-pipe, or under any other product name or descriptor.

# b. Fines:

- Any person who is guilty of a violation of the prohibitions in this section shall, upon a first offense, be fined twenty-five dollars (\$25.00).
- Any person who is guilty of violating any of the prohibitions in this section a second time within a period of five (5) years shall be fined fifty dollars (\$50.00).
- Any person who is guilty of violating any of the prohibitions in this section
  a third or subsequent time within a period of five (5) years shall be fined one
  hundred dollars (\$100.00).
- Each day on which a violation of this section occurs shall be considered a separate and distinct violation.

# e. Enforcement:

- A person shall be cited for an offense by means of a citation, summons, or
  other means provided by law or ordinance. In addition, mailing by certified
  mail of such process to an alleged violator's last known place of residence, or
  to an alleged violator's business location (but only as to violations by an
  employer), shall be deemed as personal service upon the person or entity
  charged
- 2. Enforcement of this section shall be implemented by the West Monroe Police Department, with the prosecution by the city attorney's office in West Monroe City Court. Police officers, city marshals, Code enforcement officials, and other persons expressly designated by the mayor are empowered to issue citations to persons violating any of the provisions of this section.

SECTION 2. BE IT FURTHER ORDAINED by the Mayor and Board of Aldermen of the City of West Monroe, Louisiana, in regular and legal session convened, that for cause determined to be in the best interests of the City of West Monroe and its citizens, this amendment shall be effective on and after May 13, 2020.

SECTION 3.
