AN ORDINANCE TO PROHIBIT SIMPLE THEFT IN THE VILLAGE OF GIL-BERT, LOUISIANA.

BE IT THEREFORE ORDAINED, by the Board of Aldermen of the Village of Gilbert, Louisiana, convened in regular session on December 9, 2021 to adopt Ordinance #371 to read as follows:

ORDINANCE NO. 371: SIMPLE THEFT

A person commits the crime of theft if he/she does the following:

1. Misappropriates or takes anything of value which belongs to another person, either without the consent of the other to the misappropriation or taking, or by means of fraudulent conduct, practices, or representations. An intent to deprive the other permanently of whatever may be the subject of the misappropriation or taking is essential.

2. Intentionally conceals, on his person or otherwise, goods held for sale.

BE IT ORDAINED, any person determined to be in violation of this ordinance shall receive a fine of \$100.00.
