R.S. 42:19.1, at its public meeting on Monday, December 6, 2021, and published said announcement in the Official Journal on Thursday, December 9, 2021.

SECTION 10. <u>Declaration of Emergency</u>. La. Const. Art. VI Sec. 30(B) provides "...no political subdivision shall submit the same tax proposition, or a new tax proposition that includes such a tax proposition, to the electorate more than once within a six month period except in the case of an emergency as determined by the governing authority of the political subdivision."

The proposition set forth in this Resolution was previously submitted to the voters on November 13, 2021, and failed. As the Governing Authority of Ouachita Parish, the Ouachita Parish Police Jury hereby determines, finds, and declares an "emergency" exists and supports placing this proposition before the voters on April 30, 2022, for the reasons set forth below, *inter alia*:

This proposition authorizes an ad valorem tax that provides approximately 75% of the funding required to fulfill the statutory obligations of the Ouachita Parish Police Jury and the Sheriff of Ouachita Parish with respect to operating and maintaining the Parish Jail ("Ouachita Parish Correctional Center"). Thus, this tax revenue is required to provide the food, clothing, medical care, and housing of approximately 1,100 prisoners and detainees. This tax revenue also provides funds for the wages of more than 150 men and women employed by the Sheriff in the operation of the Ouachita Correctional Center ("OCC"). In short, this tax is necessary for the operation of OCC. As the Parish Jail, the operation of OCC is mandated by law. The revenue of this millage is necessary not only for the proper care and security of those housed there, but also for the operation of the criminal justice system in Ouachita Parish, the enforcement of laws, and the safety of the community.

Recognizing the importance of OCC, the Governing Authority originally called an election for the renewal of this proposition to be held at the Open Primary election scheduled for October 9, 2021. This date was selected for two reasons. The likelihood of other matters on that ballot would save election costs and, in the event the proposition failed, it could be brought back before the voters at the April 30, 2022, election which would have been more than 6 months later.

However, after the Governing Authority placed this matter on the October 9, 2021, ballot Hurricane Ida struck Louisiana. As a result of the devastation wrought by that storm, the October 9, 2021 elections were postponed until November 13, 2021. At that election, the OCC proposition was not approved by the voters.

The "Municipal General" election scheduled for April 30, 2022, still presents the only opportunity for the voters to reconsider this proposition in time for the tax to be levied in 2022, if approved. However, due to the fact the October 2021 election was postponed because of Hurricane Ida, the April 30, 2022, now falls only 5 ½ month after the prior election. However, if

this tax is not levied in 2022 the loss of revenue would decimate the operation of OCC, cripple the criminal justice system in Ouachita Parish, jeopardize public safety, and terribly impact the financial stability of both the Ouachita Parish Police Jury and the Sheriff of Ouachita Parish. Because of the importance of OCC to the citizens of Ouachita Parish the Ouachita Parish Police Jury shows that this determination and declaration of an "emergency" under La. Const. Art. VI Sec. 30(B) in order that the voters may consider this matter on the April 30, 2022 ballot is prudent and appropriate.

AN ORDINANCE SUPPLEMENTING AND AMENDING CHAPTER 8, ARTICLE III, OF THE COMPILED ORDINANCES OF OUACHITA PARISH GOVERNING "COLLECTION OF SOLID WASTE" TO REGULATE THE SIZE AND PLACEMENT OF REFUSE CONTAINERS USED FOR SINGLE FAMILY DWELLINGS IN GARBAGE DISTRICT NO. 1 OF THE PARISH OF OUACHITA; AND, FURTHER PROVIDING WITH RESPECT THERETO.

WHEREAS, pursuant to La. R.S. 33:8002 and Ordinance No. 9049 the Ouachita Parish Police Jury serves as the governing authority of Garbage District No. 1 of the Parish of Ouachita ("Garbage District No. 1");

WHEREAS, the Ouachita Parish Police Jury issues non-exclusive franchises to companies in the business of collecting, conveying and properly disposing of solid waste in the unincorporated area of Ouachita Parish, and pursuant to Sec. 8-28.1 of the Compiled Ordinances of Ouachita Parish the owner of every occupied residence or commercial building in Garbage District No. 1 of Ouachita Parish shall maintain a contractual arrangement that provides for the collection, conveyance, and disposal of solid waste from such residence or commercial building by a franchise agent on a regular basis of not less than two (2) times per month.;

WHEREAS, the parties responsible for some single family residences in Garbage District No. 1 have recently started using large containers, commonly referred to as "dumpsters", for the collection of the typical household garbage generated at the residence;

WHEREAS, the use and placement of these "dumpsters" for the collection of household garbage at single family residences presents many problems, including, but not limited to the lacement of these containers at the roadside in the right-of-way of parish roads and state highways; damage to the edges of the road, the road shoulders, ditches, and residential driveways from the heavy trucks needed to empty and move these containers; and the creation of an inconvenience and hazard to the motoring public;

WHEREAS, pursuant to Section 8-29 of the Compiled Ordinances of Ouachita Parish and other controlling law, the Ouachita Parish Police Jury has the authority to regulate matters pertaining to the collection, conveyance and disposal of solid waste, including the type and location of waste containers used; and,

WHEREAS, the Ouachita Parish Police Jury finds that it is in the public interest to adopt regulations governing the size and placement of containers used for the regular collection of household garbage from single-family dwellings in Garbage District No. 1

#### NOW, THEREFORE:

BE IT ORDAINED by the Ouachita Parish Police Jury, in legal and regular session and in its capacity as the governing authority of Garbage District No. 1 of the Parish of Ouachita, that Chapter 8, Article III, of the Compiled Ordinances of Ouachita Parish governing "Collection of Solid Waste" be, and hereby is, supplemented and amended to add Section 8-28.2, to provide as follows:

"Sec. 8-28.1. - Limitations on Size and Placement of Garbage Containers in Garbage District Number 1 of Ouachita Parish.

Franchise agents providing containers to customers for the regular collection and disposal of solid waste from single family dwellings shall not provide containers having a volume larger than one hundred-twenty (120) gallons. This provision shall not apply to limit the placement of larger containers for the collection and disposal of construction debris in connection with construction, renovation or demolition work being conducted on the premises.

No franchise agent shall place any garbage container having a volume of more than one hundred-twenty (120) gallons in the right-of-way of any Parish Road or State Highway.

Any violation of this provision shall be deemed to be and is hereby declared to be a misdemeanor and any person convicted of the violation thereof shall be fined not more than two hundred fifty dollars (\$250.00). Each container provided or placed by a Franchise Agent in violation of this ordinance shall constitute a separate violation

BE IT FURTHER ORDAINED that the provisions of this ordinance shall become effective on February 1, 2022; and,

## **ILLEGAL DUMPING ARRESTS**



**A RECENT** investigation into the illegal dumping of used tires in the Lubenia Road area of Calhoun by Patrol Division Deputies has led to the arrest of two suspects. Vintrone A. Jackson and Earl Bernard Haynes have been arrested and charged in connection to the dumping involving several hundred used tires being illegally dumped on the wooded property. Jackson has been charged with 14 counts of gross littering (used tires), two counts of criminal trespass, and one count of contributing to the delinquency of a juvenile. Haynes has been charged with one count of gross littering, one count of criminal trespass, and one count of gross littering. Both have been booked into OCC. The investigation is continuing and more charges are expected.



# WM man gets 120 months for murder-for-hire plot

Steven Marcus Kelley, 48, of West Monroe, was sentenced last week by U.S. District Judge Terry A. Doughty to 120 months in prison, followed by three years of supervised release, in connection with a murder-for-hire plot.

The sentence handed down last week was the maximum possible penalty under the law that Kelley could have received.

Kelley was convicted by a federal jury in October 2021, following a trial in United States District Court. He was found guilty of use of a facility of interstate commerce in the commission of murder-for-hire. The charge stemmed

from a letter that Kelley wrote while incarcerated at Ouachita Correctional Center (OCC) and awaiting trial for charges of rape and molestation. In the letter, Kelley tried to hire someone to kill his ex-wife, who is the mother of the victims in the sex crimes case.

Evidence introduced at the federal trial revealed that Kelley obtained the

Believing the individual who lived at that address would carry out the murder, Kelley offered "\$10k for the job" for the individual to put "2 in the chest, 2 in the head" and to "make sure it counts." Kelley drew a map in both blue and black ink of the area where his ex-wife worked.

In an effort to avoid the letter and crime being traced back to him, Kelley used another inmate's name for the return address. He caused the letter to be mailed from OCC via the United States Postal Service.

On the night of December 10, 2019, the individual who lived at the address to where Kelley mailed the letter received and read the contents of the letter. The letter provided a physical description of the victim, the vehicle she drove, where she worked and her normal schedule to arrive at work. The letter stated that it "HAS to look like a robbery."

Realizing that the letter was soliciting someone to commit a murder, the individual took the letter to the Ouachita Parish Sheriff's Office the next morning. Law enforcement officers obtained surveillance video from OCC and the video revealed that on December 5, 2019, Kelley was sitting

on his bed writing a letter. Kelley can be seen in the video alternating between two different pens, which was consistent with the two ink colors used to draw the map. Later that same day, Kelley can be seen taking an envelope into the cell of the inmate who provided the address of the hopeful hitman.

Kelley sat on the fellow inmate's bed and addressed the letter. Moments later, the inmate whose name Kelley used on the return address of the letter entered the cell and engaged in a conversation with Kelley and the other inmate. That evening, Kelley can be seen giving the letter to another inmate who in turns gives it to a correctional officer for mailing.

On Dec. 30, 2019, law enforcement officers obtained and executed a search warrant for the Pods at the OCC where Kelley was housed at the time of the incident. Deputies found in Kelley's belongings a blue and black in pen. They found in the other inmate's bunk the address of the individual to whom Kelley mailed the letter.

The case was investigated by the FBI, United States Postal Inspection Service, and Ouachita Parish Sheriff's Office and was prosecuted by Assistant U.S. Attorneys Jessica D. Cassidy and Leon H. Whitten.
