

Governor sues state treasurer over use of unclaimed money

Louisiana Gov. John Bel Edwards' administration on Friday filed a lawsuit against state Treasurer John Schroder, continuing a dispute over whether state government should be allowed to spend money from the state's unclaimed property fund.

The fund consists of abandoned financial assets turned over to the state treasury by organizations that can't find the owner. While the owners can claim the money from the state, the entire fund is never claimed at the same time, and historically the legislature has appropriated some of it for government operations.

But Schroder is refusing to continue the practice, saying it isn't the state's money to spend.

He touts his office's efforts to return as much money as possible to the rightful owners, but he worries about what will happen if he runs out of money to pay claims.

But the administration says Schroder is attempting to usurp the legislature's constitutional spending authority.

"So far, the treasurer has simply refused to transfer the money, completely ignoring the will of the people's elected representatives, their governor and the letter of the law," Executive Counsel Matthew Block said. "The law is clear: excess revenues in the Unclaimed Property Fund are to benefit the public."

The state has never failed to pay a rightful claim, Block added, though Schroder says he had to delay paying about \$20 million in 2018.

At Friday's meeting of the legislature's joint budget committee, Edwards' Commissioner of Administration, Jay Dardenne echoed Block's argument, saying the Louisiana Supreme Court has affirmed the practice and noting that some of the money is committed to bonds that pay for a highway project. The administration's budget proposal counts on \$25 million from the unclaimed property fund. In an interview Friday, Schroder said he hadn't yet had a chance to read the law-

suit. "I believe the money belongs to the citizens," he said. "Nowhere in the law does it say we should be spending it. Whether we did it for 20 years or not doesn't make

Schroder has supported legislation the past two years to lock up the principal of the unclaimed money but allow the state to earn interest that could be used for small loans to local government. He said he expects to work with legislators again on similar legislation.

"I think it's silly to file suit," Schroder said.



IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Southwest Ouachita Waterworks, Inc. failed to take corrective action following identification of a significant deficiency. On October 8, 2019 the Louisiana Department of Health (LDH) performed a detailed inspection and engineering evaluation of our water system called a sanitary survey. During this sanitary survey, they identified two significant deficiencies in our system. As our customers, you have a right to know what happened and what we are doing to correct this situation. According to EPA's Ground Water Rule, we were required to correct the deficiencies or work with the State to develop a plan to correct the deficiencies. However, we failed to correct the deficiencies or contact the State before the established deadline and have therefore violated a requirement of the Ground Water Rule.

WHAT SHOULD I DO?

There is nothing you need to do. You do not need to boil your water or take other corrective actions. If a situation arises where the water is no longer safe to drink, you will be notified within 24 hours.

WHAT DOES THIS MEAN?

This is not an emergency. If this had been an emergency, you would have been notified within 24 hours.

The significant deficiencies has the potential to result in lack of proper treatment and oversight of the water system. Inadequately treated or inadequately protected water may contain disease-causing organisms. These organisms can cause symptoms such as diarrhea, nausea, cramps, and associated headaches. While we have not detected any evidence of contamination or other health threats related to our source water, we are still committed to correcting the deficiencies to eliminate the threat of contamination.

WHAT WAS DONE?

Violations: (1): LDH stated that all well sites must have a generator on site. In recent months, SWOW has been seeking information regarding grants for generators. We have been unable to qualify for a grant. Bids were obtained in December for a generator. Approval to purchase this generator was granted by the Board of Directors at the January 13, 2020 Board Meeting. A generator for the Larry Henry Rd. well site was ordered on January 14, 2020 at a cost of \$39,619. The concrete pad was poured at the site in early February. The estimated date for installation of generator is March 27 2020.

(2): LDH stated that SWOW has adopted a cross-connection control program. However, the program has not been fully enforced. SWOW has engaged the assistance of an outside firm to assist in implementing and enforcing the cross-connection control program. This program should be implemented and enforced by March 27, 2020.

WHEREAS. a vacancy will exist in the office of Associate Justice, 4th Supreme Court District of Louisiana, Parishes of Bienville, Caldwell, Catahoula, Claiborne, Concordia, East Carroll, Franklin, Grant, Jackson, LaSalle, Lincoln, Madison, Morehouse, Ouachita, Rapides, Richland, Tensas, Union, West Carroll, and Winn, due to the resignation of the Honorable Marcus Clark, effective June 30, 2020; and

WHEREAS, Louisiana Revised Statute 18:621 requires the Governor to call a special election to fill the vacancy in an existing judgeship when more than twelve (12) months of the term remain unexpired, in accordance with the provisions of La. R.S. 18:461 et seq., and all other applicable provisions of the Louisiana Election Code, La. R.S. 18:1 et seq., during the period commencing Wednesday, July 15, 2020, and ending at 4:30 p.m. Friday, July 17, 2020.

The special election shall be held and conducted un-SECTION 3: der the applicable provisions of the Louisiana Election Code, La. R.S. 18:1 et seq.

The primary election shall be held Tuesday, Novem-SECTION 4: ber 3, 2020, and the general election shall be held Saturday, December 5, 2020, at the times and places and in the manner, prescribed by law.

The Secretary of State, Commissioner of Elections, SECTION 5: Parish Board of Election Supervisors, Clerk of Court, Registrar of Voters, and all other persons charged with any power, function, right, duty or responsibility in conducting elections in the jurisdiction of the 4th Supreme Court District of Louisiana, Parishes of Bienville, Caldwell, Catahoula, Claiborne, Concordia, East Carroll, Franklin, Grant, Jackson, LaSalle, Lincoln, Madison, Morehouse, Ouachita, Rapides, Richland, Tensas, Union, West Carroll, and Winn, are hereby authorized, requested, directed and empowered to exercise every lawful function and to do every act necessary to conduct the special election, to cause the returns to be made, to canvass and promulgate the results, and to perform all related and incidental functions.
