Floodplain and Wetland Notice of Explanation Activity in a 100-Year Floodplain

To: All interested Agencies Federal, State, and Local Groups and Individuals

This is to give notice that the **Kentucky River Area Development District under 24 CFR Part 58** has conducted an evaluation as required by **Executive Order 11988 and/or 11990**, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect that its project in the floodplain and wetland will have on the human environment for **Chappell Dairy Building Project** under **SAI# KY202412301689**. The proposed project is located in the City of Hazard, Perry County, Kentucky. **This project will convert an unused structure located within the Kentucky River Area Development District. The building originally used as a dairy facility, is a key piece of downtown's architectural and cultural fabric. Once complete, the rehabilitated facility will house a commercial kitchen, an indoor farmers market, a disaster relief center, and storage for commodities used in the KRADD senior food program.**

The Kentucky River Area Development District has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values: The Kentucky River Area Development District evaluated alternatives. **The first option was to do nothing. This option will result in the building remaining unused and unavailable for community purposes. The second option was to renovate the existing building. This alternative would provide significant community benefits by enabling the Kentucky River Area Development District to expand its capacity and serve a greater number of residents throughout its service region. The project is in the 100-year floodplain as designated by the 2022 FEMA Floodplain Maps; however, there will be very minimal impacts to the floodplain areas as all the renovations will take place in an already existing building.**

The Kentucky River Area Development District has re-evaluated the alternatives to building in the floodplain and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of **[Executive Order 11988 and/or 11990]**, are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments. This activity will have no significant impact on the environment for the following reasons:

There will be minimum tree and vegetation removal as well as directionally drilled stream crossings. This project will provide better service to residents within the Kentucky River Area Development District service area, as well as continue improvement of the building. Once completed the project will not impede the floodplain. This is the most economical and least environmentally impacting alternative considered.

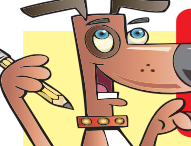
