The Kenova Police Civil Service Commission will begin testing for the position of police officer on Saturday, June 24, 2017. The Physical Agility Test will be conducted at 8:00 AM. Those passing the Physical Agility Test will be eligible to take the Police Civil Service Written Examination the same day.

All candidates must have an application on file with the Kenova City Clerk prior to 4:00 PM on June 19, 2017.

Applicants must be at least eighteen (18) years old, and no older than forty (40) at the time of the examination. Applicants must have a high school diploma, be physical and written testing, as well as interviews, background investigation, medical evaluation, drug test and polygraph examination. Successful candidates, unless previously certified by the State of West Virginia, will be required to attend the sixteen (16) week police academy at Institute. Other state certifications will be considered and processed by the West Virginia Division of Justice and Community Services.
