PREMISE- The residence of 2749 Knob Hill Drive, Clemmons, NC 27012

The residence is a single family dwelling with a basement located at 2749 Knob Hill Dr. in Clemmons, NC 27012. The residence is constructed of brick and has an attached two car garage located on the north end of the house. The driveway is paved and has a sidewalk connected to the driveway which leads to the front door of the residence. The porch is constructed of brick and has several stairs to climb in order to reach the black in color front door. A white in color mailbox is located by the street with the numbers 2749 attached to it. The backyard contains an in-ground swimming pool and is fully enclosed by a gray in color wooden fence. There is a detached storage shed located on the east side of the pool in the backyard.

Travel US Highway 421 northbound from downtown Winston Salem and continue on Highway 421 north by merging to the right at the Interstate 40 interchange. Exit Highway 421 at the Peacehaven Road exit (exit # 241) and turn left onto Peacehaven Road. Travel Peacehaven Road for approximately 3 miles and turn right onto Knob Hill Drive. 2749 Knob Hill Drive is located approximately 0.4 of a mile on the right side of the road.

CONTINUATION OF "PROBABLE CAUSE AFFIDAVIT"

The applicant is a Deputy Sheriff with the Forsyth County Sheriff's Office, currently assigned to the Investigative Services Division as an Investigator. The applicant has been employed by the Forsyth County Sheriff's Office as a sworn law enforcement officer since March of 2009. The applicant has been assigned to the Courtroom Division, Patrol Division, and Investigative Services Division during his career. The applicant is a graduate of The Police Law Institute, Death Investigation and Interview and Interrogation and is currently enrolled in the Criminal Investigation Certificate Program through The North Carolina Criminal Justice Academy. The applicant has obtained his certificate as Field Training Officer. The applicant has investigated numerous felony cases, to include but not limited to sexual assaults, armed robberies, deaths, identity theft/fraud, and narcotics investigations which have led to the arrests and convictions of numerous offenders. The applicant is a sworn law enforcement officer and thereby has the authority to investigate criminal offenses and arrest those persons responsible for committing those crimes.


On 08/03/2009 Lt. Foster (Detective at the time) with the Forsyth County Sheriff's Office met with Ms. BILLINGS and her mother at 421 River Park concerning that she had some information about a homicide that may have occurred at 2749 Knob Hill Drive in Clemmons, NC 27012.

Ms. TERINA BILLINGS told Lt. Foster that her father, Mr. ALLEN BILLINGS, had been at a residence, located at 2749 Knob Hill Drive, approximately two weeks earlier (July 19th) to socialize with an occupant of the residence. Ms. BILLINGS told Lt. Foster when ALLEN BILLINGS returned home he told her that he had observed a dead body in the basement of 2749 Knob Hill Drive. Ms. BILLINGS told Lt. Foster that ALLEN BILLINGS told her that the body was covered with a plastic tarp and had cat litter and chlorine around the body to attempt to alleviate the odor. Ms. BILINGS told Lt. Foster that ALLEN BILLINGS told her that a resident of 2749 Knob Hill Drive, PAZUZU ALGARAD told ALLEN BILLINGS that he had shot the individual 10

times because he was a snitch. Ms. BILLINGS told Lt. Foster that ALLEN BILLINGS told her that PAZUZU then dismembered the body and ALLEN BILLINGS helped bury the dismembered body parts throughout the back yard of the residence of 2749 Knob Hill Drive.

Ms. BILLINGS told Lt. Foster that ALLEN BILLINGS told her that the decedent was a white male and possibly in his twenties, but could not provide a name. Ms. BILLINGS told Lt. Foster that ALLEN BILLINGS told her to not go to the residence of 2749 Knob Hill, and that he was looking at life in prison. Ms. BILLINGS told Lt. Foster that ALLEN BILLINGS told her that she could still smell the distinct odor of the decedent once he was home. Ms. BILLINGS provided a date of 07/17/2009 to Lt. Foster and stated that was the date that ALLEN BILLINGS told her this incident occurred. Ms. BILLINGS told Lt. Foster that she had attempted to speak with ALLEN BILLINGS further about the incident, but he will not talk about the incident

Also on 08/03/2009 Lt. Foster responded to Mr. ALLEN BILLINGS' residence to speak with him about the information that he allegedly told his daughter, TERINA BILLINGS. Mr. BILLINGS admitted to Lt. Foster that he had been to 2749 Knob Hill Drive on several different occasions, but he denied ever observing a deceased body or assisting with a burial. Mr. BILLINGS did tell Lt. Foster that PAZUZU told him on 07/19/2009 that he had shot and killed a "fat mother fucker" approximately 3 days ago with an assault rifle. Mr. BILLINGS further stated to Lt. Foster that PAZUZU told him that he had shot the decedent 10 times, Mr. BILLINGS said (to Lt. Foster) that he did not question PAZUZU about the murder and told PAZUZU that he did not want to know anything about it. Mr. BILLINGS told Lt. Foster that the following day 07/20/2009 PAZUZU called him and told him that he had chopped up the body and buried it. Mr. BILLINGS told Lt. Foster that while at the residence of 2749 Knob Hill Drive, that he recalled seeing several pistols as well as an assault rifle.

On 08/04/2009, Lt. Foster responded to the address 2749 Knob Hill Drive in hopes of establishing contact with a resident, more specifically, PAZUZU ALGARAD. Upon Lt. Foster's arrival, he did make contact with PAZUZU and informed him that he had received information from several individuals that he had shot and killed someone in his basement and buried the body in his back yard. PAZUZU denied any and all allegations to Lt. Foster. Lt. Foster observed an in-ground swimming pool, as well as a cat at the residence, so it is possible that chlorine and cat litter are stored at the residence.


Lt. Foster said that on 09/24/2009 the Winston-Salem Police Department received an anonymous Crime Stoppers tip, Caller # 29940 that contained information about a subject by the name of "TAZUZU", who resides on Knob Hill Road in Clemmons. The Crime Stoppers report stated that "TAZUZU" had shot a subject and buried them in his back yard. The Crime Stoppers report further indicates that the victim in question had been missing for about a month, and that he was described as a big or tall guy.


Lt. Foster stated that on 02/09/2010 the Winston-Salem Police Department's Cold Case Homicide Unit received two anonymous e-mails concerning PAZUZU. The information contained in the two e-mails stated that PAZUZU ALGARAD of 2749 Knob Hill Drive in Clemmons, and his girlfriend (known to the applicant as AMBER BURCH aka "Bubbles") picked up a homeless person from a gas station and shot him in the head. The e-mails further stated that the deceased was buried in PAZUZU's back yard under a tarp and described PAZUZU as a religious extremist with mental disorders such as schizophrenia and agoraphobia.

Also on 02/09/2010 Lt. Foster spoke to Ms. STACEY CARTER who was contacted by a friend, Ms. ALISON STITZER, who informed Ms. CARTER that Ms. STITZER was at a concert in Asheville, NC and learned that Ms. CARTER's ex-fiancé, JOSHUA WETZLER, had been murdered and was buried in PAZUZU's back yard. Ms. STITZER is a mutual friend of Ms. CARTER and JOSHUA WETZLER. Ms. STITZER told Sgt. Shinault (Detective at the time) that she called PAZUZU late last year when she hadn't seen or heard from JOSHUA WETZLER in awhile, because she knew that PAZUZU was acquainted with JOSHUA. Ms. STITZER stated she asked PAZUZU if he had seen or heard from JOSHUA lately, and PAZUZU told her "not to worry about fat Josh anymore", and then PAZUZU changed the subject.

On 02/15/2009 Ms. CARTER contacted the Davie County Sheriff's Office and reported her ex-fiancé, JOSHUA WETZLER, missing. Ms. CARTER told the Davie County Sheriff's Office that JOSHUA was last seen in mid June at her residence in Davie County. Ms. CARTER said JOSHUA was on a downward spiral with depression and drugs and that he was on probation. Ms. CARTER stated JOSHUA had recently lost custody of their child because of no electricity or running water at his residence. Ms. CARTER stated JOSHUA had no job or money and that he had a history of disappearing for periods of time. Ms.

CARTER told the Davie County Sheriff's Office that when she hadn't heard from JOSHUA after several months that she thought that he was "on the run" from probation, but after no one from their family heard from JOSHUA after the holidays they (the family) grew further concerned. Ms. CARTER further stated to Davie County Sheriff's Office that she and JOSHUA had a 5 year old son in common and despite his problems, he was a great father, and wouldn't go this long without contacting his son. Ms. CARTER further stated that JOSHUA was in constant contact with his mother in New York, and that she hadn't heard from JOSHUA either. Ms. CARTER stated that she had contacted all of JOSHUA's known associates, but no one had heard from or seen JOSHUA.

JOSHUA WETZLER is a 6'1", 37 year old white male that Ms. CARTER described as being heavy-set or overweight. Ms. CARTER considered JOSHUA to be homeless since his electricity and water had been turned off due to non-payment and his landlord had asked him to leave. Ms. CARTER stated that JOSHUA was into the "hippie scene" and frequented Grateful Dead concerts in years past. The applicant knows from past experiences when dealing with PAZUZU that he considers himself a hippie as well as satanic.

On 07/26/2009, JOSHUA's vehicle, a 1989 Buick, bearing VIN- 1G4AH51N2KT409537 and registration plate- YVZ- 6580 registered to JOSHUA was located by the Winston-Salem Police Department at an apartment complex located at 300 E Brookline Street in Winston Salem. The report (WSPD IR#0938502) indicated that the Police Officer found JOSHUA's vehicle parked illegally within the parking lot and found the driver's side window to be rolled down and the keys still inside the ignition. The Police Officer conducted a NCIC check of the vehicle and found that same had not been reported stolen. Efforts to locate JOSHUA on that date produced negative results.


On 02/23/2010 Lt. Foster applied for and was granted a search warrant for PAZUZU ALGARAD's residence, 2749 Knob Hill Drive, so that he could continue his investigation for JOSHUA WETZLER's disappearance. A collaborative effort with the North Carolina State Bureau of Investigation, Triad Bloodhounds, and the Davie County Sheriff's Office resulted in no physical evidence that indicated that a homicide had occurred at the residence. It should be noted that prior to applying for the search warrant, Lt. Foster had consulted with North Carolina State University, more specifically, Dr. Oliver, who worked with the North Carolina Archaeological Research Center, about potentially utilizing their equipment to assist with the search. Dr. Oliver's "crew" was currently about to begin another project and their services could not be retained until at least two weeks. The Forsyth County Sheriff's Office, as an agency decided that this investigation could not wait the above stated time, and decided to proceed with the utilization of Triad Bloodhounds. It is noteworthy to mention that Dr. Oliver (NCSU) had mentioned to Lt. Foster that cadaver dogs (Triad Bloodhounds) may or may not be able to detect a buried body with the given circumstances. However, decided to go forward with the search warrant. Lt. Foster conducted a non-custodial interview with PAZUZU while on scene, during the search and PAZUZU denied any and all involvement in a homicide, and the burying of any bodies in his back yard.

It is noteworthy to mention that detectives at that time did not have a specific location in the backyard to search. It should also be noted that there were three males that went missing from the Clemmons area between 06/2009-06/2010. Two of which have not been located (TOMMY DEAN WELCH and JOSHUA WETZLER). The third missing subject (JOSEPH CHANDLER) was found deceased in Yadkin County at the Yadkin County River. The cause of death was a gunshot wound to the head from a .22 caliber rifle. The suspect, PAZUZU ALGARAD was charged and convicted for his involvement with the death of JOSPEH CHANDLER, and received 5 years probation.

On 11/08/2011, CYNTHIA JAMES, PAZUZU's mother, came to the Sheriff's Office and requested to speak with a detective about a murder that occurred at 2749 Knob Hill Drive Clemmons, NC. CYNTHIA spoke with Detective Ammons and disclosed that sometime in the latter months of 2009 that PAZUZU, AMBER, and a stocky white male, approximately being between the ages of 20-30 years of age, that was identified to her as "Tommy" were partying at her house, 2749 Knob Hill Drive. CYNTHIA told Detective Ammons that she heard a gunshot and went to the area where she heard the gunshot and observed AMBER holding a rifle, and the "Tommy" subject slumped over on the couch. CYNTHIA told Detective Ammons that PAZUZU told her to leave the area, so she complied with his request. CYNTHIA further stated to Detective Ammons, that a short time later that night another white female, identified to her as DIXIE arrived and was helping AMBER bury the body in the back yard. CYNTHIA told Detective Ammons that she looked out her bathroom window and observed DIXIE and AMBER digging a hole in the back yard.

The applicant was assigned the Missing Person report of TOMMY WELCH on 08/05/2013. The applicant contacted TOMMY WELCH's mother, CHARLOTTE BRUBAKER, and obtained no new information concerning her missing son. TOMMY had been reported missing on 10/04/2009, and was last seen at his brother's apartment (Colonial Arms Apartments) at the corner of Lewisville-Clemmons Road and Kinnamon Road. TOMMY left his brother's apartment and was said to be walking to his apartment on Brewer Avenue, in Clemmons. TOMMY could be seen on video surveillance on 10/03/2014 at 1928 hours from a gas station located at 2471 Lewisville-Clemmons Road, near the intersection of Lewisville-Clemmons Road and Stadium Drive. TOMMY could be seen walking thru the parking lot of Lowe's Food and walks out of the camera's view. TOMMY was never seen or heard from since walking thru the parking lot. Despite the applicant's efforts no new leads have surfaced over the course of the applicant's investigation of TOMMY WELCH's disappearance.

On 08/22/2014 the applicant responded to 250 Ruby Lane, in Lexington, NC to speak with DANIEL PILCHER about an unrelated case. Upon making initial contact with DANIEL PILCHER, he asked the applicant if the applicant was there to speak with him about PAZUZU. It should be noted that the applicant is familiar with PAZUZU ALGARAD from numerous investigations, and calls for service when the applicant was assigned to the Patrol Division as well as the applicant's current assignment, the Investigative Services Division. The applicant told DANIEL PILCHER that he was not there to speak with him about PAZUZU, but urged him to talk about what he knew about PAZUZU. PILCHER stated that he lived with PAZUZU for approximately three months, and while living there PAZUZU disclosed that there was a body buried in his backyard. PILCHER told the applicant that PAZUZU showed him specifically where the body was buried. PAZUZU told PILCHER that the "fat motherfucker" was buried right there under a plastic tarp. The applicant requested PILCHER to indicate on a drawing where exactly the tarp and body were located. PILCHER indicated via the drawing that the tarp was near the house and the back door of the residence that leads to the basement. PILCHER told the applicant that if you exit the basement door (into the backyard) that the tarp was located just outside that door to the right. At the conclusion of the applicant's interview with DANIEL PILCHER, the applicant requested that DANIEL complete a written statement of the above mentioned information. DANIEL stated that he would complete the statement and contact the applicant when same was complete. It should be noted that the applicant has not yet received DANIEL's statement.


On 09/26/2014 the applicant received a Crime Stoppers Report from the Winston-Salem Police Department, which had been forwarded to the applicant's attention. The Crime Stoppers report indicated that a subject by the name of MATTHEW FLOWERS had information about the murder and burial of a subject at PAZUZU's house. MATTHEW FLOWERS indicated in the Crime Stoppers report that his ex-wife, DIXIE ROSS had assisted in the burial of the body. MATTHEW continues in his Crime Stoppers report that he anonymously reported same when he first received information about the homicide. MATTHEW provided his phone number, so after reading the report, the applicant contacted MATTHEW FLOWERS and urged him to come to the Forsyth County Public Safety Center for a non-custodial interview. MATTHEW informed the applicant that he would respond and arrive within a couple of hours.

Once MATTHEW FLOWERS arrived at the Sheriff's Office at which point the applicant escorted him to a non-custodial interview room. MATTHEW told the applicant that he had known PAZUZU for approximately 8 years. MATTHEW told the applicant that PAZUZU had told him that he had raped and murdered numerous people, but MATTHEW did not know if PAZUZU was serious, MATTHEW could not provide an exact date when he heard PAZUZU make these comments. MATTHEW told the applicant that he found out that PAZUZU's girlfriend, AMBER BURCH, and a girl that he used to date, DIXIE ROSS, had become close friends and that DIXIE was spending time at PAZUZU's on a regular basis. MATTHEW stated that when he returned from deployment that he and DIXIE began to "talk" again. MATTHEW stated that DIXIE told him that she was "a part of the family" (in regards to PAZUZU's "family") and that she had been involved in some "weird things". MATTHEW stated that he grew worried about DIXIE's welfare, as he knows that PAZUZU was extremely odd and sadistic. MATTHEW stated that he paid for DIXIE's flight to Washington State, where he was stationed while he was enlisted into the US Army.

MATTHEW told the applicant that when he picked DIXIE up from the airport and during the car ride to his residence, that DIXIE told him that PAZUZU and AMBER had shot a male in the back of the head with a .22 caliber rifle. MATTHEW told the applicant that DIXIE knew this because she helped them (PAZUZU and AMBER) bury the body shortly after he had been shot. MATTHEW told the applicant that DIXIE told him that AMBER called her (DIXIE) and told her that they needed her help and wanted her to come over.

MATTHEW told the applicant that once DIXIE arrived at PAZUZU's residence (2749 Knob Hill Drive), AMBER told DIXIE they (PAZUZU and AMBER) had shot a guy and that they needed help burying the body. MATTHEW told the applicant that DIXIE told him that PAZUZU could not help with burying the body because he (PAZUZU) was jumping on the body yelling "you fucked up mother fucker" and in the process rolled his ankle. MATTHEW said that DIXIE told him that she went to the back yard and began helping dig with AMBER. MATTHEW told the applicant that DIXIE told him that she did not know how long she dug, but that DIXIE remembered trying to hurry. MATTHEW told the applicant that DIXIE told him that they (AMBER and DIXIE) didn't dig the hole deep enough, so the body was protruding from the ground. MATTHEW told the applicant that DIXIE told him that she, PAZUZU and AMBER decided to attempt to break the victim's legs, by swinging the shovel and striking his legs and arms and arms so that the body would fit into the hole. MATTHEW told the applicant that DIXIE told him that this was not successful, so a plastic tarp was placed over the body. MATTHEW told the applicant that he did not know what to do with this information, so he anonymously contacted the Winston-Salem Police Department's Homicide Unit/Crime Stoppers and told them what he had heard (without bringing DIXIE's name up). MATTHEW told the applicant that weeks went by and he had not seen or heard anything about PAZUZU, so he regularly contacted PAZUZU, in hopes of hearing from him that the police had come by.

MATTHEW told the applicant that approximately 1-2 months later (unknown exact date) PAZUZU called him "freaking out" and was calling DIXIE a bitch and a snitch because no one else knew. MATTHEW said that he took leave from the Army and told PAZUZU in person that he was the one who reported him to law enforcement and that he wasn't scared of him. MATTHEW told the applicant that he would testify to what he knows. The applicant asked MATTHEW if he knew where DIXIE currently was, to which he stated that he didn't know specifically where she was, but knew that she was in Winston-Salem and dating a male by the name of CAMERON MYERS. The applicant gathered a physical description of CAMERON MYERS, from MATTHEW due to numerous results from a query in Pistol/RMS for CAMERON MYERS.


On 09/29/2014, the applicant then began to search local databases and through the investigation located an updated address for CAMERON. The applicant responded to that location and once there, made contact with DIXIE ROSS. The applicant requested that she come to the Forsyth County Public Safety Center for a formal interview. DIXIE informed the applicant that would be fine and stated that she would be there within an hour or two.

DIXIE arrived at the Forsyth County Public Safety Center and the applicant then escorted her to a non-custodial interview room. DIXIE informed the applicant that she had been friends with PAZUZU and AMBER BURCH and spent much of her time at the residence of 2749 Knob Hill Drive in Clemmons, NC. DIXIE told the applicant that she recalled a conversation between her and AMBER that took place approximately 09/29/2009. DIXIE stated that she remembers this incident like it was yesterday, DIXIE stated that AMBER looked at her and said "Hey, Can you keep a secret?" DIXIE stated that when she replied "yes" that AMBER asked DIXIE to promise not to tell anyone, even PAZUZU. DIXIE stated that AMBER then leaned in and whispered to her and told her "I'm going to do my first". The applicant asked DIXIE what she interpreted same to mean, to which she thought AMBER was referring to premeditated murder. DIXIE stated that she inquired further into AMBER's statement and she stated, "You know like PAZ". It should be noted that PAZUZU is often referred to as "PAZ". DIXIE told the applicant that she then recalled a time where PAZUZU stated that he had killed people and that the bodies were buried in separate locations within his back yard. DIXIE stated that she tried to "pry further" into AMBER's statement, but AMBER changed the subject. DIXIE stated that she did not inquire further about AMBER's intentions.

DIXIE told the applicant that approximately 3 days after the above mentioned conversation (DIXIE believed the date to be 10/03/2009) she received an alarming text message from AMBER that stated something to the affect of "I need your help and need you to come over right away". DIXIE stated that she immediately began getting dressed, to head over to PAZUZU's residence. DIXIE told the applicant that prior to leaving; she received another text message from AMBER that stated "Never mind". DIXIE stated that she ignored this message and responded on to PAZUZU's residence (2749 Knob Hill Drive). DIXIE stated that once she arrived at PAZUZU's she observed AMBER sitting on the front porch. DIXIE said that she walked up to AMBER and she stated that AMBER said: "I just did my first", with a smile on her face. DIXIE stated that because AMBER was smiling, she assumed that AMBER was playing a joke on her. DIXIE stated that they (presumably PAZUZU and AMBER) picked up a "hitchhiker" and that he was outside in the back yard. DIXIE stated that at this point she did not believe what AMBER was saying, and DIXIE recalled asking where PAZUZU was. DIXIE told the applicant that AMBER "halfway laughed" and AMBER


replied that PAZUZU had tripped and hurt his ankle while jumping on the "hitchhiker". DIXIE said that AMBER then invited her into the residence. DIXIE said that she was afraid to say no, and curious as whether or not this was a joke. DIXIE stated that she observed PAZUZU's dogs inside and that she and AMBER proceeded into the living room where PAZUZU was sitting on the couch. DIXIE stated that once PAZUZU saw her, he placed his hand over his face and said out loud "Are you fucking serious"? "You told her"? DIXIE said AMBER said "No, I didn't tell her, she's just going to help me make a hole for those trees we're planting". DIXIE said that she did not know anything about any trees, and that it was at this point that she realized that this was not a joke. DIXIE told the applicant that she followed AMBER downstairs to the basement, where they retrieved two average sized shovels. DIXIE said that she asked AMBER what was going on, and AMBER replies "Don't worry about it, I will tell you later". DIXIE and AMBER then went outside to the backyard.

DIXIE told the applicant that once she was outside, she went to the backyard and observed a black tarp laying flat over what appeared to her to be a body. DIXIE said that AMBER asked her if she wanted to look under the tarp, being afraid to say no, and wanting to know what was going on, DIXIE answered "yes". DIXIE said that she saw a white male's arm and the side of his torso. DIXIE said the male was laying face down, on his stomach. DIXIE said that AMBER then walked over towards the middle of the yard and said "come on". DIXIE said that she replied, "What the fuck is going on"? DIXIE said that AMBER said that "she would tell her later" and that they had to dig before the sun came up. DIXIE remembered that the ground was extremely hard and it was difficult to dig. DIXIE said that adding to her struggles, her sandals kept falling off when she jumped on the shovel. DIXIE said that she took this opportunity as an excuse to discontinue the digging. DIXIE told AMBER that she couldn't continue because her sandals kept falling off. DIXIE said that AMBER then took her own shoes off and gave them to DIXIE to wear. DIXIE said that AMBER then put on shoes that she had never seen before. DIXIE said that AMBER then began to sing "I'm wearing a dead man's shoes" over and over out loud. DIXIE said that she asked AMBER, "Are you serious"? Per DIXIE, AMBER laughed and replied "Yeah". DIXIE stated that she was disgusted, but continued to dig, for what seemed like hours. DIXIE said that the hole was then a few feet deep, and PAZUZU came out of the house, wearing his knife as he usually does (clipped onto his belt). DIXIE said that PAZUZU took a look at the hole and told them (DIXIE and AMBER) to put the body in the hole. DIXIE and AMBER then looked at one another and said that the hole was too small, and the body wouldn't fit. PAZUZU told AMBER and DIXIE that it would be fine and to put the body in the hole. DIXIE said that she started to tell PAZUZU "No", but PAZUZU said "Bitch, there's plenty of room for you in this yard, too", while looking around his back yard with his arms up. DIXIE said that she refused to drag the body, and told PAZUZU that he and AMBER would have to. DIXIE said that PAZUZU spat on the ground and replied "Alright, fine". DIXIE said that both PAZUZU and AMBER walked over to the body and they began to drag the body by the feet, with the tarp still lying on top. DIXIE said that once the body was near the hole, AMBER and PAZUZU removed the tarp and began to try and attempt to force the body into the hole. DIXIE said that this was when she first observed the entire body. DIXIE said that the body was that of a white male, with what she believed to be light brown or sandy blonde hair, weighing approximately 200 pounds. DIXIE said that the decedent was wearing only boxers, and described the boxers to be possibly white and blue (possibly striped or checkered). DIXIE stated that she recalled seeing the eyes of the decedent, and remembered them being grey and cold looking. DIXIE also stated that she recalled seeing the bullet hole in the back of the decedent's head. DIXIE further elaborated that the bullet hole was in between the back and side of the head. DIXIE said that PAZUZU and AMBER "flipped" the body over into the hole. DIXIE told the applicant that the body didn't fit into the hole, and suggested to PAZUZU that they move the body into the fetal position. DIXIE said that PAZUZU didn't listen and he stated "they (AMBER, DIXIE, and PAZUZU) need to break his legs and arms". DIXIE said that she watched as AMBER and PAZUZU began to swing the shovels (like baseball bats) and strike the decedent's legs and arms. DIXIE said that she didn't recall seeing any damage, but vividly recalls the noise the shovels made when they struck the decedent's body. DIXIE told the applicant that she didn't recall hearing any bones break. After PAZUZU and AMBER were "done" striking the decedent with the shovels, AMBER asked DIXIE to continue covering the body with dirt. DIXIE said that while she and AMBER were shoveling dirt over the body, PAZUZU's mother, CYNTHIA JAMES came outside and acted as if she was "pulling weeds", but it was obvious that she was "eavesdropping" on what was occurring. DIXIE said that PAZUZU cursed at his mother and told her "get the fuck back inside". Once out of dirt, and DIXIE could see the decedent's knee, and part of the head sticking out above the ground. DIXIE said that she pointed this out to both PAZUZU and AMBER and then proceeded to pull the tarp over the body. PAZUZU then grabbed random items from around the back yard to place on the tarp.

DIXIE said that at this point, AMBER suggested that they clean the shovels, by dunking same into the pool. DIXIE added that PAZUZU kept his pool overly chlorinated, and that AMBER must have thought that this would remove any evidence of a crime from the shovels. DIXIE said that she and AMBER went into the basement and AMBER hid the shovels behind some

"junk". DIXIE said that she followed PAZUZU and AMBER upstairs, where they said the shooting occurred. DIXIE said that both AMBER and PAZUZU both told her parts about the murder. DIXIE said that AMBER told her that they (presumably PAZUZU and AMBER) picked up a "hitchhiker" to party with. DIXIE told the applicant that they returned to PAZUZU's and

while they were partying they began to ask the decedent questions such as, his family, if anyone was expecting him, etc. DIXIE said that AMBER then walked into PAZUZU's room and retrieved a gun and shot him in the back of the head. DIXIE told the applicant that they told her that the decedent was sitting on the left side of the couch (if facing the couch). DIXIE said they said that he didn't even see it coming. DIXIE said that it appeared as if they were bragging. DIXIE said that they told her "if you tell anyone, even NATE (NATE ANDERSON was DIXIE's boyfriend at the time) that she would be their "second" or maybe "third". It was at this time that they allowed DIXIE to leave, but asked her if she was going to come back over (in the future). Being scared DIXIE replied, "Yes".

During the same interview, DIXIE told the applicant that she returned to PAZUZU's two days later, and pretended that they (PAZUZU and AMBER) were still her friends. DIXIE said that everyone there was drinking and acting like drunken idiots, and DIXIE began taking pictures of everyone. DIXIE said that she made sure that she captured the tarp that was still covering the body in the background of the pictures. DIXIE was hoping that she would have had the courage to take the pictures coupled with her story to the law enforcement, but stated she just couldn't.

DIXIE continued with the interview and told the applicant that there was a small "get together" at PAZUZU's approximately two weeks after the murder and burial. DIXIE stated that AMBER asked her to help her with body again, because it was beginning to smell. DIXIE hastily told AMBER that there were too many people at the residence that could see what they were doing. AMBER comforted DIXIE and stated that PAZUZU would keep the people away. DIXIE stated that she agreed to help once again, and once outside DIXIE observed that there was a pile of loose dirt by the body and tarp. DIXIE said that she and AMBER began to shovel the loose dirt onto the body. DIXIE added that the smell was so foul that she had to cover her face with her sweatshirt. DIXIE told me that once the dirt was on the body, that she and AMBER began swinging their shovels in an overhead fashion, to compact the dirt. DIXIE said that this did not alleviate the smell at all. DIXIE noticed that her boyfriend, NATE ANDERSON, was observed by PAZUZU, peeking through the window towards the back yard. PAZUZU then came outside to the back yard and told DIXIE to go check on NATE. DIXIE said that she went to the front porch where NATE was and he was extremely intoxicated. DIXIE said that NATE saw her in the back yard and that he thought that she was participating in their (PAZUZU and AMBER's) weird rituals or something to that affect. DIXIE said that she was relieved that NATE didn't really know what they were doing, but told him a lie and stated that she wasn't doing anything like that; rather she was helping them build a fire pit. The applicant asked DIXIE if there was a fire pit in the back yard, to which she stated that there was not. The applicant asked DIXIE if she was sure, to which she stated that she was 100% sure, and that she had been in that back yard over 100 times and had never seen a fire pit. I then asked DIXIE what made her think of telling NATE about a fire pit. DIXIE said that PAZUZU had often talked about building a fire pit, because his dogs would dig up the animal sacrifices that he had buried and chew on the remains. DIXIE said that she was just "thinking on her feet" and the first thing that came to her mind was a fire pit. DIXIE stated to the applicant that NATE "bought" her story and that he didn't know anything about the body.


It was at this point that the applicant showed DIXIE photographs from the 02/23/2010 search warrant, in an attempt to locate where exactly the body was buried in the back yard. DIXIE told the applicant that the body was near the fire pit (that she had never seen until the photographs that I showed her). DIXIE viewed more photographs from the inside of the residence, and said that the couch in the living room is where PAZUZU and AMBER told her that decedent was shot in the back of the head.

The applicant asked DIXIE if she could complete a written statement and return same to the applicant tomorrow and also if she could attempt to locate the pictures that she had taken at the crime scene a few days after the murder and burial. DIXIE stated that she would complete the statement and attempt to locate the photographs she had taken.

The following day 09/30/2014, the applicant received a message that DIXIE was in the lobby of the Forsyth County Public Safety Center and wishing to speak with me. I responded to the lobby and escorted DIXIE to a non-custodial interview room. Once there, DIXIE produced her 13 page written statement, which I read to her verbatim. DIXIE also produced numerous photographs of PAZUZU, AMBER, herself, and a subject by the name of DAVE QUEEN. DIXIE stated that DAVE had no knowledge of the body. In the photographs I observed a tarp in the background of several photos. I asked DIXIE if this was



where the body was buried and covered, as mentioned in the interview the day before, to which DIXIE said "yes". I thanked DIXIE for providing the photos, and asked if I could take the pictures as evidence, to which she adamantly stated "of course".

The applicant contends that all of the information, when taken in its entirety, provides probable cause to believe that the crime of murder occurred at 2749 Knob Hill Drive Clemmons, NC 27012. The applicant also contends that there is probable cause to believe that a search of 2749 Knob Hill Drive Clemmons, NC 27012 will produce remains of the deceased, firearms, tools used to bury human bodies, dismember human bodies, evidence showing relationship between the missing persons, and PAZUZU, evidence to identify potential co-defendants, and evidence identifying other possible victims. The applicant therefore respectfully requests that this application for a search warrant for the location of 2749 Knob Hill Drive Clemmons, NC 27012, be granted.
