ENROLLMENT DEADLINE APPROACHES!

You may be aware that due to the fact that May 1st falls on a Sunday **the deadline for enrollment and project additions and/or deletions is 4:30 PM on April 29, 2022.** What you may not realize is that, although you may have enrolled online, you are technically not re-enrolled if you have not paid your enrollment fees. You must be enrolled online AND have all enrollment fees paid to the 4-H Office by 4:30 PM of Friday, May 2nd in order to be able to participate in the 2022 Delta County Fair.

The 2021/2022 fee for **regular 4-H members** (8-18 years of age) is **\$50.00** for the first two projects and \$5.00 for each additional project beyond the first two. **Cloverbud** (ages 5-7) fees will be **\$30.00**. (All ages are based on December 31st, 2021.) Returning members must have re-enrolled by close of business on February 1st to avoid paying a late fee. Members re-enrolling after this deadline will be assessed a **\$20 per member** late fee. (Late fees do not apply to Cloverbud, new member, and leader enrollments.)

There are several families that have been on the 'pending' list for quite a while. Please be aware that, though you may have enrolled online, if you haven't paid your fees you are not actively enrolled! In addition, this applies to market livestock enrollment deadlines. If you have enrolled online but you have not paid your fees by the deadline you will not be allowed to weigh-in/tag-in your animals!



Market Sheep, Goat and Swine Enrollment Deadline

4-H members who want to enroll in the 4-H market sheep, goat or swine project **MUST** have their enrollment for this project posted online and enrollment fees paid to the Delta Extension Office by 4:30 PM, on **Friday, April 29, 2022.**



Meat Quality Assurance Trainings

The following is the “Official” State 4-H policy regarding the Meat Quality Assurance Act and the required training:

- Any 4-H member enrolled in a market or breeding livestock project that has not previously attended training **must do so.**
- Any 4-H member who was a Junior (age 13 or under) and is moving into the Senior division in 2022 (age 14 as of December 31, 2021), will be required to attend the training.
- **Everyone** enrolled in a 4-H livestock project must sign the Tri River Area 4-H Commitment to Excellence.



In summary, all 4-H members must attend the Wholesome Meat training once as a Junior (13 and under) and once as a Senior (14 and over). You may attend training in another county if you cannot make the date scheduled in your county. Be sure to sign in when you arrive, this way we have a record of your attendance. Attendance at a MQA Class will fulfill swine members Pork Quality Assurance Training requirements. Below is a list of dates for these trainings:

- April 25 - Meat Quality Assurance Class, 6:30 PM, Montrose County Fairgrounds
- April 26 - Meat Quality Assurance Class, 6:30 PM, Heritage Hall, Delta County Fairgrounds
- April 27 - Meat Quality Assurance Class, 6:30 PM, Mesa County Fairgrounds

COLORADO 4-H DOG IDENTIFICATION CERTIFICATES



In order for animals to be shown at the 2022 Delta County Fair all dog identification certificates must be uploaded to 4HOnline by 4:30 PM on April 29, 2022. (Please be aware that May 1st is a Sunday and we will not be open.) Instructions on how to do this are available in your dog record book. Members must designate all dogs that will or might be participating in their 4-H project.



STATE FAIR RULE FOR GENERAL PROJECTS!

If a member enrolls in two units of the same project (For example: leathercraft. A member enrolls in Unit 2 & Unit 3) they must exhibit in the higher unit. When a member takes two units at the same time, they should master the skills of the lower unit and therefore exhibit in the higher unit.

RECORD BOOK COVER REQUIREMENT!

ALL record books must be turned in enclosed and secured in binders. Please hole punch your pages and use either ACCO or brad type binders. Three ring binders are still acceptable, however we do ask that they be no more than 1 inch thick. Be sure to double check that ALL pages/photos/receipts are securely attached inside your binders. The member name and project should be clearly visible on the outside of the binder. Please be sure to either write or attach a label with this information to the cover of your binder. (If you have a see-through cover and the front page of your record book can be seen you can skip this step.)

The 4-H Office is not responsible items that are lost from record books.



RECORD BOOK POLICY



All Delta County 4-H members with general projects (those that are displayed in the exhibit hall) who do NOT bring an exhibit to the 2022 Delta County Fair will be required to turn in their record books on September 2, 2022 - which is the same date that the livestock, horse, dog and shooting sports record books are due! The 70% completion requirement will apply to these books. In addition, general project members who do not participate in the 2022 Fair and fail to turn in their record book(s) will not be allowed to participate in those project(s) the following 4-H year.




Important Horse Levels

The highest level test that a member has taken and passed (both written **and** riding) as of June 24, 2022 is the level that member will be allowed to exhibit in at the 2021 Delta County Fair! Written levels tests will not be given at the Delta Extension Office from July 1, 2022 through August 31, 2022.

Delta County Horse Leaders who are giving Horse Levels **RIDING** tests need to be sure to turn in all completed tests to the Delta Extension Office. This is the *only* way we have of knowing which members have passed the different riding levels. If you do not turn this information in, we will assume that the information we have on file is the most current

ATTENTION HORSE MEMBERS!!!



It is that time year when all you can think about is getting on your horse and riding. There is still one last piece of information that each of you must upload into 4HOnline. You must have a Horse ID for each horse that you may ride uploaded, plus a \$2.00 fee per horse identified turned in to the Delta Extension Office, by 4:30 PM on **April 29th**. The Horse ID Certificate may be found in your E-record or you can pick one up at the Extension Office.

DELTA COUNTY 4-H

Eligibility:

- ✓ You must be a graduating member of the class of 2022 from a school program located in Delta County, Colorado
- ✓ You must have completed 1 year of 4-H and be in good standing the year prior to applying
- ✓ You must plan to attend a university, community college, vocational center, or other type of learning institution in the fall following graduation
- ✓ You are required to participate in the current year Delta County Fair
- ✓ You must be currently enrolled in the Delta County 4-H Program your graduating year of high school and complete all 4-H and project requirements



Interested high school seniors who meet the above requirements need to contact the Delta County Extension Office at 874-2195 for more information, application requirements, and an application form. **Applications are due by April 18, 2022.**

These scholarships are intended to provide financial assistance to deserving students, but are not intended to cover all expenses.





FIRST YEAR LEADER BACKGROUND CHECKS



All first year leaders will be submitted for a background check. (Consent for this is given when you fill out and sign your Volunteer Leader enrollment.) After you have enrolled online you will receive an email requesting that you go to a secure website called HireRight, which is approved by CSU, and provide requested information. Background checks cannot be completed without your information. Your enrollment will remain pending until your background check is complete. Please note that if you do not complete this information you will not be allowed to participate in the 4-H program as a leader. (All information remains confidential—even the county offices are not provided with details.) If you have any questions regarding first year leader background checks, please call Jackie at 874-2198.


