Incident Narratives

Original Narrative

On 6/22/2026 I was dispatched to 4610 Highway 25 North within the county of Greenwood, in reference to an assault. Upon arrival, I met with [REDACTED] who advised that there was an incident that occurred between her employee and a customer. I was advised that the customer later identified as Kimberly Rowe accused the cashier later identified as [REDACTED] as being "rude". I was advised by [REDACTED] that verbal argument ensued between [REDACTED] and Kimberly which then lead to a physical altercation. I was advised by [REDACTED] that she did have the altercation on video and I then observed the security footage. I then observed Kimberly at the register and a short time later I observed the two then engaged into a verbal dispute and a short time later Kimberly then attempted to pick up a container of sodas. I then observed [REDACTED] reach across the counter and grasp the soda container and pull it back towards the register. The container then ripped and at that time Kimberly then shoved the container towards [REDACTED] which appeared to strike [REDACTED]. I then observed [REDACTED] then throw a soda can at Kimberly which appeared to strike her in the arm. I then observed Kimberly talking on the phone and [REDACTED] walk around the counter and speaking to Kimberly. I then took a video of the footage and was advised by [REDACTED] that she wished for Kimberly to be placed on trespass notice from the store. I then advised [REDACTED] that I would attempt to make contact with Kimberly and place her on trespass notice. I then made contact with Kimberly at [REDACTED] and was advised by Kimberly that upon checking out [REDACTED] was very rude and had an attitude. I was advised by Kimberly that after paying for several items she attempted to purchase a container of soda. I was advised by Kimberly that she advised [REDACTED] that her son was going to pay for the sodas to which [REDACTED] then voided the transaction due to the soda's already being scanned. I was advised that while doing so [REDACTED] then started acting rude about the situation and Kimberly then confronted her about her attitude. I was advised that a verbal dispute then ensued, and she called [REDACTED] several racial slurs due to her being upset. I was then advised by Kimberly that she then attempted to move the soda container so that her son could pay for the drinks and at that time [REDACTED] then grabbed the container causing it to break. I was then advised by Kimberly that she then pushed the container back towards [REDACTED] but that she did not strike her with it. I was advised that [REDACTED] then picked up one of the soda cans and threw it at her striking her in the arm. I then advised Kimberly that due to the incident being mutual combat that I would be filing a report with the GCSO and placing her on trespass from the property. I then provided Kimberly with the trespass notice and was advised by Kimberly that she understood that she could not return and the consequences if she did.

I attempted to make contact with [REDACTED] via cell phone [REDACTED] with negative contact.

I was later contacted by Kimberly who stated that part of the incident was recorded by a witness and posted the video to Facebook. I was advised by Kimberly that since it has been posted someone used public information to post her phone number, address, and her family's information. I was advised by Kimberly that she has now been receiving calls and messages and that she wished for the GCSO to be aware and a screenshot of the post was sent to me and uploaded into the attachment portion of this report. I advised her that I would conduct property checks throughout my shift.

My BWC was active throughout the duration of this incident.
