That on May 15 th , 2024 the defendant, Bryan Joseph Getchius, knowingly, intentionally and without authority of law had in his
actual possession a blue-in-color prescription pill bottle with approximately 65 blue-in-color, round pills scored "LAN 1282," and
approximately 3.26 grams of a blue-in-color powder, both of which field tested presumptive as Fentanyl, a Schedule II controlled
substance. The pills appeared to be poorly made, broke apart with a very small amount of force and were consistent with
clandestinely manufactured Fentanyl pills. Getchius was found to be in possession of the controlled substances during a lawful
traffic stop near the intersection of Bypass 25 NE and Commerce Circle West, within the County of Greenwood. This is in violation
of SC Code of Laws. GCSO Case # 24-2137, R/O D. Keener.

On 05/15/2024 at approximately 2312 hours, while on proactive patrol in the area of Bypass 72, I observed a silver-in-color, Toyota Camry (bearings SC tags of: YBR184) swerving between the #1 and #2 lanes; at one point, straddling the center line. I caught up with the vehicle as it went under the train trestle near the old Greenwood Civic center and activated my blue lights to conduct a traffic stop. The vehicle pulled into the parking lot of Emily's Buffet and came to a stop. I approached and identified myself to the driver, Bryan Getchius (W/M, DOB: 03/05/1984). I advised Bryan of the reason for the traffic stop and requested the necessary documents (driver's license, registration and proof of insurance), but Bryan presented me with a Florida Identification card and was unable to provide any additional documents.

Bryan advised that he had an ID card, but that his license was under suspension. Bryan stated that he was living in the area with his mother and then stated that he was living in Florida. He stated that he was working in Florida, but multiple times, it appeared as though little details would change about where he was actually living. While speaking with Bryan, I observed that he was sweating profusely on his head/neck area, visibly shaking and breathing extremely heavily. Bryan was also observed responding slowly to simple questions and stuttering when doing so. I questioned Bryan about this and Bryan advised that he was only nervous due to his license being suspended. Bryan was then asked to exit the vehicle and did so without incident. Once out of the vehicle, it became more obvious that Bryan was nervous.

Bryan's hands were observed shaking, and he continued to sweat more and more. I then asked Bryan if there was anything illegal in the vehicle, to which Bryan stated there was not. I then asked Bryan for consent to search his vehicle and Bryan agreed. While doing so, Deputies located numerous prescription pill bottles prescribed to Bryan. In one bottle, labeled "Dicyclomine Hydrochloride 10mg", I located ten (10) blue-in-color capsules, labeled "Lannett 0586" along with sixty-five (65) light blue-in-color, circular shaped pills scored "LAN 1282", which were identified by their markings as Dicyclomine Hydrochloride 20mg. Bryan was then advised of his Miranda Rights and stated that he understood.

The pills appeared to be poorly made and broke apart with a very small amount of force. A large amount of light blue powder was also located in the bottom of the pill bottle and had an approximate weight of 3.26 grams. Due to Deputies having prior knowledge of pills consistent with these being clandestinely made and containing Fentanyl, Deputies conducted multiple field tests with not only the pills themselves, but also the loose powder. All of which, indicated a positive reaction for the presence of Fentanyl! Bryan was advised that he was being placed under arrest for Possession of a Schedule II Controlled Substance.

Bryan was then placed into the rear of Deputy Stevens marked patrol vehicle #: 121, transported to GCDC, where custody was transferred to jail personnel without incident, and he was booked and lodged. Upon further investigation of the blue capsules, Deputies field tested the contents, which did have a positive reaction for the presence of Cocaine and the capsules/powder had a total combined weight of 2.60 grams.

Bryan was charged with Trafficking Fentanyl (pills), PWID Fentanyl (powder) and Possession of Cocaine.

Agner's Garage responded to the traffic stop location, took possession of the vehicle, and it was towed.

The illegal substances were placed into a S.L.E.D. B.E.S.T. kit (B.E.S.T. kit #: B376672) and placed into GCSO temporary evidence locker #: 18 to be sent off for analysis. Two cell phones (white-in-color iPhone and a blue-in-color iPhone/clear case) were seized and placed into GCSO temporary evidence locker #: 18 pending further

investigation. Photographs have been attached.

BWC and dash camera were on and active throughout the duration of the traffic stop. There is nothing further to report at this time.


