On 01/04/2026 at 0259 hours, I responded to [REDACTED] Hall Street in reference to an unknown problem.

Upon arrival, I observed [REDACTED], lying in the roadway, directly in front of [REDACTED] Hall, head facing south, and his feet facing west. I immediately attempted to assess the wound severity by unzipping his black jacket. This is when I observed [REDACTED] to be deceased, after suffering a gunshot wound to the left armpit. While attempting to establish where the incident occurred, I observed a white camera above the front door of [REDACTED] Hall. This information was relayed to responding officers.

As officers began arriving, Hall St was blocked by marked patrol units. PFC Keller and Capt. Budreau began placing crime scene tape up around the area. A crime scene log was started by PTL Lopez. While in the roadway, I noticed two occupants exit [REDACTED] Hall, and begun speaking spanish. Officers made contact with those occupants, identified as [REDACTED], were observed assisting another hispanic male, identified as [REDACTED], who suffered a gunshot wound to the left thigh. Officers entered the residence, I then assisted that male to the floor in the front room of the residence, in which myself, Ofc. Hill and Ofc Keller removed his clothing, and applied a tourniquet at the highest point of his thigh. Officers then assisted the two females out of the residence, and outside the crime scene.

No other injuries were located on this victim, and we stood by with him until EMS arrived and removed [REDACTED] from the residence.

During providing aid, other officers conducted a protective sweep of the residence and located no other persons inside the residence. During this sweep officers did view in plain sight several items which appeared to be illegal narcotics along with large sums of currency.

I assisted in securing the crime scene, until detectives arrived on scene at which time the scene was turned over to Major Shockley. Further information will be added in officers supplemental reports.
