SLED CHARGES FORMER GREENWOOD COUNTY SHERIFF'S LIEUTENANT WITH MISCONDUCT IN OFFICE AND DISTRIBUTION OF METHAMPHETAMINE

The South Carolina Law Enforcement Division (SLED) charged Mark Grayson Davis, 39, with Misconduct in Office and Distribution of Methamphetamine – First Offense on Tuesday, May 19, 2026. The Greenwood County Sheriff's Office requested the SLED investigation.
