Affordable Workforce Housing Annual Fee Update. Kristi Malone, Joint Planning Staff, presented to the Joint Board for consideration of approval an update to the Town and County Affordable Workforce Housing fee-in-lieu value as required annually. Pursuant to the Teton County and Town of Jackson Land Development Regulations Sec. 6.3.5.D.5:

The Board of County Commissioners/Town Council shall update the fee in-lieu amount annually, by Resolution, based on the cost of developing the required affordable workforce housing and the resale value of the required affordable work-

The cost of development shall be provided by the Housing Director to reflect the full development cost of habitable floor area, including land and non-habitable floor area, based on recent past development.

ii. Unit sizes shall be assumed to be a). 1 Bedroom/Studio: 650 sf habitable b). 2 Bedroom: 900 sf habitable c). 3 Bedroom: 1.150 sf habitable

iii. The maximum sales and rental prices shall be as established by the Housing Department annually pursuant to the Rules and Regulations.

iv. The capitalization rate for rental units shall be assumed to be eight percent (8%).


