Stilson Wildlife Permeability Measures

Heather Overholser, Director of Public Works, and Chris Colligan, Project Manager, presented a workshop regarding Stilson Wildlife Permeability Measures.

On July 16, the Board of County Commissioners considered and approved a Conditional Use Permit for the Stilson Transit Center (CUP2024-0001). There were discussions about wildlife permeability mitigation measures that should be considered, which are not conditions to the CUP because they would apply to other parcels in the Stilson area, and not to the Stilson Transit parcel. Staff was directed to bring the items outlined below for further discussion and consideration by the Commission at a workshop.

The Stilson Transit Center site is on the boundary between two "character districts," County Valley and River Bottom. The upgraded Stilson transit center will meet County policy objectives of both districts by providing greater transit access and support the connectivity and mobility for residents, area workers, and visitors. The Comprehensive Plan goal for these two character districts includes preserving wildlife habitat and scenic vistas. To achieve this goal, the Commission indicated interested in looking to other parcels in the Greater Stilson area to protect wildlife permeability.

Permeability for wildlife through the Stilson area is critical to the current health and movement of wildlife populations and will become even more important with the recent installation of four wildlife crossings, two of which are directly adjacent to the Stilson parcels. Teton County Public Works has been closely involved in the planning and stakeholder processes for the reconstruction of the WY 22 Snake River Bridge and the WY 22/390 intersection, as well as the construction of four wildlife underpasses in the Stilson vicinity. Through the Stilson Transit CUP approval process, there was recognition of the ecological value of the greater Stilson area and how it contributes to wildlife permeability and movement throughout the Snake River corridor. As such, the Board directed staff to further develop four concepts for protecting and enhancing wildlife permeability throughout the greater Stilson area discussed in this workshop




