Teton County is issuing this Request for Proposals ("RFP") in search of a qualified consultant with expertise and experience in habitat restoration and land conservation planning to develop a vegetation restoration project and assist with conservation planning for Teton County's property located at the junction of Wyoming Highway's 22 and 390. The area, colloquially known as the Greater Stilson area, includes the Stilson Transit Center, private properties under Teton County Scenic Preserve Trust, private property currently used for skier parking, and property set aside for future recreational use (8.5 acres) owned by Teton County, Teton County is considering the placement of a conservation easement on the Teton County Parks and Recreation parcel at Stilson (in its entirety or a portion) via the Teton County Scenic Preserve Trust.
