Resolution Endorsing and Supporting the Town of Jackson's Plastic Bag Ordinance

WHEREAS, the Town of Jackson, Wyoming, a first-class city within Teton County, Wyoming, adopted in January 2019, Ordinance P, banning the free distribution of single-use plastic bags. The new Town of Jackson ordinance goes into effect within the Town of Jackson on April 15, 2019 as to grocers and large retailers, and on November 1, 2019 as to small retailers, WHEREAS, the Town of Jackson made findings within their adoption of Ordinance P banning the free distribution of single-use plastic bag, as follows:

1. The Town of Jackson has a responsibility to protect the natural environment, economy, and health of its citizens; and

2. The Town of Jackson . . . is committed to: pursuing a waste diversion goal of sixty percent (60%) or better; preserving Jackson's unique environmental resources for generations to come by limiting environmental degradation and waste; and promoting practices that are sustainable and minimize harms to the natural environment; and

3. The Town of Jackson . . . is committed to minimizing the amount of solid waste it directs to landfills with an ultimate goal of "zero waste" by increasing efforts such as recycling and composting of waste; and

4. The Town of Jackson . . . is committed to be a model of sustainability and support public and private sustainability

In the Town of Jackson, innumerable single-use disposable plastic bags are used each year that cannot be recycled in a cost-efficient manner; and

6. Single-use disposable plastic bags create waste, pollute the Town and County's waterways, roadways, landscapes and harm wildlife populations; and
7. The Town Council made the finding and determined that

prohibiting single-use disposable plastic bags and requiring a charge for disposable paper bags and reusable plastic bags at grocers, large retailers, retailers and retail stores would address the environmental and health problems associated with such use, would relieve Town taxpayers of the costs incurred by the Town in conjunction therewith, and would be in the best interest of the public health, safety, and welfare of the Town of Jackson, and

WHEREAS, Ordinance P also provides for a waste reduction fee of Twenty Cents (\$.20) for each disposable paper bag or reusable plastic bag provided to the customer at the point of sale. The fees collected shall be held in a Waste Reduction Fee Account and shall be paid to the Teton County Integrated Solid Waste and Recycling Division for the costs of implementations. ing a Plastic Bag Outreach Plan, and WHEREAS, the Teton County Board of County

Commissioners recognize that plastic bag reduction is a strategy to the Road to Zero Waste Plan; that the Teton County Integrated Solid Waste and Recycling Division is leading an educational and community outreach campaign to assist retailers and shoppers with the transition away from plastic bags, and to build a community ethic for single-use plastics reduction; and

WHEREAS, the Teton County Board of County Commissioners do not have the jurisdictional authority to ban plastic bags in the unincorporated areas of Teton County, but recognize that reducing plastic bags in Teton County is benefi-

cial for many reasons, including:

1. Saves time and money on windblown plastic bag litter at the Teton County Recycling Center, Transfer Station, and Landfill; and

2. Reduces bag litter throughout the community, which can eventually make its way downstream into the river system and/or into digestive systems of wildlife; and

Plastic bags clog storm sewers and drains; and Reduces contamination in recycling streams; and

5. Reduces the consumption of a non-renewable resource. NOW, THEREFORE, having duly met at a regular meeting and considered the matter, the Teton County Board of County Commissioners hereby resolve as follows:

RESOLVED, the Teton County Board of County Commissioners do hereby endorse and support the Town of Jackson's Ordinance P banning the free distribution of singleuse plastic bags; and

FURTHER RESOLVE, that the Teton County Board of County Commissioners encourages grocers, retailers, and retail stores in the unincorporated areas of Teton County to voluntarily stop using single-use plastic bags; and FURTHER RESOLVE, to support the Teton County Integrated Solid Waste and Recycling Division in their outreach efforts to assist the Town of Jackson in their Plastic Bag Outreach Plan.

The Department of Environmental Quality/Water Quality Division (DEQ) has conducted a review of the proposed Buffalo Valley Water District, Water Distribution System Upgrades and Repairs project in accordance with EPA and State of Wyoming procedures for implementing the State Environmental Review Process. DEQ has determined that this project is eligible for a categorical exclusion. Accordingly, DEQ is exempting the project from further substantive environmental review requirements under the State Environmental Review Process. Neither an Environmental Assessment/Finding of No Significant Impact nor an Environmental Impact Statement/Record of Decision will be required for the proposed action. The following is a brief description of the situation and the proposed action and a brief statement of how the action meets the criteria for a categorical

The project will involve replacement of existing deteriorated galvanized piping which have been prone to leak and cause major system disruptions. An SRF loan in the amount of \$134,025.00 along with a Wyoming Mineral Royalty Grant (MRG) of the same amount is anticipated to pay for this work. The loan will be repaid with annual assessments that are currently \$960 for developed lots and \$690 for undeveloped lots.

The Buffalo Valley Water District is aware of and accepts the fact that they will be responsible for any required mitigative actions associated with and including storm water runoff, erosion control, archeological/historic artifacts, and air quality concerns. These will be part of the standard State Revolving Funds Program contract conditions.

DEQ is granting an exclusion because this project will replace existing buried water lines within existing easements. This project will be completely constructed in previously disturbed ground that includes existing water lines, utility lines and roadways. DEQ has determined that exempting the proposed project from further review under the State Environmental Review Process will not result in adverse impacts to the population or this area of the Buffalo Valley Water District or Teton County, Wyoming.
