NOTICE OF INTENT TO ADOPT AN AMENDMENT TO THE TETON COUNTY LAND DEVELOPMENT REGULATIONS (LDRs) RELATED TO EXTERIOR LIGHTING STANDARDS (AMD2025-0002)

Notice is hereby given pursuant to Wyoming Statute §16-3-103 that Wyoming Stargazing, through Samuel Singer, has submitted a request for an amendment to the Teton County Land Development Regulations (LDRs). The proposal is related to Section 5.3.1, Exterior Lighting Standards.

This is an amendment to the Land Development Regulations which is authorized pursuant to Wyoming Statute §18-5-201. The Teton County Planning Department has complied with the requirements of Wyoming Statute §9-5-304 and a copy of the assessment may be obtained from the Teton County Planning Department.

Pursuant to Wyoming Statute §18-5-202(b) the Teton County Planning Commission shall hold a public hearing at which a recommendation will be made on the proposed Teton County LDR amendments to the Teton County Board of County Commissioners. The Teton County Planning Commission public hearing will take place at 6:00 p.m. on February 9, 2026, in the Commissioners Meeting Room of the Teton County Administration Building at 200 S. Willow St. in Jackson, Wyoming.

Pursuant to Wyoming Statute §18-5-202(c) the Teton County Board of County Commissioners shall hold a public hearing to consider the recommendation from the Teton County Planning Commission and adoption of the proposed amendment on March 17, 2026, at 9:00 a.m. in the Commissioners Meeting Room of the Teton County Administration Building at 200 S. Willow St. in Jackson, Wyoming.

The purpose of the meeting is to allow citizens to review and comment on the following project: SCWD Transmission Line Replacement Project necessary to maintain water district supply, prevent leaks, and possible catastrophic system failure.

At the meeting, Squaw Creek Water District will present the preliminary facility plan and budget for the proposed project and will discuss the estimated costs of the improvements, and the plan for funding the improvements. Based on current cost estimates, Squaw Creek Water District plans to borrow up to \$164,475.00 from the Wyoming Drinking Water State Revolving Loan Fund administered by the Wyoming Office of State Lands and Investments. No increase in user fees is anticipated to repay the loan. Loan terms will be an interest rate of 2% for a 30-year term.
