(WITH RELINQUISHMENT OF DOWER & CURTESY)

And we hereby covenant with said **Grantees** that we will forever warrant and defend the title to the said lands against all claims whatsoever.

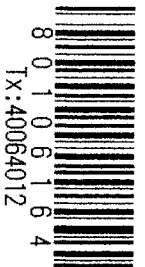
