JIM JUSTICE

What do you see as your greatest challenge when elected?

Once I go to Washington, D.C., as the next U.S. Senator from West Virginia, one of my



For too many years, Congress has ignored the legislative framework for budgeted and passed end-of-fiscal-year continuing resolutions that mostly lock into place funding priorities and decisions from years prior. How important is it to you to lead via your party platform?

My values inform who I am and how I will vote more than my political affiliation. I am a Democrat because historically the Democratic party has aligned with my general values. The party is at its best when advocating for the working class and standing up for the underdogs in our society. What do you see as your greatest challenge when elected?

The greatest challenge that we face is getting our national economy under control. Our national debt is totally out of control due to the immature and self-serving procedures that our national representatives have been following. I will not support any national deficit budget. Inflation is destroying the will and the capability for citizens to have control over their financial futures. National debt and the Federal Reserve and social support franchises are the cause. (Everything that I need to spend money on has increased in the past recent years by 40% to 50% while the national standards indicate single digit percentages. This is caused by the fact that inflation is not computed for the family, the citizen, or the individual but rather for the subsidized national economy.)

The USA is no longer the international peacekeeper. Our influence over intra-national strife is ineffective. We risk our own freedoms in the process of trying to be the "parent" over the international "immature." Conflict is not a solution to any issue; resolution resides in individual and national maturity and the exercise of self-sufficiency rather than international instruction. As a representative of West Virginia in Congress I represent rationality and thoughtfully explicative actions that resolve problems and issues rather than spend national resources, funds or avoidances on personal reputations. I expect to be able to listen and respond as a facilitator of the basic tenants of American citizenry.

How important is it to you to lead via your party platform?

The basic principle of the Libertarian Party in the U.S. is to ensure the right to liberty and the exercise of individual choice so long as it does not detrimentally effect any other citizen or cause or standard. This is akin to the Golden Rule of Christianity, or to the principles of the medical rule "to first do no harm." This principle should guide all of our actions and ever represent our true humanity.

Party platforms are designed to reflect some unified and national policy. The whole reason for statehood and the individual representation of our state is to apply reason and practicality to the needs and advancements of our state. National issues should be reflected accordingly as issues that must be reflected in the advancement of our individual citizens in every respect. We are a nation of individuals united under the common causes upon which we agree as members of a democratic system. All of our representatives must adhere to that vision and practice. As Senator from West Virginia, I expect to be judged on and held accountable to that vision.

How will you communicate to voters regarding what is happening with your role/office and do you believe that communication is important?





What do you see as your greatest challenge when elected?

The statutory authority of the Secretary of State's Office is controlled by

the Legislature. With the Legislature's consent, I want to make it easier for West Virginians to vote by mail, without their first having to submit an excuse to do so. Californian voters have been



able to vote by mail without first submitting an excuse to do so since 1978. I believe that my greatest challenge would be to get the West Virginia Legislature to grant similar rights to West Virginian

How important is it to you to lead via your party platform?

First, please note that the West Virginia Democratic Party is a "Big Tent" party. We Democrats welcome conservatives, moderates and liberals to join, and participate in, our party. Second, please further note that the West Virginia Democratic Party does not dictate my positions as a candidate. I would operate the Secretary of State's Office in a professional, nonpartisan manner. Another thing that I would like to do, with the Legislature's consent, would be to place most of the employees in the Secretary of State's Office under Civil Service. If elected, I pledge never to run for a different office, such as Governor, while I am serving as your Secretary of State.

How will you communicate to voters regarding what is happening with your role/office and do you believe that communication is important?

If elected as your Secretary of State, I would use all appropriate media with respect to what is happening in the Secretary of State's Office. Yes, I DO believe that two-way communication is very important.

I have already worked for 29 years in state government and know how important that it is for public servants to welcome suggestions, comments, and criticisms from the public. Ordinary citizens often have great insights as to how public servants may improve services that a state agency or office provides to members of the public.

KRIS WARNER

We must maintain the highest level of confidence West Virginians have in their

elections. Concerns from the lack of election integrity in other states filter into West Virginia. Examples of concerns include indiscriminate mailing of ballots, such as occurred in Wisconsin, where 2200 duplicate bal-



lots were sent to voters without their asking. Ballots being dropped in unsupervised drop boxes, and the inconsistent curing of ballots in states such as Pennsylvania. States like California are now allowing non-citizens to vote in local elections. None of these occur in West Virginia, but our voters hear about these issues and have concerns about election integrity in general. The Secretary of State's office under my leadership will continue the office's current priorities of educating our citizens about election integrity and working collaboratively with our 55 county clerks and our legislature to keep West Virginia elections safe, secure, honest and fair.

How important is it to you to lead via your party platform?

The WV Republican party has a well thought out and comprehensive platform. However, much of that platform deals with

The position of State Auditor shouldn't be based on a party platform. My role is to ensure transparency, accountability, and accuracy in government finances, and that transcends party lines. and Liberties. Here are a couple examples that I am working on: Open Fields Doctrine, which is a Supreme court opinion from 1924 which severely limited your 4th amendment Rights. Your personal information held by third parties.

We now see that corporations often volunteer to turn over private information to authorities without requiring a warrant or subpoena for said information, thus circumventing the 4th Amendment protections, example cell phone data. Learn more on these issues at charleshorst.com.

How important is it to you to lead via your party platform?

I am a Republican and support the platform in most cases, so I find it important to support the party agenda to continue moving West Virginia forward, but that support is not absolute. If we do not have a common goal to work towards not much would get accomplished.

How will you communicate to voters regarding what is happening with your role/office and do you believe that communication is important?

I often use Facebook to help inform constituents of legislative issue's, and plan to start using townhall events before and after sessions to discuss what issue's are important to the people.







I think the answer to this one is three-fold. Having talked to many people throughout the county it is clear that the primary concerns facing our county government are land use/development, Emergency service



gaps and shortfalls, and a general loss of civility and transparency in the way our government operates. That being said, there are clear steps that can be taken to bring these problems back under control.

Land use and development- The main concern here is the rural zoning which allows nearly unrestricted development of Solar farms over land that was previously agricultural within growth boundaries and the ability to have zoning appeal in non-growth boundar-

ies. This land is a finite resource and the people of Jefferson have made it clear that there is no desire for any more of these industrial scale solar farms to be permitted. I have a few ideas for how we can address this, one being an overhaul of our Rural zoning ordinances to remove solar as an allowed use, and possibly make Solar farms be their own separate zoning, closing the door on farms being turned into industrial scale solar. Actions I have already taken on the planning commission is making a clear direction in our 2045 comprehensive plan that at minimum additional buffers, impervious area (topsoil), vegetative buffers, and agrivoltaics be modified and updated in our zoning ordinance following the adoption of our plan.

Emergency service gaps and shortfalls-Our county has seen rapid population growth, but our EMS and Police services have struggled to keep up from both a personnel and budget standpoint. While they cannot be allocated towards salaries, we can leverage the massive demand for homes in this county with increased impact fees that would greatly assist police and EMS budgets with equipment and other property desperately needed in their budgets. I met with Chief Morgan of Shepherdstown, and he shared a lot of his opinions and explained many of their funding comes from various fundraising efforts showing a financial risk and strain on our first responders.

Civility and transparency- The past couple of years our county government has struggled to collaborate effectively to tackle many of the issues I have mentioned. Having spoken with many of the candidates for commission, I am confident that regardless of who is elected, we will work together and tackle these important issues. As far as transparency, time and time again I hear from county residents that they feel like the Commission is not being clear and transparent in their decision-making process. If I am elected, I will make it a priority to ensure people in the community impacted by Commission decisions have a clear understanding of what is being discussed so they have an opportunity to bring forward their concerns and comments, which will then merit consideration and discussion among the commissioners.

How important is it to you to lead via your party platform?

This is a great question, I believe that both the Republican and Democratic party platforms really are geared towards State and Federal issues, with very little being directly applicable to the types of things that fall under the county Commission's control. For civility and open dialog to really come back to the commission,

I think hot button DC issues must be put aside so we can focus on the very immediate and ultimately nonpartisan needs of the county. However, as a fiscal conservative I do believe that any plans we put forward in the commission should not be funded by additional taxes/levies on current county residents. They should instead by supported by increased impact fees on new developments, as well as meaningful effort put into enticing the kinds of business that will build a solid tax base and be a good complement to our local economy.

How will you communicate to voters regarding what is happening with your role/ office and do you believe that communication is important?

For many years I have been deeply involved in our Jefferson Community through local nonprofits, my church, the Jefferson Chamber of commerce as a business owner, and groups of wonderful volunteers. I think this connection to the community has given me excellent insight into the needs of the county, as well as great relationships with community and municipal leaders. One of the cornerstones of my platform in running for the Commission, is I want to build closer ties between Jefferson municipalities and our county government. There are so many missed opportunities for collaboration and input when town Councils are not fully consulted on Commission decisions which directly impact their communities. I would encourage town halls, forums, and participation in local meetings for increased communication.


