# Officials release information on primary election

MARTINSBURG — With the deadline for voter registration approaching, Berkeley County Clerk Tony Petrucci issued a release to remind voters of key dates and registration deadlines for the May 14 primary election.

These dates reflect the West Virginia Secretary of State (SOS) 2024 Elections Calendar, which will affect all counties.

According to the elections calendar, the voter registration deadline is April 23. This date also serves at the deadline for voters to change their political party affiliation.

"There are multiple ways to register to vote in West Virginia, and our staff at the Berkeley County Voter Registration Office is happy to provide assistance to any resident who may have questions about registering to vote," Petrucci said in the statement.

In the release, Petrucci reminded residents to check to see if their registration is still active if they have not voted in several prior elections.

The SOS website, https://ovr.sos. wv.gov/Register/Landing, can be used to check registration, as well as register to vote online or change party affiliation. To submit a registration form online, residents must enter their driver's license number or an approved identification (ID) card number, along with the last four digits of their Social Security card.

Residents can also register to vote by mail or in person. Downloadable registrations forms are available at the SOS website. Registration forms are also available at the county clerk's office, public libraries, colleges, universities and senior community centers. Those unable to download or pick up a form in person can call the Secretary of State's Office at 304-558-6000, or toll-free at 866-767-8683, to request a mailed registration form.

Once complete, the forms can be delivered to the county clerk's office by mail or in person.

From May 1-11, excluding Sunday, registered voters may participate in early voting in Berkeley, Jefferson and Morgan counties.

In-person votes can be cast at one of three locations in Berkeley County: 400 W. Stephen St., Martinsburg; Bedington Ruritan, 3947 Williamsport Pike, north of Martinsburg; and the South Berkeley Vol-

unteer Fire Company substation, at 4127 Winchester Ave., south of Martinsburg. Voting hours for this 10-day period at each location will be from 8 a.m. to 5 p.m.

Early voting in Jefferson County will be held from 9 a.m. to 5 p.m. at Charles Washington Hall, 100 W. Washington St., second floor, in Charles Town. Voters can access the second floor by using the entrance marked "Suite 201" on North George Street.

In Morgan County, early voting will be held from 9 a.m. to 5 p.m. at the Morgan County Clerk's Office, 77 Fairfax St., Room 102, in Berkeley Springs, excluding Sundays.

Voters who are unable to participate in early voting may vote through absentee ballot. The deadline to apply for an absentee ballot is May 8. This applies to registered voters who are ill, disabled, traveling or studying outside of their home countries or who meet other criteria. Visit the SOS website for more information.

Hand-delivered absentee ballots must be returned to county clerk office by Monday, May 13, for the primary election. If returning them by mail, they must be postmarked and mailed to the county clerk's office by Tuesday, May 14, and received by Monday, May 20, in order to be counted.

Voting at the polls will be held from 6:30 a.m. to 7:30 p.m. on Tuesday, May 14. Votes will be cast using a touch screen to mark each ballot choice, and the voting machine will print a completed ballot for voters to place in a scanner or ballot box. Headphones and a tactile keypad will be available for voters who require an audio ballot

Voters registered with one of the state's four recognized political parties (Democratic, Libertarian, Mountain or Republican) can either vote that party's ballot or the nonpartisan ballot. Voters registered with another party or with no party can choose which recognized party's ballot

they'd like or vote a nonpartisan ballot.

Voters must present an acceptable form of ID, such as a driver's license, U.S. Passport, birth certificate, W.Va. hunting or fishing license or a voter registration card. First-time voters who haven't provided ID when registering to vote must provide a valid ID either at the polls or include a copy with their absentee ballots.

Exemptions are available to residents of state-run long-term care facilities, voters accompanied by an adult who has known them for at least six months and voters who are known by a poll worker for at least six months. Registered voters who cannot get an approved ID can apply for a free voter card at the county clerk's office. Voters with disabilities are allowed to receive certain types of assistance or accommodations when voting either in person or via absentee ballot.




What are the top two pressing issues relevant to the office you seek and how would you address them?



How long have you lived in the area: I have made Ganotown my home for the last 22 years and I have lived in Berkeley County for the last 33 years.

## Relevant experience serving the community:

I have been a Scouts BSA leader for the last 17 years with Pack 37 and Troop 37 from Hedgesville. The last six years, I was the Cub Master of Pack 37. Though I have led and worked on many community service projects, "Scouting for Food" is a big one we do every year in November. Last year, we distributed flyers the first weekend of November and the next weekend we picked up the food and set a new record for our Pack/ Troop; over 2,100lbs of food which we delivered to Loaves and Fishes Food Bank. Our Pack also partners with Hedgesville Elementary School where we clean up the school grounds a couple of times a year and the last 2 years, we have worked on repairing and painting their foot bridge that crosses the wet land area of the school grounds.

# What are the top 2 pressing issue relevant to the office you seek and how would you address them?

Teacher and staff moral is one of my top issues. Educators are underpaid and

overworked. If elected, I plan to work with the union, the Legislature, and the county to get locality pay in West Virginia. Though this process will take time, I feel that deliberate and persistent action is the only thing that will get us there. The current School Board members sent a very nice report to the legislature last fall but it seems it was ignored by the Legislature.

I think looking at the budget transparently would help our school district compete with other counties around us, even before locality pay. For instance, I believe that administration should not make any more than 4 times the lowest paid staff. I would like to explore if Berkeley County could offer to pay a portion of the payments on teacher's student loans as long as they work for the County, or a percentage after a certain number of years of service. Most large businesses offer tuition reimbursement for employees.

Another issue is student behavior, there have been grade school teachers taken to the hospital from being assaulted by first graders and then the same student is back in the classroom the next day. The other extreme is kids being suspended for minor infractions. A lot of this goes back to the Safe Schools act and I believe it needs modified. Administrators need the leeway to administer the correct punishment for the infraction and violent students need to be removed from the school immediately.

## What separates you from the other candidates?

While I myself have never been a teacher, I come from a family of teachers, my mother is a retired teacher and my fa-



# Berkeley County Schools submits levy election order

MARTINSBURG — Berkeley County Schools recently submitted a levy election order for the May 14 primary election for the continuation of an additional school levy for general expenses for the public schools.

The main purpose of the levy is to provide additional funds needed for the schools. Like in 2019, the school levy will include a five-year plan, with an increase to \$46 million annually for \$230 million.

The school levy for 2024 proposes additional funds, including \$31,612,000 for local salary supplements and benefits

for all personnel; \$3,500,000 to provide instructional materials, textbooks and other instructional equipment; \$408,000 to provide financial support to several community organizations; \$6,500,000 to provide additional staff and equipment where necessary to address increased enrollment; and \$3,980,000 to provide upkeep and maintenance of facilities.

"Continuing the BCS School Excess Levy allows us to continue to provide support to all of our staff, students and the community through salary supplements, benefits, textbooks, technology, safety and security measures, facility maintenance and more," BCS Executive Director of Communications Karla Troppman said. "Additionally, the School Excess Levy allows us to continue support for community partners."

The last levy was adopted during the election on Nov. 16, 2019. The proposed funds included \$18,678,500 to provide local salary supplement and benefits to all personnel; \$3,500,000 to provide instructional materials, textbooks and other instructional equipment; \$321,500 to provide financial support to several community organizations; \$5,900,000 to provide additional staff and equipment where necessary to address increased enrollment; and \$3,200,000 to provide for the upkeep and maintenance of facilities.

For the 2024 levy, there is a jump of \$12,933,500 in funding for salary sup-

plements and benefits for all personnel. There are smaller increases in other areas. as well, including more funds to support the Berkeley County Health Department (\$30,000), Martinsburg-Berkeley County Parks and Recreation board (\$132,500), the West Virginia University Berkeley County 4-H Extension Office (\$93,000) and the Martinsburg-Berkeley County Public Library (\$152,500).

During previous meetings, members of the board of education shared their wish to do more for these organizations, as they do a lot to support students and the community.

Berkeley County residents will vote on the school levy during the primary election on May 14.



Google Reviews for the Magistrate Court and Clerk's office in Jefferson County is a whopping 1.8 stars. That's not what serving the people of this community should look like. I understand that most folks coming to the magistrates' office are often dealing with difficult life situations, which can set the tone for their impressions. However, I have read a number of these reviews and we can do better. The services of the Magistrates and Magistrate Clerk's Office must be competent, courteous, and accessible. An office that is only open Monday through Friday, from 7:30 am to 4:30 pm, shouldn't be closed during lunchtime. When are the working people of Jefferson County supposed to be able to handle their business? I think this says something about the present mindset on public service. Do

we want to elect more of the same?

## What separates you from the other candidates?

Over the course of my career, I've seen many people assume they know how to do a job that isn't theirs. Watching decisions being made by others is not the same as making those decisions yourself. When the reality sets in that you are now the one responsible for these decisions, impacting other people's futures and families, people you probably don't even know... When that kind of responsibility settles squarely on your shoulders for the first time... it is a sobering moment. At least it should be. It just hits different. Decision makers and leaders know what I'm talking about. You are now responsible for these decisions. The weight of that authority rests in your hands. Things look much differently from that perspective.

I have spent most of my lifetime in public service; three decades of that in metropolitan-area law enforcement. From patrol officer to commander, I held many different ranks, roles, and responsibilities. Split-second, life-changing decisions were commonplace for me. 



The officer to citizen ratio in Berkeley County is well below the national suggested ratio. Our manpower shortage prohibits our agency from performing the necessary extra patrols in the remote, less accessed areas of the county, such as Back Creek Valley. The shortage further impairs our department from adding additional deputies to the Eastern Panhandle Drug and Violent Crimes Task Force or staffing a full time presence on Interstate 81. Efforts are currently underway to hire the 2 to 3 deputies remaining in the latest hiring process. I recently sought and gained approval from the Berkeley County Commission to offer certified police officers a \$10,000.00 sign on bonus for the next hiring cycle. I am currently working with our command staff and office manager to update and improve our recruiting efforts in the future with new advertising, creative ways to reach potential candidates, exploring relevant job fair locations, looking into creating an updated recruitment video to use in our social media platforms and/or possible television, and any other innovative approach to attract quality individuals to the Berkeley County Sheriff's Office. Our command staff and county officials continue to work on a new model/ restructuring of our department's rank and command staff, in order to better facilitate and manage the necessary and unavoidable manpower increases that will be required to adequately serve our county residents.

This new structure will take into account the staffing requirements for the most recently planned Spring Mills Emergency Services sub station and also a future planned South Berkeley substation. Planning ahead for the future growth and establishing a sound foundation to adequately manage and administrate the Sheriff's Department is key to the future success of the agency. Also, I will always advocate for better pay and benefits for our current dedicated civilian and uniformed members.

School Safety Measures to protect our most precious resource, our children. Currently, the Berkeley County Sheriff's Department has 3 School Resource Officers (SRO) assigned to Hedgesville, Spring Mills, and Musselman High Schools. These SRO's also divide all the remaining county middle schools and elementary schools as their secondary responsibilities. This inevitably leaves our schools inadequately protected and is no where close to being where schools need to be in regards to protecting the students. I will continue to meet, work with, and strategize with our command staff, school personnel, state/federal/ county officials and our citizens of Berkeley County to eventually implement a sound plan to fully staff each school with their own SRO and/or a SSO (School Safety Officer). The Berkeley County School Board has recently hired several SSO's to begin to staff some of the unmanned schools. I will draft and submit legislation relevant to this matter in order to clearly cover the needs of such an important safety/education related program. There is no greater responsibility than to ensure the safety and security of our

children.

#### What are the top two pressing issues relevant to the office you seek and how would you address them?

The increasing caseload due to the growth of our community and, the need for people to feel heard and that they have had an opportunity to make their case. My being elected will address the first issue of an increasing caseload. Berkeley and Jefferson counties need a family court judge who can handle a heavy caseload. My trial court and judicial experience has prepared me to conduct the hearings efficiently and keep the cases moving towards resolution. With regards to the second issue, the need for people to feel heard and that they had an opportunity to make their case, this goes to judicial temperament. I think looking at the budget transparently would help our school district compete with other counties around us, even before locality pay. For instance, I believe that administration should not make any more than 4 times the lowest paid staff. I would like to explore if Berkeley County could offer to pay a portion of the payments on teacher's student loans as long as they work for the County, or a percentage after a certain number of years of service. Most large businesses offer tuition reimbursement for employees.

Another issue is student behavior, there have been grade school teachers taken to the hospital from being assaulted by first graders and then the same student is back in the classroom the next day. The other extreme is kids being suspended for minor infractions. A lot of this goes back to the Safe Schools act and I believe it needs modified. Administrators need the leeway to administer the correct punishment for the infraction and violent students need to be removed from the school immediately.

### What separates you from the other candi-

While I myself have never been a teacher, I come from a family of teachers, my mother is a retired teacher and my father was principal and 5/6 grade teacher at my elementary school. My aunts all were teachers, my grandfather was even a teacher at a one room school house before he went to World War II, and lastly my wife is a first grade aide at Hedgesville Elementary. So, I am very familiar with the school system and how it works. I also have a Business Administration degree and have run my own restaurants over the years, so I know how to be fiscally responsible.

#### What separates you from the other candidate?
