Dear Ms. Rollenhagen,

In accordance with the statutory provisions of sections 1819(h) and/or 1919(h) of the Social Security Act and the regulations at 42 CFR 488.430, a Civil Money Penalty (CMP) was imposed on Pine Ridge Health and Rehabilitation Center for not meeting the Medicare and/or Medicaid requirements for participation.

The total amount of the CMP is **\$194,760.00**. This total represents the imposition of a Federal Civil Money Penalty of \$1,365.00.00 per day for fifty-five (55) days beginning November 22, 2021 and continuing through January 15, 2022, a Federal Civil Money Penalty of \$16,845.00 per day for two (2) days beginning January 16, 2022 and continuing through January 17, 2022, and a Federal Civil Money Penalty of \$1,365.00.00 per day for sixty-three (63) days beginning January 18, 2022 and continuing through March 21, 2022. **We received your letter dated April 19, 2022 waiving your right to an appeal, and as a result, the CMPs have been reduced by 35%.**

**The amount due on May 18, 2022 is \$126,594.00.**

If payment is not received by the due date, we will ask the Medicare Administrative Contractor and/or the State Medicaid Agency to deduct the CMP and any accrued interest from sums owed to you, with no further notification from this office. Interest is assessed in accordance with the regulations at 42 CFR 488.442, on the unpaid balance of the penalty beginning on the due date. The current rate of interest for Medicare is **9.375%**.

**Please DO NOT send the payment to the Atlanta Regional Office.**

**We no longer accept payments by paper checks.** To pay this penalty, you may select **ONE** of the following two options: (1) ACH Transfer of Funds; or (2) Electronic Wire Transfer of Funds.

To assure proper crediting of your payment, please be sure to include the CMP case number **2022-04-LTC-387** shown above on your correspondence, as well as your **Tax Identification Number**.
