16 COUNT 1 ATTEMPTED MURDER IN THE SECOND DEGREE

The defendant, on or about December 5, 2023, in Jackson County, Oregon, did unlawfully and intentionally attempt to cause the death of Jesse Draper, another human being.

18 COUNT 2 ASSAULT IN THE FIRST DEGREE

The defendant, on or about December 5, 2023, in Jackson County, Oregon, did unlawfully and intentionally cause serious physical injury to Jesse Draper by means of a firearm, a dangerous or deadly weapon.

20 COUNT 3 UNLAWFUL USE OF A WEAPON

The defendant, on or about December 5, 2023, in Jackson County, Oregon, did unlawfully attempt to use, carry or possess with intent to use unlawfully against Jesse Draper, a firearm, a dangerous or deadly weapon.

23 The state further alleges that defendant used or threatened the use of a firearm in the


