The undersigned, a law enforcement officer, competent to testify, states as follows: That he/she believes a crime was committed by the above named defendant in the City and/or County of Spokane, State of Washington, because:

On 08/07/22 at approximately 1540 hours multiple Spokane Police Officers and I were dispatched to the area of 2224 E South Riverton for a person with a weapon call. The 911 caller, later identified as Michael Williams (05/06/81), reported seeing a female pointing a firearm at a male. This female was later identified as Sydney J Baker (03/11/99) and the male was identified as Oshay Sharp. Williams reported Sydney Baker was chasing Sharp westbound on E South Riverton with the firearm and a short time later he reported hearing two gun shots. Williams reported Sydney Baker and Sharp were arguing about money just prior to hearing the gun shots. Williams reported Sydney Baker then returned to the apartment complex, located at 2224 E South Riverton and entered either apartment # 103 or #105.

When I arrived on scene, multiple other Officers were already on scene and were containing the apartment complex. I called Williams on the phone and he confirmed he had called 911 just a few minutes earlier. I asked Williams to tell me what happened and he told me the following:

He was inside of his apartment, located at 2224 E South Riverton #306, when he heard a male (Oshay Sharp) and female (Sydney Baker) arguing outside. Sharp and Baker were arguing about a phone and money. He believed Baker was trying to get her cell phone back from Sharp. Sharp walked away from the area and Baker followed Sharp. He then saw Baker pull out a black pistol and point it at Sharp, demanding he return her phone to her. Baker and Sharp both walked

away from the apartment complex westbound on E South Riverton. Just a short time later he heard two gun shots from the area where direction where Baker and Sharp had walked. A few minutes later he saw Baker return to the apartment complex and he was on his back deck. Baker looked at him, pointed the handgun at him and told him something similar to, "Mind your own fucking business". He felt very threatened by Bakers statement and by the fact she pointed a gun at him, believing she may actually carry out the threat and shoot him. Baker then walked back into apartment #103. Several minutes later he saw Baker and another black male exit apartment #103 again. He saw Baker hand a handgun to the male, who wrapped the handgun in a towel or a blanket. The male walked to the garbage dumpster on the south east corner of the common area of the apartment complex and he threw the wrapped blanket into the dumpster. The male then walked back into apartment #103. A few minutes later, the same male again returned to the dumpster and retrieved something from it. He was unable to tell what exactly the male removed from the dumpster, but the male then walked back inside apartment #103.

I ended my phone call with Williams when I was approached by Jayla Sharp (03/18/96), who told me she was Oshay Sharp's cousin. I asked Jayla Sharp to tell me what she knew and she told me the following:

About 5-10 minutes ago she received a panicked phone call from Oshay Sharp, in which he told her that Sydney Baker had shot at him with a gun. Oshay Sharp told her he was running away from the area on foot. She did not know Oshay Sharp's current whereabouts. Oshay Sharp and Sydney Baker have a one and a half year old daughter in common.

Spokane Police Officers loud hailed Sydney Baker's apartment (#103) and she emerged from the apartment unarmed. Another person, identified as Marcus Deadman, also emerged from apartment #103 unarmed. Officers entered apartment #103 to check the welfare of Sydney Baker's young daughter and found her unharmed inside the apartment.

Officer Baughn told me he spoke with Sydney Baker after she was detained. Officer Baughn told me Sydney Baker stated she was arguing with Oshay Sharp because he had taken her cell phone from her and he was walking away with it. Officer Baughn told me Sydney Baker stated she retrieved a black Glock handgun from her vehicle (2005 Honda Accord WA plate BVW7930), a gun she had just acquired earlier in the day for protection. Officer Baughn told me Sydney Baker stated she followed Oshay Sharp on foot westbound on E South Riverton, demanding he give her back her phone.

CONTINUATION OF AFFIDAVIT OF FACTS:

Officer Baughn told me Sydney Baker told him Oshay Sharp slapped her across her face and she believed he was going to assault her further. Officer Baughn told me Sydney Baker stated she then fired one round into the air from her handgun. Officer Baughn told me Sydney Baker stated she then returned to her apartment (#103) and she placed the handgun into the bottom drawer of a filing cabinet in the living room of her apartment.

I applied for and was subsequently granted a search warrant to search Sydney Baker's apartment for firearms and firearms related items. I entered the apartment and opened the bottom drawer of a black filing cabinet in the living room of the apartment. As I opened the drawer I immediately saw a black handgun inside. Upon further inspection, the firearm was identified as a Glock 43X handgun. The handgun had a loaded round in the chamber and additional rounds in the attached magazine. The scene was photographed by Corporal Guzzo, who also later placed the handgun into property as evidence. I left a copy of the search warrant inside of Sydney Baker's apartment.
