17 JENNIFER S. CLARK, Deputy County Attorney, deposes and says that on or about
18 the 7th day of November, 2019, in Missoula County, the Defendant committed the
19 offenses of COUNT I: ARSON, a Felony, in violation of Montana law, namely: Mont. Code
20 Ann. 45-6-103, punishable by 20 years MSP and/or \$50,000 fine; COUNT II:
21 POSSESSION OF A DESTRUCTIVE DEVICE, a Felony, in violation of Montana law,
22 namely: Mont. Code Ann. 45-8-334(2), punishable by 10 years MSP and/or \$50,000 fine.

23 The facts constituting the offense are:

25 COUNT I: On or about the 7th day of November, 2019, the above-named
26 Defendant committed the offense of arson when, by means of fire or explosives, he
27 knowingly or purposely damaged or destroyed an ATM that exceeded \$1,500 in value
28 belonging to First Security Bank without consent.

2 COUNT II: On or about the 7th day of November, 2019, the above-named
3 Defendant, with the purpose to commit a felony, had in his possession a destructive
4 device, a pipe bomb, on a public street.

**AFFIDAVIT OF PROBABLE
CAUSE**

JENNIFER S. CLARK, Deputy County Attorney, Montana, being first duly sworn
upon oath, deposes and says:

I have read the official law enforcement reports regarding the investigation of GUY
MURRAY CULLIGAN for allegedly committing the offenses of COUNT I: ARSON, a
Felony, in violation of Montana law, namely: Mont. Code Ann. 45-6-103; COUNT II:
POSSESSION OF A DESTRUCTIVE DEVICE, a Felony, in violation of Montana law,
namely: Mont. Code Ann. 45-8-334(2).

1 Based upon the following facts which have been obtained from reports of the law
2 enforcement officer which, if true, constitute sufficient probable cause to justify the filing of
3 the charges. The facts from those reports are as follows:
4

5 On November 7, 2019, around 10:45 a.m., police and fire personnel responded to
6 an explosion heard in the area of Broadway and Madison. A caller to 911 reported
7 hearing an explosion, seeing flames and seeing an older male pour gasoline on a First
8 Security Bank ATM shortly before the explosion. The caller saw the male throw lighted
9 material toward the ATM and then it exploded. The caller stated the explosion blew out
10 the windows in the vehicle that the male had arrived in. He left the scene in a grey
11 minivan with a disabled person parking permit and temporary tags.
12

13 Police located the van near the courthouse on Pine Street. There was damage to
14 the driver's side and the windows were broken out. The driver was identified as Guy
15 Culligan. Officers noted that Culligan's facial hair was singed. They saw an ATM keypad
16 in the van. A cylindrical object was seen on the floorboard of the van and appeared to be
17 a pipe bomb. An x-ray of the item showed .22 caliber bullets and other items sealed
18 inside. The value of the ATM is estimated around \$30,000.00.

20 Culligan stated that the ATM seized another person's bank card that he was trying
21 to use to obtain money. He admitted to purchasing \$1.00 worth of gasoline and driving to
22 the bank with the purpose of lighting the ATM on fire. He admitted pouring the gasoline on
23 the ATM and throwing a lit object to ignite it. He admitted the cylindrical object was a pipe

1 bomb that had been built by another person years earlier. He placed it in his van with the
2 intent of possibly using it to cause an explosion inside the ATM.
