The undersigned, a law enforcement officer, competent to testify, states as follows: That he/she believes a crime was committed by the above named defendant in the City and/or County of Spokane, State of Washington, because:

On October 12th, 2025 at just before 1am, SPD responded to the area of 600 South McClellan in Spokane WA on a report of a shooting. Officers would arrive to locate a deceased male inside a vehicle. Initial information indicated an unknown suspect walked up to the car and began firing at the victim, seated inside.

**Officer Addicks can testify to the following:**

On 10/12/25 at 0110 hours I was working uniformed patrol for the Spokane Police Department when I responded to the 'Hampton Inn', located at 675 S McClellan in Spokane WA, to assist other officers on a shooting call.

At approximately 0300 hours I was contacted by a male and female in front of the entrance to the 'Hampton Inn'. The male and female identified themselves as Aaron Gould and Jackie McArthur. Gould inquired about what happened in front of the hotel and then told me that he and McArthur may have witnessed the incident.

**Witness Aaron P Gould can testify to the following:**

He and McArthur were driving westbound on W 6th Ave and made a left turn onto S McClellan to go to the 'Hampton Inn'. He did not remember what time exactly it was. As he made the turn onto S McClellan, he heard three to four gunshots. He continued driving southbound on S McClellan and he saw a male standing next to a vehicle, directly to the south of the hotel driveway entrance. He also noticed that there was a large amount of broken glass next to the vehicle. He was unable to look inside the vehicle because the windshield was covered by a sun visor. The male, who was standing next to the vehicle, then walked away diagonally westbound across S McClellan. He was unable to see where the male walked and described it as "he walked into the darkness".

He described the male he saw walking away as a white male, about 5'9" tall and weighing about 150-160 pounds. According to him, the male was not large in stature. The male was wearing a black hoodie with some sort of white print on it. The male had the hood pulled up over his head and was wearing a half mask over his face.

**Witness Jackie McArthur can testify to the following:**

Her account of the incident was the same as Gould's, however her description of the male who walked away differed. McArthur also said that the male was smaller in stature, about 5'9" tall and weighing about 150 pounds. She also remembered that the male was wearing a black hooded sweatshirt with white print on it. She believed the male she saw had black, longer curly hair. McArthur furthermore believed that the male was not a white male but rather had "brown" skin. McArthur did not believe the male was a black male, but rather possibly a mixed-race male.

**Witness Mayger D. Jones can testify to the following:**

He has known Jon A Higgs (AKA Stacks) for over a year.

On 10/11/25 he and a girl named Sammi (Samantha R. Thaxton), and Jon were at Sammi's apartment located at 627 S Bernard St #9, Spokane WA.

He is aware Higgs carries a small, black .380 handgun with weird bullets that were different than

While in Jon's apartment he heard honking outside.

He heard Jon state something to the effect of, if he keeps that up, I'm going to pop him.

He is aware Jon and victim, Derick Shafer have been fighting over Sammi.

He is aware Jon has received videos from Derick having sexual intercourse with Sammi which made Jon angry.

On the evening of 10/11/25 Jon, Sammi, and him went to the 7-11. They later left and went to the area of Lewis and Clark Highschool. After some time, Jon and Sammi left him there.

He had last seen Jon wearing all black with a black face covering.

The next day he heard about a shooting and that the victim was Derick and he believed that Jon may have been responsible.

**Detective Dotson can testify to the following:**

On 10/16/2025 I went to the Ridpath Club Apartments at 515 W Sprague Ave in Spokane, Washington to check for video related to the shooting call from 10/12/2025 at about 0048 hours.

I had seen video of the shooting incident that showed the suspect wearing a dark Addidas hooded sweatshirt, dark pants, dark shoes, a dark backpack with a large Nike Swoosh. Another video of the suspect from the same location showed him carrying a blue umbrella prior to the shooting. The Addidas sweatshirt had a large "Trefoil" logo on the front and there appeared to be a white t-shirt tail hanging out the back of the sweatshirt.

Detective Eckersley had told me that Samantha Thexton, the decedent's ex-girlfriend, had reportedly been at the Ridpath Apartments prior to the shooting. I brought along a photograph of Thexton, as well as photos of Jon Higgs, Andre Moore (AKA "Mac") and Mayger Jones. The photographs were about 6"x7" headshots. It was my understanding that all of those individuals had potential involvement in the shooting investigation.

CONTINUATION OF AFFIDAVIT OF FACTS:

I contacted the on-site apartment manager, Willow Gold, in the office of the Ridpath, and she gave me access to the camera system. I scrubbed through several hours of video of the front entrance of The Ridpath on Sprague Ave. I saw a male in dark pants and a dark hooded Addidas sweatshirt with a Trefoil logo on the front, consistent with the clothing of the shooting suspect. The timestamp on the video at that time was 0004 hours on 10/12/2025. The male in the Addidas sweatshirt was talking with another male in front of the entrance of the apartment. I continued to watch video until the male turned around. I then saw the white T-shirt hanging out the back of the sweatshirt and the Nike Swoosh backpack. Based on the clothing match, proximity to the Hampton Inn and the timeframe, the male in the video seemed to be the same person from the video of the shooting, especially considering it was the middle of the night.

Due to my lack of familiarity with the camera system, I asked Gold for assistance going through the video to try and get a better look at the subject's face. As she went through several camera angles, she told me it appeared the male in the Addidas sweatshirt had a tattoo under his right eye. Gold recognized the male talking with the subject as Ridpath resident Sean Iraiqtat. I took some pictures of the screen and sent them to Detective Eckersley.

Detective Widhalm with the TARU unit responded to the Ridpath to retrieve the video of the shooting suspect. I was not able to review all of the video depicting the suspect at that time. Detective Widhalm noticed the male was also carrying a collapsed blue umbrella.

Detective Erdman Joined me on scene and we contacted Sean Iraiqtat and Dawn Phillips in room 615 at the Ridpath. I identified myself as a police detective, told him we had seen video at the apartment of him speaking with someone involved in our investigation. I showed him a screen shot of him talking to the male in the Addidas sweatshirt. He said that male went by the name "Mac", but he thought his real name was "Matt" or "Matthew". He did not know his last name. He said he had recently given Mac a bass guitar and an amp and was teaching him how to play. He told us Mac had a girlfriend named something similar to "Arianna" who had recently had a baby and had been staying at the Catalyst Project. He said Mac seemed out of sorts on the night he spoke to him in front of the apartment, and he assumed it was stress related to the new baby.

Phillips was also familiar with Mac and his girlfriend who had both been over to their apartment.

Detective Erdman asked if there was anything else about his appearance that would help identify Mac and Phillips told us that Mac had a facial tattoo.

I showed Phillips and Iraiqtat the photo I had brought of Andre Moore. They both immediately confirmed that Moore was the person they knew as Mac. Iraiqtat confirmed Moore was the person in the photo wearing the Addidas sweatshirt in the surveillance video photo.

**Detective Cedeno can testify to the following:**

On 10-15-2025 I was present for much of the recorded interview of Samantha Thexton at the Gardner detective's office. During portions of the interview, Det. Eckersley stepped out, and I spoke with Thexton alone. During those times, the following substantive information was learned (see full AXON recording and Det. Eckersley's report for complete details):

She described 'Mac' as being possibly around 6'02", skinny – about 150lbs, darker skin tone, unknown nationality, about 21 or 22 years old, puffy curly brown hair with the back and sides of his head shaved. She stated that 'Mac' has a tattoo on his face, underneath what she believed to be his right eye. The tattoo was of normal (dark) color and "medium" in size, but she did not recall what it was of.

For ease of the reader 'Mac' is the defendant with the legal name of Andre D Moore (DOB 01/08/93).

She and Jon know Mac "from the streets" and she knows that Jon and Mac are both drug dealers. Jon and Mac both deal fentanyl. When she and Jon go to the Ridpath (downtown Spokane), they just hang out in the front where Jon deals drugs.

She clarified on the evening (prior to the shooting), Mac had come to her residence and taken a shower. After the shooting, when Mac returned hours later, she was asleep, but recalled that Mac took another shower at that time and appeared "quiet". She recalled Mac telling Jon that he was tired and hungry. When Mac came back after the shooting, he was wearing the "same outfit".

After the second shower, she believes he put on different clothes, but she felt that it was "blurry" and she could not recall completely.

She then described "Popeye", who was present at her apartment when they heard the gunshots. Shortly after hearing the gunshots, Popeye left on foot, then about a half an hour later, she and Jon left her apartment. She described Popeye as about 50 years old, "Mexican, bigger, tall and wide" and has no scars, marks or tattoo's that she's aware of. She doesn't really know Popeye well but has seen him out in passing for the last year or two. She believes Jon gave Popeye directions to her apartment.

Thexton was then presented with a photo montage by Det. Curtis, during which time Det. Eckersley and I stepped out of the interview room.

Shortly after re-entering, Det. Eckersley left the room. I asked Thexton if she had ever heard anyone call 'Mac' by another name, which she said she had not. When Mac later returned after the gun shots, she did not talk to Mac about the gun shots, but Jon did. She knew that Jon told Mac that she and Jon heard on the police scanner that Derick had died. Jon then told Mac to leave, which Mac did.

I asked if Mac said he was involved, to which Thexton stated "I know he was involved" (1:09 timestamp). When I asked how she knew Mac was involved, Thexton stated, "Because he told Jon, that he was the one that shot him because Derick was trying to get inside my house with a crowbar, in the back door. And he told him a couple of times to leave, and I guess Derick supposedly mouthed off to him and was smirking at him, and he got pissed off." She did not know what Mac did with the gun, and she did not directly hear Mac say these things, she learned that Mac had stated it to Jon, who told her "pretty much right away" after Mac left her apartment. She did not recall Mac leaving anything at her apartment when he came back after the shooting and Mac didn't tell her where he went after the shooting. She had been sleeping on and off when Mac had come back after the shooting, where Mac had brought groceries over and she recalled Jon telling Mac to leave and that Mac was an idiot.

After this incident, she and Jon saw Mac while they were walking in the Browne St. viaduct "just the other night", where she asked Jon "How he could be so calm after doing something horrible

like that? And Jon said 'he's done it before'. She denied that she or Jon asked Mac to kill Derick.

When she saw Mac in the viaduct, she thought he was wearing the same clothing as the night of the shooting.

When Mac left their apartment before the shooting, Jon provided Mac with her blue umbrella, but she did not know where Mac was going to go or what he was going to do. She recalled that Derick had still been honking his car horn outside her apartment at that time (how he gets a hold of her), and that Derick had been "doing that for days."

She recalled that Jon was in the kitchen at the time that Mac told him he had shot Derick. She could only hear whispering but could not hear their conversation. After the shooting, she did not see Mac with a gun when he was back at her apartment.

She knows Mac's 'baby mama' to be named "Arienna" or something similar, and she is friends with her on Facebook. I then left the room and retrieved my dept. issued laptop. I then utilized Facebook, where Thexton identified her own profile as being under "**Sammie Rebecca**" (<https://www.facebook.com/profile.php?id=61577122213630>). We then searched through her friends list and located a profile for **Ayana Marie Fletcher** (<https://www.facebook.com/MissAyanaMarie>), believed to be Mac's 'baby mama'. Within Ayana's profile, she showed to be "in relationship" with a user by the name of Mac Dre, with a profile picture linked. I opened the photograph, which depicted a male with a tattoo under his eye, which Thexton positively identified as being "Mac", confirming that she was confident it was him. She believed he still had the lower chin beard and mustache and looked similar in likeness today as in his Nov. 18th, 2023 profile picture. I clicked the profile link to **Mac Dre** (<https://www.facebook.com/profile.php?id=61553917491820>), where I observed there to be just the one profile picture in the photos section. She was unaware if Ayana or Mac had any other social media accounts.

**Witness Samantha R Thexton can testify to the following:**

On 10/15/25 she was in the area of W Pacific Ave and S State St in Spokane WA and was contacted by Detective Eckersley.

She was asked if she would talk to him about Derick's death which she agreed to travel with him in his detective's vehicle voluntarily to the investigations building.

She freely and voluntarily provided information regarding her ex-boyfriend Derick J Shafer's death to Detective Eckersley and Detective Cedeno.

**Detective D. Eckersley your affiant can testify to the following:**

He is a Spokane Police Department Major Crimes Detective and was acting in that capacity on 10/12/25.

At approximately 0130 he received a phone call from the On-Call Major Crimes Supervisor Sgt Bode. He was advised there was a shooting death that occurred next to the Hampton Inn located at 675 S McClellan St in Spokane WA.

He arrived at the scene and observed a deceased male later identified as Derick J Shafer (DOB 09/22/87).

Derick was on the ground mostly nude due to first responders attempting first aid. He observed what appeared to be gunshot wounds on Dericks body.

He observed several spent shell casings on the ground near the vehicle.

He observed video surveillance of the incident captured from the security cameras located at Hampton Inn.

He observed in the video Derick arriving at approximately 0045 hours from an alley to the west of Hampton Inn in his silver, 2011 Hyundai Sonata WA-CUE8074 and park facing North on the East side of S McCellan St.

At approximately 0048 hours a person dressed all in dark clothing with an Addidas hoodie with the hood up, walking out of the same alley where Derick had driven out of.

The person walks S/B on the West sidewalk of S McClellan St.

The person continues to walk S/B until they stop under a streetlight directly to the West of Derick's vehicle. The person then looks to South, then East towards Dercks vehicle. The person turns South and begins walking South/East. The person walks out of camera view for a few seconds then back into view but now N/B just a few feet away from Dericks's vehicle. As he the person approaches, they produce a handgun from the right side of their person. The person then fires multiple shots into Derick's vehicle at time stamp 10/12/2025 Sun 00:49:15. The person then slowly walks N/W back toward the alley. They only begin to walk briskly when another vehicle is seen traveling S/B on S McClellan St.

He observed video collected from 201 W 6th Ave which supported the video both in time stamps and the suspect traveling to and from the scene through an alley.

On 10/15/25 your affiant conducted a voluntary interview with Samantha R Thexton (DOB 12/12/94) (AKA Sammi). Samantha was advised the room was being audio and visually recorded. She was also advised she could leave the interview room at any time.

During your affiant's interview with Sammi she informed me of the following in summary:

She has known Derick Shafer for about 5 years and had dated him in the past.

Your affiant asked her what she was here to talk about.

On the evening of 10/11/25 her current boyfriend Jon A Higgs, a male only known to her as Mac (later identified by her through Facebook page as Andre D Moore 01/08/93), and her were in the downtown area walking back to her apartment located at 627 S Bernard St #9 in Spokane WA.

She described defendant Moore as a tall, curly poofy haired male, with tattoos on his face clothes as being a grey pull over hooded sweatshirt with a large bright graffiti, in a graphic design either in the shape of Addidas or Nike logo, dark pants and had a backpack.

While walking they stopped briefly near Lewis and Clark Highschool. They informed defendant Moore of where her apartment was and to go ahead of them.

CONTINUATION OF AFFIDAVIT OF FACTS:

They all arrived at her apartment at an unknown time where all three of them hung out inside for a while.

She believed that about three hours before the gunshots (shooting occurred at 0048 hours) Derick came to her apartment in his vehicle. He was honking his horn trying to get her attention, so she went downstairs. She said Derick just needed some drugs, so she gave him some. She told him he needed to stop honking his horn. She went back to apartment where she later heard more honking. She did not know where Derick went after she left him outside.

At about 2200 hours Defendant Moore was preparing to leave the apartment. She observed as Jon offered Defendant Moore a blue umbrella because it was raining outside.

She initially stated that it was just her and Jon were the only ones left in the apartment when they heard multiple gunshots a few hours later however, she later added there was a male by the name of Popeye there as well.

They waited for a little while then heard on police scanner app that the person shot just a block away was Derick Shafer. They panicked and fled from the apartment in fear the police would think they had something to do with it.

During the investigation I interviewed a Mayger D Jones. He stated he was at Sammi's apartment with Jon and Sammi the night before 10/11/25 and that he had seen Jon with a handgun that had odd ammunition. Sammi denied this during her interview and further stated he had not been at her apartment for a few days. I have included his statements in this document as his observations of the ammunition are important as it appears to match that of what unique projectiles were removed from Derick's body during autopsy.

According to Spokane County Jail booking photo and data recorded, Defendant Moore is listed as 6'01" tall, 143 pounds, Black hair, brown eyes.

At 22:05:29 a silver car believed to be Derick Shafer is seen traveling from West to East in the alley. The vehicle turns S/B onto S McClellan St then into a parking lot. This is also captured on Hampton Inn video.

At 22:08:23 a person is seen walking S/B on the east sidewalk of S McClellan St. They are carrying a deployed umbrella. The person then enters the lot belonging to 201 W 6th Ave. It appears they are wearing a backpack which is partially obscured by the umbrella.

The person stays in the parking lot until 22:09:50 where they linger on the sidewalk. They slowly begin to walk S/B on the sidewalk. Then back N/B, then West down the alley.

As I was aware this area was also partially covered by the cameras at Hampton Inn, I tasked Detective Nyugen with reviewing that data. She later informed me there was a person with a blue umbrella at that same time wearing the same clothing as the person who later returned to shoot and kill Derick.

I reviewed this video myself.

The camera points NW and covers S McClellan St and a portion of the parking lot to the West. The video is in color.
