## To the Employment Security Department:

Verizon is consolidating and restructuring its operations to maximize the utilization of company facilities and resources. As part of this consolidation, certain of Verizon's operating unit(s) will be conducting layoffs in specific business functions across the state of Washington. Accordingly, this letter is being issued in accordance with any possible obligation under the Washington Securing Timely Notification and Benefits for Laid-Off Employees Act ("WARN") to notify you that Verizon is separating approximately 165 employees at facilities within the state of Washington at the below-listed addresses (collectively, the "Facilities"), with employee separations expected to commence effective January 23, 2026:

Employee separations resulting from this action are expected to be permanent. The affected employees are not represented by a union or any other collective bargaining representative. Verizon does not allow separated employees to displace any other employee based on seniority or any other factor (i.e., no "bumping rights" exist). Employees affected by this

consolidation activity will have the opportunity to secure alternative employment with Verizon, provided they meet eligibility requirements. This action is not the result of, nor reasonably expected to result in, any overall relocation or contracting out of Verizon's Washington operations/employee positions.

A list of the job titles held by the above-referenced affected employees, and the number of affected employees holding each such job title, is attached hereto. At Verizon we take the responsibility of protecting the personal information of our employees very seriously, including taking steps to ensure that any recipients of such information maintain it confidentially. Given that this notice is generally obtainable by third parties, and that affected employees have a legitimate privacy interest in not having their names, contact information, and selection for layoff made available to the general public for review, republication, or other purposes, we have omitted employee names and home addresses from this notice. The privacy interest here is the same interest that underlies the confidentiality of unemployment compensation information in the Employment Security Department's files. RCW 50.13.020. To assist with communication between affected employees and the Department, we are providing the Department's contact information to all affected employees.

We are providing you with this notice based upon the best information available to us at this time and do not plan to provide future notices with respect to this action. We wish to provide you with notices that are helpful, rather than inundate you with repeated or intermittent updates. However, please let us know if you would like us to provide you with future notices or additional information.
