Gentlemen,

I received indication from local media that a public release was issued from the Board of Commissioners earlier today that essentially states the Commission does not consider me the County Attorney in light of the July 12, 2021 inactive status I was placed on due to lacking 1.75 continuing legal education (CLE) credits for CLE reporting year 2020-21.

Simply put, there is *no excuse* for the delay in attaining the CLE credits necessary – the explanation is simply that it constitutes an oversight on my part. The date I received notice (July 14, 2021) of being placed on inactive status is the same day I completed the CLE requirements by on-line course and paid the \$200 reinstatement fee and \$50 late fee.

Attached is a copy of the Montana Supreme Court order reinstating to active status. In the future, please feel free to communicate any concerns with me. My Office is committed to professionalism and maintaining a healthy working relationship between local elected public officials.
