The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Disorderly Conduct - Offensive/Abusive/Boisterous/Noisy/Obscene

Minnesota Statute: 609.72.1(3)

Maximum Sentence: 90 days jail, 1,000 fine, or both

Offense Level: Misdemeanor

Offense Date (on or about): 04/28/2025

Control #(ICR#): 25020791

Charge Description: On or about April 28, 2025, within the City of Rochester, County of Olmsted, Shiloh Marie Hendrix (DOB 2/18/1989,) while in a public or private place and knowing, or having reasonable grounds to know, that it would or would tend to alarm, anger, disturb others, or provoke an assault or breach of the peace, did wrongfully and unlawfully engage in offensive, obscene, abusive, boisterous, or noisy conduct, or in offensive, obscene, or abusive language that would reasonably tend to arouse alarm, anger, or resentment in others, relative to victim Y.J.

Charge: Disorderly Conduct - Offensive/Abusive/Boisterous/Noisy/Obscene

Charge Description: On or about April 28, 2025, within the City of Rochester, County of Olmsted, Shiloh Marie Hendrix (DOB 2/18/1989,) while in a public or private place and knowing, or having reasonable grounds to know, that it would or would tend to alarm, anger, disturb others, or provoke an assault or breach of the peace, did wrongfully and unlawfully engage in offensive, obscene, abusive, boisterous, or noisy conduct, or in offensive, obscene, or abusive language that would reasonably tend to arouse alarm, anger, or resentment in others, relative to victim S.B.O.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

That your complainant is a peace officer employed by the Rochester Police Department who was advised of the following by Lt. F.O., a law enforcement officer with that agency, known to your complainant to be truthful and reliable and who is hereinafter referred to as F.O., that on or about April 30, 2025, he became aware of an incident that had occurred on April 28, 2025, at Roy Sutherland Playground, which is in the vicinity of the Soldier's Field Park, in the City of Rochester, Olmsted County.

F.O. learned that an individual had taken a phone video (hereinafter, "the video") of his encounter with an adult female, shortly after the female had engaged in a hostile and racist manner with a child who was at the park. The video had been uploaded to a social media platform where it was receiving significant attention.

Through further investigation, including a review of the video as well as social media activity related to the video, the suspect adult female was identified to be Shiloh Marie Hendrix, DOB 2/18/1989, hereinafter referred to as defendant. Attempts to make contact with defendant were unsuccessful.

Further investigation included a statement by a man identified as S.H.J. S.H.J. explained that he was at the above referenced park on April 28, 2025, shortly after 6 p.m., with his three children. One of his children (Y.J.) is eight years of age and is profoundly and visibly autistic. Due to his disability, Y.J. does not understand typical boundaries and requires intensive parental supervision. S.H.J. explained that at some point while at the park, Y.J. approached a diaper bag that belonged to someone else and he took an applesauce pouch from the bag. S.H.J. saw Y.J. take the item and attempted to retrieve the item from his son. Defendant also saw Y.J. take the item from her diaper bag and began chasing Y.J. as well. Y.J. climbed the playground equipment in an attempt to get away from his father and from defendant. Defendant became very angry while chasing Y.J. Defendant shouted at him and repeatedly used a racial epithet (the N-word; Y.J. is of Somali background,) causing Y.J. to freeze. Based on her anger and her words, S.H.J. feared that defendant may strike Y.J. Defendant angrily grabbed the food item from Y.J.

An individual, identified as S.B.O., who saw this encounter and heard defendant call the child the N-word approached defendant. With his phone recording, he asked defendant why she called the child the N-word, and pointed out to her that the child is autistic. Defendant admitted to calling the child the N-word, stating that she can call him that "if he acts like one." When pressed further, defendant turned her anger toward the man taking the video, raising her middle finger at him, cursing at him and repeatedly using the same epithet against him (the N-word.) When asked if she was about to hit the child, she said "Yeah! He took my son's stuff!" and said "That little f***ing kid did..." When confronted about her use of "hate speech" defendant twice stated "I don't give a s***." followed by "f*** off!"

S.H.J. explained that Y.J., as well as his other children, were very scared and troubled by Defendant's hateful words and conduct. At the time of this incident, there were multiple other unidentified individuals in the park, including children. In summary, defendant wrongfully and unlawfully engaged in offensive, obscene, abusive, boisterous, or noisy conduct, or in offensive obscene, or abusive language that would reasonably tend to arouse

alarm, anger, or resentment in others.
