Detective Blake Davidson (hereinafter "affiant"), first duly sworn on oath, deposes and says:

That he has reason to believe that the offenses of Murder in the Second Degree and Carrying or Use of Firearm in the Commission of a Separate Felony has been committed and that the perpetrator of said offense is Eric Thompson (hereinafter "Thompson");

That Murder in the Second Degree is in violation of Section 707-701.5 and 706-656 of the Hawai'i Revised Statutes;

That Carrying or Use of Firearm in the Commission of a Separate Felony is in violation of Section 134-21 of the Hawaii Revised Statutes;

That the facts tending to establish the grounds for the issuance of a warrant of arrest for Thompson are as follows:

Your affiant is a resident of the City and County of Honolulu, State of Hawaii; that your affiant is a police officer employed by the Honolulu Police Department (hereinafter "HPD") and has been so employed for fifteen (15) years; that your

affiant is presently assigned as a Detective to the Criminal Investigation Division (hereinafter "CID"), Homicide Detail, and has been so assigned since 2021; that prior to this current assignment, your affiant was assigned to the CID, Financial Crimes Detail and Sex Crimes Detail, with HPD; and that your affiant, in the course of performing his assigned duties, has investigated numerous criminal offenses including murders, assaults, sex assaults, and other related offenses, and has so testified in the courts of the State of Hawaii;

That on January 13, 2022, your affiant and Detective
Kaiminaauao Mead (hereinafter "Detective Mead") were assigned by
CID Homicide Lieutenant Deena Thoemmes to further investigate an
Unattended Death type case which occurred on January 12, 2022,
was reclassified to a Murder in the Second Degree type case
documented under HPD report number 22-017454;

Affiant ascertained the following facts, circumstances, and information to the best of his belief and knowledge, after reviewing the reports and statements relevant to this case:

1. On January 12, 2022, at about 6:12 p.m., L.T. was texting with her son, Jon Tokuhara (hereinafter "Tokuhara") regarding him picking up dinner at her residence after he had finished work. Tokuhara is an acupuncturist and is the owner and operator of Tokuhara Acupuncture and Healthcare located at 94-310 Waipahu Depot Street, Waipahu, HI 96797. At 6:12 p.m., Tokuhara sent his last text message to L.T. Tokuhara did not come to L.T.'s residence after their text message conversation to pick up dinner as they had arranged.

- 2. On January 13, 2022, at about 8:00 a.m., L.T. went to Tokuhara Acupuncture and Healthcare to check on Tokuhara and see if he wanted the dinner that he did not pick up the previous day. L.T. observed that Tokuhara's white Toyota Tacoma was parked in his parking stall fronting the business. L.T. accessed the business via the backdoor The back door which is located in the parking lot area. was closed, but unlocked when she first went in. There is a front door to the business which is accessed on Waipahu Depot Street, however this entrance is not used and the gate is secured with a bicycle lock. The front entrance has not been used for at least six (6) months. Upon entering the business, L.T. observed Tokuhara lying on the floor of his office, with a pool of blood by his head. Tokuhara appeared to be unresponsive and L.T. exited the building to get assistance and call 911.
- 3. On January 13, 2022, at about 8:11 a.m., Officer John Mintern (hereinafter "Officer Mintern") arrived on scene. Emergency Medical Services were already on scene and related to Officer Mintern that Tokuhara was deceased. Tokuhara was pronounced dead by Dr. Michael Dung on January 13, 2021, at 12:07 p.m.
- 4. Upon making checks of the scene, Officer Mintern observed what appeared to be a spent .22 caliber bullet casing on the ground near Tokuhara's head. Officer Mintern then initiated an Unattended Death type case.
- 5. Your affiant and Detective Mead were assigned to investigate this case documented under HPD Report Number 22-017454 and responded to the scene along with personnel from the HPD Scientific Investigation Section ("SIS") and the City and County of Honolulu Office of the Medical Examiner.
- 6. Upon your affiant's arrival at the scene, further checks were made in the office area and two additional spent .22 caliber bullet casings were located on the ground. One of the casing was found under Tokuhara's person and the other was located behind Tokuhara's refrigerator. All three bullet casings were recovered into evidence and submitted for analysis and identification. The three bullet casings were later analyzed by Criminalist Cindee Lorenzo (hereinafter "Criminalist Lorenzo"). Criminalist Lorenzo is assigned to analyze and identify firearms and ammunition in the Firearms and Ammunition unit of the Scientific

Investigative Section at HPD. She has been a Criminalist in that unit for 21 years. On January 31, 2022, Criminalist Lorenzo identified all three bullet casings as .22 Long or .22 Long Rifle discharged cartridge cases. Criminalist Lorenzo noted that .22 Long or .22 Long Rifle cartridges can be fired from pistols, revolvers, and rifles. Criminalist Lorenzo was unable to distinguish between .22 Long and .22 Long Rifle cartridges because both have the same dimensions.

- 7. Two cellular phones, which belonged to Tokuhara, were also located on the desk in the office. The two cellular phones were recovered as evidence. A digital forensic examination was conducted on both phones. It was determined that one of the recovered cellular phones was a phone that was not in service and needed WIFI to be operable. Through interviews conducted by your affiant and Detective Mead, it was determined that the WIFI-only phone was used to play the application Pokemon Go. That phone mirrored certain data on his other personal cellular phone and contained much of same information as the personal cellular phone. The examination on the other personal phone, which does have service, revealed that Tokuhara's cellular phone was last unlocked on January 12, 2022, at 6:18 p.m. After 6:18 p.m., there is no activity that is initiated by Tokuhara's cellular phone.
- 8. On January 14, 2022, at about 10:00 a.m., Doctor Jon Gates (hereinafter "Dr. Gates") conducted an autopsy on Tokuhara. Based on the autopsy examination and based on available information, Dr. Gates concluded that the cause of death was a gunshot to the head and the manner of death is homicide.
- 9. Video surveillance was recovered from various business located near the scene. At the time of recovery, checks of the video surveillance time stamp are done in comparison to the real time. The time difference is then notated by officer doing the recovery of the video surveillance. Officer William Oku III (hereinafter "Officer Oku") examined the multiple video surveillance footage recovered from neighboring businesses. Officer Oku discovered that some video surveillance footage include timestamps that do not correspond to the actual time. In an effort to consolidate a timeline of events, he reviewed each recovered video surveillance footage and determined the actual times for each video by adjusting for the time

difference that was noted during the recovery of video surveillance at each location. The video surveillance depicts the following events on January 12, 2022:

- At about 5:57 p.m., a white, four-door Chevrolet Silverado pickup (hereinafter "Silverado") is seen turning north onto Waipahu Depot Street from Farrington Highway.
- As the Silverado drives past the businesses on Waipahu Depot Street, the front license plate of the vehicle is visible. A still photograph taken from the video surveillance show that the first three characters in the license plate appear to letters and the last three characters in the license plate appear to be numerals. Based on the images, it was determined that the license plate was a State of Hawai'i license plate that begins with three letters and ends in three numerals.
- At about 5:57:34 p.m., the Silverado turns east onto Hikimoe Street.
- At about 5:57:38 p.m., the Silverado turns north onto Kahuailani Street.
- At about 5:58:10 p.m., the Silverado continues on Kahuailani Street and passes the intersection with Puamano Street. The Silverado then drives out of view of the camera.
- At about 6:10 p.m. a person is visible walking west on Kahuailani Street near the intersection with Puamano Place. The person is wearing dark colored clothing, a light colored hat, and carrying what appears to be a large brown paper shopping bag with handles.
- At about 6:11:40 p.m., the person continues west and then south as Kahuailani Street curves towards Hikimoe Street.
- At about 6:12:50 p.m., the person is seen walking near the intersection of Kahuailani Street and Hikimoe Street where he then begins walking west on Hikimoe Street.
- At about 6:13:37 p.m., the person walks to the intersection of Hikimoe Street and Waipahu Depot Street.
- At about 6:14:04 p.m., the person crosses Waipahu Depot Street near the front door of Tokuhara Acupuncture and Healthcare.

- At about 6:14:55 p.m., the person then begins walking south on Waipahu Depot Street to the end of the building. This surveillance camera has a more detailed view of the person due to his close proximity to the camera. The person is wearing a light colored bucket style hat, dark colored sunglasses, a light colored head covering and scarf, a dark colored jacket over a light colored shirt, dark colored pants, shoes, and a shopping bag with handles.
- At about 6:14:59 p.m., the person walks around the south end of the building and into the parking lot area.
- At about 6:15:35 p.m., the person walks to an area of the parking lot where Tokuhara's vehicle and the door to his business are visible.
- At about 6:16:03 p.m., the person enters the entrance to Tokuhara Acupuncture and Healthcare.
- At about 6:16:51 p.m., the person exits Tokuhara Acupuncture and Healthcare. Based on the video surveillance, the suspect was inside Tokuhara's office for no longer than forty-eight seconds.
- At about 6:17:22 p.m., the person walks back around the south end of the building and crosses Waipahu Depot Street. The person is seen still carrying the large brown paper shopping bag with handles.
- As the person is crossing Waipahu Depot Street, his hat falls off his head, and is left behind by the person. The hat is left in the roadway for approximately ten (10) minutes until it is picked up by an unknown person pedestrian, later identified as V.T.
- At about 6:17:52 p.m., the person walks east on Hikimoe Street and crosses the street.
- At about 6:18:18 p.m. the person is walking north on Kahuailani Street towards the area of the street where it begins to curve to the east.
- At about 6:20:05 p.m., the person is walking east on Kahuailani Street near the intersection of Puamano Street. The person then goes out of camera view. This was the same direction as the Silverado when it first drove by.
- At about 6:21:30 p.m., the Silverado is visible driving west on Kahuailani Street. The Silverado then turns north onto Puamano Street and approaches Waipahu Street.

- At about 6:22:00 p.m., the Silverado is visible driving east on Waipahu Street. The license plate of the Silverado is not visible and there do not appear to be any distinguishing marks on the Silverado. There are no items visible in the bed of the Silverado.
- Video footage of the entrance/exit of Tokuhara's business does not show any other person entering or exiting from when the suspect exits until Tokuhara's mother arrives the following morning at 8:00 a.m.
- 10. Based on the foregoing observations, coupled with Tokuhara's last text at 6:12 p.m. to his mother, we believe the suspect who shot and killed Tokuhara was the person seen in the video surveillance and driving off in the Silverado with a front license plate beginning with letters and ending in numerals.
- 11. On January 26, 2022, your affiant and Detective Mead met with Servco Auto sales specialist M.G. at the Waipahu Servco Auto car dealership. M.G. has worked in sales at Servco Waipahu Auto since 1997 and is intimately familiar with Chevrolets as one of the brands of vehicles that M.G. sells at Servco Waipahu Auto are Chevrolets. M.G. was shown still photographs of the Silverado taken from the video surveillance in the Waipahu area. M.G. related that based on the body type of the vehicle as well as other features, the vehicles in the still photographs is a 2014, 2015, or 2016 model Chevrolet Silverado basic crew cab standard bed work truck.
- 12. Your affiant and Detective Mead went through police database and the National Highway Traffic Safety Administration database to determine the registered owners of all Chevrolet Silverado models from the years 2014 through 2016. With the help of the HPD Strategic Enforcement Detail, we were able to determine that there are fifty-three (53) Chevrolet Silverado models from the years 2014 through 2016 registered in the State of Hawai'i with license plates that begin with letters and end in numerals. The HPD Strategic Enforcement Detail then called up fifty-two (52) of the fifty-three (53) registered owners. Some belonged to University of Hawai'i, others belonged to the Department of Land and Natural Resources. Based on photographs, seeing the vehicles in person, or their location, we were able to exclude fifty-two (52) of the fifty-three (53) Chevrolet Silverados as the suspect

- vehicle. The registered owner of the only Chevrolet Silverado we were unable to exclude is Eric H. Thompson (hereinafter "Thompson").
- 13. On January 22, 2022, V.T. was located in the area of the Hawaii Plantation Village in Waipahu. V.T. was shown a still photograph of him with the hat that the person was wearing when he crossed Waipahu Depot Street. V.T. identified himself in the still photograph and related that he had observed the hat in the middle of the street and picked it up because it did not seem to belong to anyone. V.T. then put the hat on and walked back to his campsite at the Hawaii Plantation Village. V.T. then put the hat in his campsite and did not wear it again. V.T. related that no one else besides him had handled or worn the hat from the time that he had found it in the street on January 12, 2022 until the time that it was recovered by police on January 22, 2022. The hat was recovered as evidence and processed by SIS. After processing the hat, SIS found fibers and a hair in the hat which can be analyzed and compared to any samples recovered during this investigation.
- On January 13, 2022, at about 8:04 p.m., your affiant 14. and Detective Mead conducted a recorded interview with K.O., a patient of Tokuhara and last patient of the day on January 12, 2022. K.O. has been a patient of Tokuhara since 2016 and has been seeing him on a regular basis for acupuncture, scheduling weekly appointments with K.O every Wednesday from 3:30 p.m. to 5:30 p.m. On January 12, 2022, just before 3:30 p.m., K.O arrived at Tokuhara's office for her scheduled appointment. K.O. then received her acupuncture treatment from 3:30 p.m. to about 5:30 p.m. After completing her appointment, K.O. left Tokuhara's office and went to her vehicle, which was parked right outside the office. K.O. did not observe anything out of the ordinary during her appointment or in the parking lot area when she was leaving. Tokuhara did not appear to act out of the ordinary when he treated her.
- 15. We learned from K.O. that Joyce Thompson (hereinafter "Joyce") is married to Thompson. In her interviews, K.O. provided information as to Tokuhara's relationship with Joyce. K.O. is a teacher and taught both Joyce and her husband, Thompson, when they were high school students at Kalani High School. Joyce and Thompson began a relationship in high school that turned into their marriage. K.O.

introduced Joyce to Tokuhara in 2019 for acupuncture because Joyce was suffering from back pain and was also looking for treatment to help with fertility. In a conversation she had with Joyce on August 11, 2021, Joyce revealed that she recently had an affair, but did not initially say with whom she had the affair, and that her husband, Thompson, knew about the affair.

- 16. Your affiant and Detective Mead investigated Tokuhara's phone to learn more of his relationship with Joyce and any material relevant to his death. Most recent messages and phone calls on Tokuhara's cellular phone were with his current girlfriend. Located in Tokuhara's Instagram direct messages, however, were a conversation between him and Joyce with the user name "@littesqueezeme." Their direct message conversation that we could view spanned the time period from May 14, 2021 to July 23, 2021.
- 17. Detective Mead reviewed the content of the direct messages between Tokuhara and Joyce. During the course of their direct messages, Tokuhara and Joyce spoke at length of their intimate relationship. They both spoke of Joyce being married and express fear of her husband, Thompson, discovering their relationship. There are also several explicit, nude videos and photographs of Joyce and Tokuhara in their direct message conversation.
- 18. Tokuhara appeared to want a long term relationship with Joyce and not just an affair. Joyce related to Tokuhara that she was not willing to leave her husband, but does care for Tokuhara and wanted to continue their relationship.
- 19. In July of 2021, Tokuhara and Joyce had a conversation regarding Thompson finding out about their intimate relationship. Joyce told Tokuhara that they have to end their relationship and that he cannot contact her anymore. Tokuhara asked if he can keep in contact with Joyce through her siblings. Joyce related that they should not have any contact. The last Instagram message was sent on July 23, 2021.
- 20. The next contact between Tokuhara and Joyce is a missed facetime call from Joyce to Tokuhara on August 22, 2021. No further communication was located in Tokuhara's

cellular phone, however not all deleted calls and conversations were visible on Tokuhara's cellular phone.

- 21. Checks via police database indicate that there is a Joyce and Eric Thompson that reside at 4901 Kalanianaole Highway. Thompson is a 34 year old male with a birth year of 1987. His information on his Hawaii Drivers License indicates that he is 5'8" and 160 pounds. Thompson has twelve registered firearms in the State of Hawaii. Thompson is also the registered owner of a white 2014 Chevrolet Silverado bearing Hawaii license plates TFW 289.
- 22. On January 20, 2022, HPD officers conducted surveillance of 4901 Kalanianaole Highway and observed Thompson's Silverado bearing Hawaii license plates TFW 289 in the driveway of his residence. In the bed of the Silverado was a silver cross box which is commonly used to store tools. The video surveillance used to determine the suspect vehicle did not show the suspect Silverado with a silver cross box in the bed of the truck.
- 23. Officers recovered additional surveillance video footage from Thompson's neighbor. The footage is from a camera that overlooks the street Thompson lives on and part of his driveway.
- 24. Officer Oku also examined the footage and in an effort to consolidate a timeline of events, he reviewed the recovered video surveillance footage from Thompson's neighbor and determined the actual times for that video by being adjusting for the time difference that was noted during the recovery of video surveillance. The video surveillance depicts the following events on January 12, 2022:
 - At about 5:20 p.m., a white Chevrolet Silverado, is visible emerging from Thompson's driveway and turns onto the lane shared by the residences. The Chevrolet Silverado then drives towards Kalanianaole Highway. There are no distinguishing marks or items visible in the bed of the truck.
 - At about 6:47 p.m., a white Chevrolet Silverado, returns and drives onto the lane shared by Thompson and his neighbor from the direction of Kalanianaole Highway. The Chevrolet Silverado then drives into Thompson's driveway. There are no distinguishing marks or items visible in the bed of the truck.

- At about 7:34 p.m., what appears to be the glow of a fire is visible on northwest corner of the property located at 4901 Kalanianaole Highway.
- At about 7:39 p.m., the glow is no longer visible.
- At about 9:53 p.m., the same white Chevrolet Silverado emerges from Thompson's driveway and turns onto the lane shared by the residences. The Chevrolet Silverado then drives towards Kalanianaole Highway. The Chevrolet Silverado now has a cross box in the bed of the truck.
- At about 10:43 p.m., the white Chevrolet Silverado drives onto the lane shared by the residences from the direction of Kalanianaole Highway. The Chevrolet Silverado then drives into Thompson's driveway. There is still a cross box in the bed of the Chevrolet Silverado.
- 25. Based on personal experience and checks on Google Maps show that on January 12, 2022, it would take a vehicle between 35-55 minutes to reach the area of Kahuailani Street from 4901 Kalanianaole Highway if they departed at 5:20 p.m. The Chevrolet Silverado is first seen on video surveillance in the Waipahu area at 5:57 p.m., which is 37 minutes after the Chevrolet Silverado is seen leaving the driveway of 4901 Kalanianaole Highway.
- 26. Based on personal experience and checks on Google Maps show that on January 12, 2022, it would take a vehicle between 26-40 minutes to reach 4901 Kalanianaole Highway from the area of Kahuailani Street if they departed at 6:22 p.m. The Chevrolet Silverado is seen on video surveillance at 4901 Kalanianaole Highway at 6:48 p.m., which is 26 minutes after the Chevrolet Silverado is last seen in the Waipahu area on Mokuola Street.
- 27. On January 31, 2022, your affiant prepared a search warrant to search the premises of 4901 Kalanianaole Highway, the 2014 Chevrolet Silverado bearing State of Hawaii license plate TFW289 registered to Thompson, and the person of Eric Thompson.
- 28. The search warrant allowed for the search for physical, transfer, or trace evidence, firearms, firearms components, ammunition, ammunition clips or magazines, a biological sample from Thompson, video surveillance systems and all electronic devices capable of remotely accessing the video surveillance.

- 29. On January 31, 2022, the search warrant was reviewed and approved by the Honorable Judge James Kawashima of the District Court of the First Circuit. This search warrant was filed as S.W. 2022-035.
- 30. On February 1, 2022, at about 7:30 p.m., S.W. 2022-035 was served to Thompson in the parking lot of 820 West Hind Drive. A biological sample was taken from Thompson and his cellular phone was recovered as evidence. Thompson's vehicle bearing State of Hawaii license plate TFW289 was recovered as evidence and towed to the Main Police Station.
- 31. On February 1, 2022, at about 7:35 p.m., S.W. 2022-035 was executed at 4901 Kalanianaole Highway. Among the items recovered were the twelve (12) firearms registered to Thompson. Two (2) additional firearms were recovered from the residence that are not registered in the State of Hawaii.
- 32. On February 4, 2022, Detective Mead submitted a request to have the hat recovered from V.T. analyzed for possible DNA evidence.
- 33. On February 10, 2022, HPD Criminalist Michelle Amorin (hereinafter "Criminalist Amorin") completed a report regarding the analysis of the hat recovered from V.T. The report indicated that following:
 - From the sample taken from the interior side of the crown of the hat, Thompson cannot be excluded as a possible contributor to the DNA mixture. Using the most conservative frequency estimate calculated, approximately 131,200 unrelated individuals would have to be evaluated before expecting to find an individual that would have a DNA profile that cannot be excluded as a possible contributor to the mixed DNA profile from this item of evidence.
 - From the sample taken from the interior top of the crown of the hat, Thompson cannot be excluded as a possible contributor to the DNA mixture. Using the most conservative frequency estimate calculated, approximately 224,800 unrelated individuals would have to be evaluated before expecting to find an individual that would have a DNA profile that cannot be excluded as a possible contributor to the mixed DNA profile from this item of evidence.

34. All of this occurred within the City and County of Honolulu, State of Hawaii;

WHEREFORE, your affiant respectfully prays that based upon the facts and circumstances contained in this affidavit, a warrant of arrest be issued for the arrest of Eric Thompson for the charges of Murder in the Second Degree and of Carrying or Use of Firearm in the Commission of a Separate Felony; that said Eric Thompson be brought forthwith before this Judge or detained subject to the order of this Court or any other court in which the offense to which the said Eric Thompson is triable for violation of Section 707-701.5 and 706-656 and Section 134-21, of the Hawaii Revised Statutes.

On or about January 12, 2022, in the City and County of Honolulu, State of Hawaii, Eric Thompson did knowingly carry on his person or have within his immediate control or did intentionally use or threaten to use a firearm while engaged in the commission of a separate felony, to wit, Murder in the Second Degree and/or any included felony offense of Murder in the Second Degree, whether the firearm was loaded or not, and whether operable or not, thereby committing the offense of Carrying or Use of Firearm in the Commission of a Separate Felony, in violation of Section 134-21 of the Hawaii Revised Statutes. Eric Thompson commits the offense of Murder in the Second Degree, in violation of Section 707-701.5 and 706-656 of the Hawai'i Revised Statutes, if he did intentionally or knowingly cause the death of Jon Tokuhara.

If convicted of this offense or any included felony offense, Eric Thompson may be subject to sentencing in accordance with Section 706-661 and Section 706-662(4)(a) of the Hawaii Revised Statutes where he is a multiple offender in that he is being sentenced for two or more felonies or is already under sentence of imprisonment for any felony, and an extended term of imprisonment is necessary for the protection of the public.

Detective Blake Davidson (hereinafter "affiant"), first duly sworn on oath, deposes and says:

That he has reason to believe that the offenses of Murder in the Second Degree and Carrying or Use of Firearm in the Commission of a Separate Felony has been committed and that the perpetrator of said offense is Eric Thompson (hereinafter "Thompson");

That Murder in the Second Degree is in violation of Section 707-701.5 and 706-656 of the Hawai'i Revised Statutes;

That Carrying or Use of Firearm in the Commission of a Separate Felony is in violation of Section 134-21 of the Hawaii Revised Statutes;

That the facts tending to establish the grounds for the issuance of a warrant of arrest for Thompson are as follows:

Your affiant is a resident of the City and County of Honolulu, State of Hawaii; that your affiant is a police officer employed by the Honolulu Police Department (hereinafter "HPD") and has been so employed for fifteen (15) years; that your

affiant is presently assigned as a Detective to the Criminal Investigation Division (hereinafter "CID"), Homicide Detail, and has been so assigned since 2021; that prior to this current assignment, your affiant was assigned to the CID, Financial Crimes Detail and Sex Crimes Detail, with HPD; and that your affiant, in the course of performing his assigned duties, has investigated numerous criminal offenses including murders, assaults, sex assaults, and other related offenses, and has so testified in the courts of the State of Hawaii;

That on January 13, 2022, your affiant and Detective
Kaiminaauao Mead (hereinafter "Detective Mead") were assigned by
CID Homicide Lieutenant Deena Thoemmes to further investigate an
Unattended Death type case which occurred on January 12, 2022,
was reclassified to a Murder in the Second Degree type case
documented under HPD report number 22-017454;

Affiant ascertained the following facts, circumstances, and information to the best of his belief and knowledge, after reviewing the reports and statements relevant to this case:

1. On January 12, 2022, at about 6:12 p.m., L.T. was texting with her son, Jon Tokuhara (hereinafter "Tokuhara") regarding him picking up dinner at her residence after he had finished work. Tokuhara is an acupuncturist and is the owner and operator of Tokuhara Acupuncture and Healthcare located at 94-310 Waipahu Depot Street, Waipahu, HI 96797. At 6:12 p.m., Tokuhara sent his last text message to L.T. Tokuhara did not come to L.T.'s residence after their text message conversation to pick up dinner as they had arranged.

- 2. On January 13, 2022, at about 8:00 a.m., L.T. went to Tokuhara Acupuncture and Healthcare to check on Tokuhara and see if he wanted the dinner that he did not pick up the previous day. L.T. observed that Tokuhara's white Toyota Tacoma was parked in his parking stall fronting the business. L.T. accessed the business via the backdoor which is located in the parking lot area. The back door was closed, but unlocked when she first went in. There is a front door to the business which is accessed on Waipahu Depot Street, however this entrance is not used and the gate is secured with a bicycle lock. The front entrance has not been used for at least six (6) months. Upon entering the business, L.T. observed Tokuhara lying on the floor of his office, with a pool of blood by his head. Tokuhara appeared to be unresponsive and L.T. exited the building to get assistance and call 911.
- 3. On January 13, 2022, at about 8:11 a.m., Officer John Mintern (hereinafter "Officer Mintern") arrived on scene. Emergency Medical Services were already on scene and related to Officer Mintern that Tokuhara was deceased. Tokuhara was pronounced dead by Dr. Michael Dung on January 13, 2021, at 12:07 p.m.
- 4. Upon making checks of the scene, Officer Mintern observed what appeared to be a spent .22 caliber bullet casing on the ground near Tokuhara's head. Officer Mintern then initiated an Unattended Death type case.
- 5. Your affiant and Detective Mead were assigned to investigate this case documented under HPD Report Number 22-017454 and responded to the scene along with personnel from the HPD Scientific Investigation Section ("SIS") and the City and County of Honolulu Office of the Medical Examiner.
- 6. Upon your affiant's arrival at the scene, further checks were made in the office area and two additional spent .22 caliber bullet casings were located on the ground. One of the casing was found under Tokuhara's person and the other was located behind Tokuhara's refrigerator. All three bullet casings were recovered into evidence and submitted for analysis and identification. The three bullet casings were later analyzed by Criminalist Cindee Lorenzo (hereinafter "Criminalist Lorenzo"). Criminalist Lorenzo is assigned to analyze and identify firearms and ammunition in the Firearms and Ammunition unit of the Scientific

Investigative Section at HPD. She has been a Criminalist in that unit for 21 years. On January 31, 2022, Criminalist Lorenzo identified all three bullet casings as .22 Long or .22 Long Rifle discharged cartridge cases. Criminalist Lorenzo noted that .22 Long or .22 Long Rifle cartridges can be fired from pistols, revolvers, and rifles. Criminalist Lorenzo was unable to distinguish between .22 Long and .22 Long Rifle cartridges because both have the same dimensions.

- 7. Two cellular phones, which belonged to Tokuhara, were also located on the desk in the office. The two cellular phones were recovered as evidence. A digital forensic examination was conducted on both phones. It was determined that one of the recovered cellular phones was a phone that was not in service and needed WIFI to be operable. Through interviews conducted by your affiant and Detective Mead, it was determined that the WIFI-only phone was used to play the application Pokemon Go. That phone mirrored certain data on his other personal cellular phone and contained much of same information as the personal cellular phone. The examination on the other personal phone, which does have service, revealed that Tokuhara's cellular phone was last unlocked on January 12, 2022, at 6:18 p.m. After 6:18 p.m., there is no activity that is initiated by Tokuhara's cellular phone.
- 8. On January 14, 2022, at about 10:00 a.m., Doctor Jon Gates (hereinafter "Dr. Gates") conducted an autopsy on Tokuhara. Based on the autopsy examination and based on available information, Dr. Gates concluded that the cause of death was a gunshot to the head and the manner of death is homicide.
- 9. Video surveillance was recovered from various business located near the scene. At the time of recovery, checks of the video surveillance time stamp are done in comparison to the real time. The time difference is then notated by officer doing the recovery of the video surveillance. Officer William Oku III (hereinafter "Officer Oku") examined the multiple video surveillance footage recovered from neighboring businesses. Officer Oku discovered that some video surveillance footage include timestamps that do not correspond to the actual time. In an effort to consolidate a timeline of events, he reviewed each recovered video surveillance footage and determined the actual times for each video by adjusting for the time

difference that was noted during the recovery of video surveillance at each location. The video surveillance depicts the following events on January 12, 2022:

- At about 5:57 p.m., a white, four-door Chevrolet Silverado pickup (hereinafter "Silverado") is seen turning north onto Waipahu Depot Street from Farrington Highway.
- As the Silverado drives past the businesses on Waipahu Depot Street, the front license plate of the vehicle is visible. A still photograph taken from the video surveillance show that the first three characters in the license plate appear to letters and the last three characters in the license plate appear to be numerals. Based on the images, it was determined that the license plate was a State of Hawai'i license plate that begins with three letters and ends in three numerals.
- At about 5:57:34 p.m., the Silverado turns east onto Hikimoe Street.
- At about 5:57:38 p.m., the Silverado turns north onto Kahuailani Street.
- At about 5:58:10 p.m., the Silverado continues on Kahuailani Street and passes the intersection with Puamano Street. The Silverado then drives out of view of the camera.
- At about 6:10 p.m. a person is visible walking west on Kahuailani Street near the intersection with Puamano Place. The person is wearing dark colored clothing, a light colored hat, and carrying what appears to be a large brown paper shopping bag with handles.
- At about 6:11:40 p.m., the person continues west and then south as Kahuailani Street curves towards Hikimoe Street.
- At about 6:12:50 p.m., the person is seen walking near the intersection of Kahuailani Street and Hikimoe Street where he then begins walking west on Hikimoe Street.
- At about 6:13:37 p.m., the person walks to the intersection of Hikimoe Street and Waipahu Depot Street.
- At about 6:14:04 p.m., the person crosses Waipahu Depot Street near the front door of Tokuhara Acupuncture and Healthcare.

- At about 6:14:55 p.m., the person then begins walking south on Waipahu Depot Street to the end of the building. This surveillance camera has a more detailed view of the person due to his close proximity to the camera. The person is wearing a light colored bucket style hat, dark colored sunglasses, a light colored head covering and scarf, a dark colored jacket over a light colored shirt, dark colored pants, shoes, and a shopping bag with handles.
- At about 6:14:59 p.m., the person walks around the south end of the building and into the parking lot area.
- At about 6:15:35 p.m., the person walks to an area of the parking lot where Tokuhara's vehicle and the door to his business are visible.
- At about 6:16:03 p.m., the person enters the entrance to Tokuhara Acupuncture and Healthcare.
- At about 6:16:51 p.m., the person exits Tokuhara Acupuncture and Healthcare. Based on the video surveillance, the suspect was inside Tokuhara's office for no longer than forty-eight seconds.
- At about 6:17:22 p.m., the person walks back around the south end of the building and crosses Waipahu Depot Street. The person is seen still carrying the large brown paper shopping bag with handles.
- As the person is crossing Waipahu Depot Street, his hat falls off his head, and is left behind by the person. The hat is left in the roadway for approximately ten (10) minutes until it is picked up by an unknown person pedestrian, later identified as V.T.
- At about 6:17:52 p.m., the person walks east on Hikimoe Street and crosses the street.
- At about 6:18:18 p.m. the person is walking north on Kahuailani Street towards the area of the street where it begins to curve to the east.
- At about 6:20:05 p.m., the person is walking east on Kahuailani Street near the intersection of Puamano Street. The person then goes out of camera view. This was the same direction as the Silverado when it first drove by.
- At about 6:21:30 p.m., the Silverado is visible driving west on Kahuailani Street. The Silverado then turns north onto Puamano Street and approaches Waipahu Street.

- At about 6:22:00 p.m., the Silverado is visible driving east on Waipahu Street. The license plate of the Silverado is not visible and there do not appear to be any distinguishing marks on the Silverado. There are no items visible in the bed of the Silverado.
- Video footage of the entrance/exit of Tokuhara's business does not show any other person entering or exiting from when the suspect exits until Tokuhara's mother arrives the following morning at 8:00 a.m.
- 10. Based on the foregoing observations, coupled with Tokuhara's last text at 6:12 p.m. to his mother, we believe the suspect who shot and killed Tokuhara was the person seen in the video surveillance and driving off in the Silverado with a front license plate beginning with letters and ending in numerals.
- 11. On January 26, 2022, your affiant and Detective Mead met with Servco Auto sales specialist M.G. at the Waipahu Servco Auto car dealership. M.G. has worked in sales at Servco Waipahu Auto since 1997 and is intimately familiar with Chevrolets as one of the brands of vehicles that M.G. sells at Servco Waipahu Auto are Chevrolets. M.G. was shown still photographs of the Silverado taken from the video surveillance in the Waipahu area. M.G. related that based on the body type of the vehicle as well as other features, the vehicles in the still photographs is a 2014, 2015, or 2016 model Chevrolet Silverado basic crew cab standard bed work truck.
- 12. Your affiant and Detective Mead went through police database and the National Highway Traffic Safety Administration database to determine the registered owners of all Chevrolet Silverado models from the years 2014 through 2016. With the help of the HPD Strategic Enforcement Detail, we were able to determine that there are fifty-three (53) Chevrolet Silverado models from the years 2014 through 2016 registered in the State of Hawai'i with license plates that begin with letters and end in numerals. The HPD Strategic Enforcement Detail then called up fifty-two (52) of the fifty-three (53) registered owners. Some belonged to University of Hawai'i, others belonged to the Department of Land and Natural Resources. Based on photographs, seeing the vehicles in person, or their location, we were able to exclude fifty-two (52) of the fifty-three (53) Chevrolet Silverados as the suspect

- vehicle. The registered owner of the only Chevrolet Silverado we were unable to exclude is Eric H. Thompson (hereinafter "Thompson").
- On January 22, 2022, V.T. was located in the area of 13. the Hawaii Plantation Village in Waipahu. V.T. was shown a still photograph of him with the hat that the person was wearing when he crossed Waipahu Depot Street. identified himself in the still photograph and related that he had observed the hat in the middle of the street and picked it up because it did not seem to belong to anyone. V.T. then put the hat on and walked back to his campsite at the Hawaii Plantation Village. V.T. then put the hat in his campsite and did not wear it again. V.T. related that no one else besides him had handled or worn the hat from the time that he had found it in the street on January 12, 2022 until the time that it was recovered by police on January 22, 2022. The hat was recovered as evidence and processed by SIS. After processing the hat, SIS found fibers and a hair in the hat which can be analyzed and compared to any samples recovered during this investigation.
- On January 13, 2022, at about 8:04 p.m., your affiant and Detective Mead conducted a recorded interview with K.O., a patient of Tokuhara and last patient of the day on January 12, 2022. K.O. has been a patient of Tokuhara since 2016 and has been seeing him on a regular basis for acupuncture, scheduling weekly appointments with K.O every Wednesday from 3:30 p.m. to 5:30 p.m. On January 12, 2022, just before 3:30 p.m., K.O arrived at Tokuhara's office for her scheduled appointment. K.O. then received her acupuncture treatment from 3:30 p.m. to about 5:30 p.m. After completing her appointment, K.O. left Tokuhara's office and went to her vehicle, which was parked right outside the office. K.O. did not observe anything out of the ordinary during her appointment or in the parking lot area when she was leaving. Tokuhara did not appear to act out of the ordinary when he treated her.
- 15. We learned from K.O. that Joyce Thompson (hereinafter "Joyce") is married to Thompson. In her interviews, K.O. provided information as to Tokuhara's relationship with Joyce. K.O. is a teacher and taught both Joyce and her husband, Thompson, when they were high school students at Kalani High School. Joyce and Thompson began a relationship in high school that turned into their marriage. K.O.

introduced Joyce to Tokuhara in 2019 for acupuncture because Joyce was suffering from back pain and was also looking for treatment to help with fertility. In a conversation she had with Joyce on August 11, 2021, Joyce revealed that she recently had an affair, but did not initially say with whom she had the affair, and that her husband, Thompson, knew about the affair.

- 16. Your affiant and Detective Mead investigated Tokuhara's phone to learn more of his relationship with Joyce and any material relevant to his death. Most recent messages and phone calls on Tokuhara's cellular phone were with his current girlfriend. Located in Tokuhara's Instagram direct messages, however, were a conversation between him and Joyce with the user name "@littesqueezeme." Their direct message conversation that we could view spanned the time period from May 14, 2021 to July 23, 2021.
- 17. Detective Mead reviewed the content of the direct messages between Tokuhara and Joyce. During the course of their direct messages, Tokuhara and Joyce spoke at length of their intimate relationship. They both spoke of Joyce being married and express fear of her husband, Thompson, discovering their relationship. There are also several explicit, nude videos and photographs of Joyce and Tokuhara in their direct message conversation.
- 18. Tokuhara appeared to want a long term relationship with Joyce and not just an affair. Joyce related to Tokuhara that she was not willing to leave her husband, but does care for Tokuhara and wanted to continue their relationship.
- 19. In July of 2021, Tokuhara and Joyce had a conversation regarding Thompson finding out about their intimate relationship. Joyce told Tokuhara that they have to end their relationship and that he cannot contact her anymore. Tokuhara asked if he can keep in contact with Joyce through her siblings. Joyce related that they should not have any contact. The last Instagram message was sent on July 23, 2021.
- 20. The next contact between Tokuhara and Joyce is a missed facetime call from Joyce to Tokuhara on August 22, 2021. No further communication was located in Tokuhara's

cellular phone, however not all deleted calls and conversations were visible on Tokuhara's cellular phone.

- 21. Checks via police database indicate that there is a Joyce and Eric Thompson that reside at 4901 Kalanianaole Highway. Thompson is a 34 year old male with a birth year of 1987. His information on his Hawaii Drivers License indicates that he is 5'8" and 160 pounds. Thompson has twelve registered firearms in the State of Hawaii. Thompson is also the registered owner of a white 2014 Chevrolet Silverado bearing Hawaii license plates TFW 289.
- 22. On January 20, 2022, HPD officers conducted surveillance of 4901 Kalanianaole Highway and observed Thompson's Silverado bearing Hawaii license plates TFW 289 in the driveway of his residence. In the bed of the Silverado was a silver cross box which is commonly used to store tools. The video surveillance used to determine the suspect vehicle did not show the suspect Silverado with a silver cross box in the bed of the truck.
- 23. Officers recovered additional surveillance video footage from Thompson's neighbor. The footage is from a camera that overlooks the street Thompson lives on and part of his driveway.
- 24. Officer Oku also examined the footage and in an effort to consolidate a timeline of events, he reviewed the recovered video surveillance footage from Thompson's neighbor and determined the actual times for that video by being adjusting for the time difference that was noted during the recovery of video surveillance. The video surveillance depicts the following events on January 12, 2022:
 - At about 5:20 p.m., a white Chevrolet Silverado, is visible emerging from Thompson's driveway and turns onto the lane shared by the residences. The Chevrolet Silverado then drives towards Kalanianaole Highway. There are no distinguishing marks or items visible in the bed of the truck.
 - At about 6:47 p.m., a white Chevrolet Silverado, returns and drives onto the lane shared by Thompson and his neighbor from the direction of Kalanianaole Highway. The Chevrolet Silverado then drives into Thompson's driveway. There are no distinguishing marks or items visible in the bed of the truck.

- At about 7:34 p.m., what appears to be the glow of a fire is visible on northwest corner of the property located at 4901 Kalanianaole Highway.
- At about 7:39 p.m., the glow is no longer visible.
- At about 9:53 p.m., the same white Chevrolet Silverado emerges from Thompson's driveway and turns onto the lane shared by the residences. The Chevrolet Silverado then drives towards Kalanianaole Highway. The Chevrolet Silverado now has a cross box in the bed of the truck.
- At about 10:43 p.m., the white Chevrolet Silverado drives onto the lane shared by the residences from the direction of Kalanianaole Highway. The Chevrolet Silverado then drives into Thompson's driveway. There is still a cross box in the bed of the Chevrolet Silverado.
- 25. Based on personal experience and checks on Google Maps show that on January 12, 2022, it would take a vehicle between 35-55 minutes to reach the area of Kahuailani Street from 4901 Kalanianaole Highway if they departed at 5:20 p.m. The Chevrolet Silverado is first seen on video surveillance in the Waipahu area at 5:57 p.m., which is 37 minutes after the Chevrolet Silverado is seen leaving the driveway of 4901 Kalanianaole Highway.
- 26. Based on personal experience and checks on Google Maps show that on January 12, 2022, it would take a vehicle between 26-40 minutes to reach 4901 Kalanianaole Highway from the area of Kahuailani Street if they departed at 6:22 p.m. The Chevrolet Silverado is seen on video surveillance at 4901 Kalanianaole Highway at 6:48 p.m., which is 26 minutes after the Chevrolet Silverado is last seen in the Waipahu area on Mokuola Street.
- 27. On January 31, 2022, your affiant prepared a search warrant to search the premises of 4901 Kalanianaole Highway, the 2014 Chevrolet Silverado bearing State of Hawaii license plate TFW289 registered to Thompson, and the person of Eric Thompson.
- 28. The search warrant allowed for the search for physical, transfer, or trace evidence, firearms, firearms components, ammunition, ammunition clips or magazines, a biological sample from Thompson, video surveillance systems and all electronic devices capable of remotely accessing the video surveillance.

- 29. On January 31, 2022, the search warrant was reviewed and approved by the Honorable Judge James Kawashima of the District Court of the First Circuit. This search warrant was filed as S.W. 2022-035.
- 30. On February 1, 2022, at about 7:30 p.m., S.W. 2022-035 was served to Thompson in the parking lot of 820 West Hind Drive. A biological sample was taken from Thompson and his cellular phone was recovered as evidence. Thompson's vehicle bearing State of Hawaii license plate TFW289 was recovered as evidence and towed to the Main Police Station.
- 31. On February 1, 2022, at about 7:35 p.m., S.W. 2022-035 was executed at 4901 Kalanianaole Highway. Among the items recovered were the twelve (12) firearms registered to Thompson. Two (2) additional firearms were recovered from the residence that are not registered in the State of Hawaii.
- 32. On February 4, 2022, Detective Mead submitted a request to have the hat recovered from V.T. analyzed for possible DNA evidence.
- 33. On February 10, 2022, HPD Criminalist Michelle Amorin (hereinafter "Criminalist Amorin") completed a report regarding the analysis of the hat recovered from V.T. The report indicated that following:
 - From the sample taken from the interior side of the crown of the hat, Thompson cannot be excluded as a possible contributor to the DNA mixture. Using the most conservative frequency estimate calculated, approximately 131,200 unrelated individuals would have to be evaluated before expecting to find an individual that would have a DNA profile that cannot be excluded as a possible contributor to the mixed DNA profile from this item of evidence.
 - From the sample taken from the interior top of the crown of the hat, Thompson cannot be excluded as a possible contributor to the DNA mixture. Using the most conservative frequency estimate calculated, approximately 224,800 unrelated individuals would have to be evaluated before expecting to find an individual that would have a DNA profile that cannot be excluded as a possible contributor to the mixed DNA profile from this item of evidence.

All of this occurred within the City and County of Honolulu, State of Hawaii;

WHEREFORE, your affiant respectfully prays that based upon the facts and circumstances contained in this affidavit, a warrant of arrest be issued for the arrest of Eric Thompson for the charges of Murder in the Second Degree and of Carrying or Use of Firearm in the Commission of a Separate Felony; that said Eric Thompson be brought forthwith before this Judge or detained subject to the order of this Court or any other court in which the offense to which the said Eric Thompson is triable for violation of Section 707-701.5 and 706-656 and Section 134-21, of the Hawaii Revised Statutes.
