Page County Attorney, James L. Varley, reports the following activities in the Iowa District Court for Page County for the week of August 4, 2025. The Honorable Jennifer Benson Bahr, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Scott Edward Biekkola Jr., age 39, Omaha, Nebraska, appeared by counsel and admitted to violating the terms and conditions of his probation. The Defendant's probation was revoked and the original sentence of 5 years was imposed.

Helena Jean Dietl, age 64, Clarinda, Iowa, appeared with counsel and pled guilty to Possession with Intent to Deliver Methamphetamine. The defendant was sentenced to 10 years in prison, suspended. The Defendant was placed on probation for two years and ordered to obtain a drug/alcohol evaluation and follow any recommendations. Defendant was ordered to pay a fine of \$1,000, suspended, surcharges and court costs.

Aaron Lee Gardner, age 24, Shenandoah, Iowa, appeared by counsel and pled guilty to Operating While Under the Influence-1st Offense. The defendant was sentenced to 45 days of incarceration and fined \$1,250. All but 2 days of the term of incarceration was suspended and the Defendant was placed on probation for 9 months. As a condition of probation, the defendant is to obtain a drug/alcohol evaluation and successfully complete the Drinking Driver's School. The defendant was ordered to pay court costs, surcharges and court-appointed attorney fees.

Abbigale D Marsh, age 21, Pittsburg, Kansas, appeared by counsel and pled guilty to Possession of a Controlled Substance, Marijuana. The defendant was fined \$430 and ordered to pay court costs, surcharges and court-appointed attorney fees.

Adam Wayne Morris, age 47, Clarinda, Iowa, appeared by counsel and pled guilty to Theft in the 3d Degree. The defendant was sentenced to 4 days in jail, with credit for time served. Defendant was ordered to pay a fine of \$855, suspended, restitution, surcharges and court costs.

Kristi Kay Smith, age 52, Sumner, Iowa, appeared by counsel and pled guilty to Obstructing Justice-Failure to Report. The defendant received a deferred judgment and was placed on probation for 9 months. A civil penalty in the amount of \$855 was assessed and the defendant was ordered to pay court costs.

Mileena Jade Villanueva, age 27, Clarinda, Iowa, appeared by counsel and pled guilty to Child Endangerment Without Injury. The defendant received a deferred judgment and was placed on probation for 2 years and ordered to obtain a drug/alcohol evaluation and follow any recommendations. A civil penalty in the amount of \$855, suspended and the Defendant was ordered to pay court costs.
