Unit 2 was traveling westbound and was in the turning lane to head north. Unit 1 did not see unit 2 in the turning lane and sideswiped unit 2 hitting in the front of both vehicles and disabling both vehicles front tires and wheels. No injuries reported at the accident.

Unit 1 was traveling north on Levi rd. Unit 1 loss traction while traversing downhill when he lost control of his vehicle driving to fast for weather conditions. Unit 1 then started to slid towards the west ditch and went into the west ditch causing him to roll the vehicle multiple times. Unit 1 was found by a witness to the accident stating unit 1 had lost control at the top of the hill and rolled when he hit the ditch. Unit1 was unable to keep control of his motor vehicle. The vehicle is a total loss.
