ON 07-28-2015, I WAS NOTIFIED OF A SINGLE VEHICLE ACCIDENT. THE CALLER SAID THE DRIVER WAS UNHARMED AND DID NOT WANT RESCUE. THE DRIVER COULD NOT BE LOCATED WHEN I ARRIVED ON SCENE. SHE ARRIVED SHORTLY AFTER, AND SAID SHE WAS PICKED UP BY A RELATIVE. THE DRIVER SAID, AT APPROXIMATELY 2115 HOURS VEHICLE 1 WAS TRAVELING SOUTH ON LEVI RD. THE DRIVER OF VEHICLE 1 SAID SHE WAS TRAVELING APPROXIMATELY 55 MPH WHEN IT BEGAN TO RAIN. THE DRIVER SAID THAT SHE WAS NEAR THE CURVE WHEN HER TIRES HIT THE SAND AND LOOSE DIRT AND SHE LOST TRACTION. Unit 1 was traveling west bound on Bunge Ave. Unit 1 was traversing a slight curve to the left. There are skid marks showing that Unit 1 abruptly changed directions in the roadway and over corrected the steering causing a loss of control. The vehicle went into the north ditch and the front end pushed into the dirt. The vehicle then turned back west and appears to have slid on it's side until reaching Allis Rd where the embankment brought the car up, and flipped it to its roof, sliding across the gravel. The vehicle came to a rest in the northwest ditch of the intersection of Bunge Ave and Allis Rd.
