Page County Attorney, Carl M. Sonksen, reports the following activities in the Iowa District Court for Page County for the week of July 29, 2024. The Honorable Craig M. Dreismeier, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Richard Eugene Auffert Jr., age 62, Clarinda, Iowa, appeared by counsel and entered a plea of guilty to Operating While Intoxicated-2nd Offense. The Defendant was sentenced to 60 days in jail, with all but 7 days suspended. Defendant was placed on probation for 9 months and was ordered to complete a substance abuse evaluation and the drinking driver's program as conditions of probation. The Defendant was ordered to pay a fine of \$1,870, court costs and surcharges.

William Harold Bailey, age 43, Shenandoah, Iowa, appeared with counsel and admitted to violating the terms and conditions of his probation. Defendant's probation was revoked and the original sentence of ten years was imposed. Defendant was ordered to reside at the Residential Correctional Facility in Council Bluffs, Iowa until maximum benefits have been achieved.

Riley Dale Kelcey Christie, age 36, Clarinda, Iowa, appeared by counsel and pled guilty to Criminal Mischief in the Third Degree. The Defendant was granted a deferred judgment for a period of two years. Defendant was placed on probation for two years and assessed a civil penalty of \$8540. Defendant is ordered to pay restitution to Lincoln Lawn Care in the amount of \$3,850.15, court costs and surcharges.

Devonci D. Combs, age 25, Shenandoah, Iowa, appeared by counsel and pled guilty to Assault. The Defendant was sentenced to 19 days in jail and a fine of \$105. Defendant was ordered to pay surcharges, court costs and court-appointed attorney fees.

Lissa J. Dunkeson, age 37, Shenandoah, Iowa, appeared by counsel and entered a plea of guilty to Domestic Abuse Assault With Intent to Inflict Serious Injury. The Defendant was granted a deferred judgment for 12 months. Defendant was placed on probation for 12 months and shall complete the Iowa Domestic Abuse Program. The Defendant was ordered to pay court costs, surcharges and court-appointed attorney fees.

Chris Bobbie Eickemeyer, age 58, Clarinda, Iowa, appeared by counsel and entered a plea of guilty to Operating While Intoxicated-1st Offense. Defendant was sentenced to 45 days in jail, with all but 2 days suspended. The Defendant was placed on probation for 9 months and was

ordered to complete a substance abuse evaluation and the drinking driver's program as conditions of probation. A \$1,250 fine was imposed, and the Defendant was ordered to pay court costs and surcharges.

Andria Marie Flynn, age 42, Shenandoah, Iowa, appeared with counsel and admitted to violating the terms of her probation. Defendant was found in violation of the terms of her probation and extended her probation 5 months. The Defendant was ordered to pay court costs and court-appointed attorney fees.

Andrew Travis Gaunt, age 35, Clarinda, Iowa, appeared by counsel and pled guilty to three counts of Burglary 3rd Degree. The Defendant was sentenced to 5 years on each count, suspended and a fine of \$1025 on each count, suspended. The Defendant was placed on probation for 2 years. The Defendant was ordered to pay court costs and court-appointed attorney fees.

Andrew Travis Gaunt, age 35, Clarinda, Iowa, appeared by counsel and entered a plea of guilty to Burglary 3rd Degree. The Defendant was sentenced to 5 years on each count, suspended and a fine of \$1025 on each count, suspended. The Defendant was placed on probation for 2 years. The Defendant was ordered to pay court costs and court-appointed attorney fees.

Jules Lee Daniel Gould, age 30, Shenandoah, Iowa, appeared by counsel and admitted to violating the terms of his probation. Defendant was found in contempt and is sentenced to 29 days in jail, with credit for time served. The Defendant shall remain on probation and was ordered that upon release from jail he sign up for probation. The Defendant was ordered to pay court costs, surcharges and court-appointed attorney fees.

Daniel Jude Kruse, age 34, Omaha, Nebraska, appeared by counsel and entered a plea of guilty to Possession of Methamphetamine. The Defendant was granted a deferred judgment for 9 months and is placed on probation for 9 months. The Defendant was ordered to complete a substance abuse evaluation and follow the recommendations. The Defendant was ordered to pay a civil penalty of \$430, court costs, and court-appointed attorney fees.

Dan Jude Kruse, age 34, Omaha, Nebraska, appeared by counsel and entered a plea of guilty to Operating While Under the Influence-1st Offense. The Defendant was placed on probation for 9 months and was ordered to complete a substance abuse evaluation and the drinking driver's program as conditions of probation. The Defendant was ordered to pay a civil penalty of \$1,250, court costs, surcharges and court-appointed attorney fees.

Elizabeth Marie Merriett, age 36, Shenandoah, Iowa, appeared with counsel and entered a plea of guilty to Child Endangerment. The Defendant was granted a deferred judgment and placed on probation for 1 year. The Defendant was ordered to complete a substance abuse evaluation and was ordered to pay a civil penalty of \$855, court costs, surcharges and court-appointed attorney fees.
