Page County Attorney, Carl M. Sonksen, reports the following activities in the Iowa District Court for Page County for the weeks of June 7, 2021. The Honorable James S. Heckerman, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Jacob Allen Cochran, age 39, Council Bluffs, Iowa, appeared with his attorney and admitted to violating the terms of his probation. The Defendant probation was revoked and his original sentenced of five years in prison was imposed.

Summer Brooke French, age 25, Shenandoah, Iowa, appeared with her attorney and admitted to violating the terms of her probation. The Defendant's probation was revoked and she was found in willful contempt of court. Defendant was sentenced to 30 days in jail.
