Page County Attorney, Carl M. Sonksen, reports the following activities in the Iowa District Court for Page County for the week of September 27, 2021. The Honorable Greg W. Steensland, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

Shawn Carlene Beard, age 50, Lenox, Iowa, appeared with her attorney and entered a guilty plea to Operating While Under the Influence, Second Offense. The Defendant was sentenced to 60 days in jail, with all but 14 days suspended and given credit for time served. Defendant was ordered to pay court costs, surcharges, court-appointed attorney's fees and a \$1,875 fine. The Defendant was placed on informal probation for one year and will obtain a substance abuse evaluation and complete the Drinking Driver's School.

Christopher Charles Bowers, age 40, Shenandoah, Iowa, appeared with his attorney and entered a guilty plea to Eluding Law Enforcement. The Defendant was sentenced to 365 days in jail, with all but 21 days suspended and given credit for time served. Defendant was ordered to pay court costs, surcharges, court-appointed attorney's fees and a \$855 fine, suspended. The Defendant was placed on informal probation for one year.

Defendant was ordered to pay court costs, surcharges, court-appointed attorney's fees and a \$1,250 fine on Count II and a fine of \$855 on Count II. The Defendant was placed on informal probation for one year and will obtain a substance abuse evaluation and complete the Drinking Driver's School.

The Defendant was sentenced to thirty days in jail, with all but 2 days suspended and given credit for time served. The Defendant was placed on informal probation for one year and will obtain a substance abuse evaluation and complete the Drinking Driver's School.
