**Page County Attorney, Carl M. Sonksen, reports the following activities in the Iowa District Court for Page County for the weeks of October 16, 2017 and November 2, 2017. The Honorable Kathleen A. Kilnoski, District Court Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.**

Kelsey Dawn Amos, age 24, St. Joseph, Missouri, appeared with her attorney, and pled guilty to Eluding. The Defendant was sentenced to three hundred and sixty four days in the county jail with credit for time served. The jail sentence is suspended and the defendant was placed on informal probation for a period of one year. The Defendant was fined \$315.00, ordered to pay fines, surcharges and court costs and court appointed attorney fees.

John Burson, age 40, Essex, Iowa, appeared with his attorney, and entered a guilty plea to charges of Disorderly Conduct. The Defendant was ordered to pay court costs, fines, surcharges, and court appointed attorney fees.

Maiah Lyn Caron, age 24, Kansas City, Missouri, appeared with her attorney and entered a written Waiver of Rights and Appearance and Plea of Guilty to Operating a Motor Vehicle While Intoxicated. The Defendant was sentenced to two days in the Page County Jail. The Defendant was given credit for the two days already served through the Second Chances weekend OWI Program. The Defendant completed her Substance Abuse Evaluation with no recommendations for treatment; therefor Defendant was not placed on informal probation. The Defendant was assessed the minimum fine of \$1,250.00. Half of the fine shall be waived if the Defendant shows proof of a valid license or permit within four months of the order. The Defendant was ordered to pay all applicable surcharges, court-appointed attorney fees, and court costs immediately.

Jared Douglas Comstock, age 21, Farragut, Iowa, appeared with his attorney and entered a written Waiver of Rights and Appearance and Plea of Guilty to Possession of a Controlled Substance, Marijuana. The Defendant was ordered to serve seven days in the jail with credit for any time previously served. The Defendant is assessed a \$315.00, suspended. The Defendant's driving privileges in the State of Iowa are revoked for 180 days. The Defendant was ordered to pay all fines, costs, court appointed attorney fees, and surcharges.

Melissa Lynn Gibson, age 36, Essex, Iowa, appeared with her attorney and entered a written plea of guilty to Operating While Intoxicated. The Defendant was sentenced to thirty days in jail, with all but two days suspended. The Defendant was fined \$1,250.00 and taxed the court costs expenses and surcharges. One half of the fine shall be waived if the Defendant files proof of a valid driver's license within four months of sentencing date. The Defendant was authorized to enter the Urban Dreams/Weekender Program to satisfy 48 hours of incarceration ordered. The Defendant was placed on Informal Probation for a period of one year. The Defendant shall obtain a substance abuse evaluation and follow all treatment recommendations, receive no criminal law violations, attend and successfully complete the Drinking Driver's School and pay all restitution, fines and court costs associated herein. The Defendant was ordered to pay fines, court costs, surcharges, expenses and restitution assessed as substantiated.

Seth Kuipers, age 39, Clarinda, Iowa, appeared with his attorney and entered a plea of guilty to Possession of a Controlled Substance with Intent to Deliver Methamphetamine and Tax Stamp Violation. The Defendant was sentenced to a term not to exceed ten years for Possession and a term not to exceed five years for the Tax Stamp Violation; sentences are to run concurrent. The Defendant was given credit for time served. Defendant's sentences are suspended and the Defendant was placed on formal probation for a period of three years. Conditions of probation include having no arrests, obtaining an alcohol and substance abuse evaluation and follow recommendations for treatment. The Defendant's driving privileges are revoked for a period of one hundred eighty days. The Defendant was fined a total of \$1,750 for both counts, ordered to pay fines, court costs, surcharges, attorney fees immediately.

Jill Christine Currin, age 39, Braddyville, Iowa, appeared with her attorney and pled guilty to Assault on Persons Engaged in Certain Occupations. The Defendant was sentenced to two years in prison, all suspended. She was placed on informal probation for one year and fined \$625.00. The Defendant was ordered to pay fines, penalties and surcharges, court costs, and court appointed attorney fees.

Amanda Marie Sprinkel, age 28, Council Bluffs, Iowa, appeared wither attorney and entered a plea of guilty to Unlawful Possession of a Prescription Drug. The Defendant was sentenced to sixty days in the Page County Jail with credit for time served. The Defendant was fined \$315.00, ordered to pay surcharges, court costs, and court appointed attorney fees. The Defendant's driver's license was suspended for one hundred eighty days. The Defendant was placed on informal probation for a period of one year

Edward Paul Swanson, age 57, Braddyville, Iowa, appeared with his attorney and submitted a written plea of guilty to Possession of a Controlled Substance, Methamphetamine. The Defendant was sentenced to a period of sixty days in the Page County Jail, suspended. The Defendant was placed on Informal Probation for one year. The Defendant's driving privilege was suspended for a period of one hundred eighty days. The Defendant was fined \$315.00, ordered to pay all court costs, surcharges, and court appointed attorney fees.

Rex York, age 68, Cherokee, Iowa, appeared with his attorney and was found guilty by Trial of Indecent Exposure. The Defendant was sentenced to ninety days in the County Jail. The Defendant was ordered to register with the County Sheriff within five days of release from custody and shall complete all necessary sex offender registry forms and pay the sex offender registration fee. The Defendant was ordered to pay a civil penalty of \$250.00, assessed court costs, and court appointed attorney fees.

James Michael Rollinson Jr., age 34, Clarinda, Iowa, appeared with his attorney and pled guilty to Operating While Intoxicated. The Defendant was ordered to serve two days in Page County Jail, ordered to pay a fine of \$1,250.00. Half of fine shall be waived if Defendant shows proof of a valid license or permit within four months of the sentencing date. The Defendant was given credit for any time previously served. The Defendant completed the Second Chance Program and is given credit for two days towards his jail sentence and the Defendant obtained a substance abuse evaluation with no further treatment recommended. The Defendant was ordered to pay all applicable court costs, surcharges and appointed attorney's fees. The Defendant's driving privileges were revoked for a period of one hundred eighty days.

Samuel Joseph Rainwater, age 22, Shenandoah, Iowa, appeared with his attorney and entered a guilty plea to Operating While Intoxicated. The Defendant was sentenced to thirty days in jail with all but two days suspended. The Defendant was given credit for time served. The Defendant was ordered to obtain a substance abuse evaluation and follow any recommendations. The Defendant was fined the minimum fine. All court costs, including court appointed attorney fees are taxed to the Defendant, fines, court costs, and surcharges are due immediately.

Tristan Reed, age 23, Clarinda, Iowa, appeared with his attorney and entered a Written Waiver of Rights and Appearance and Admission of Probation Violation. The Defendant's probation was revoked. The Defendant's original sentence was imposed. The Defendant was sentenced to thirty days in the county jail with all but two days suspended. The Defendant was discharged unsuccessfully from informal probation. The Defendant was ordered to pay all applicable surcharges, court appointed attorney fees, and court costs.

Garth Stacey, age 19, Shenandoah, Iowa appeared with his attorney and entered a written admission of violation of the terms and conditions of probation. The Defendant was held in contempt of court for failure to comply with the terms of his probation. The Defendant was sentenced to serve fifteen days in the Page County Jail. The Defendant was unsuccessfully discharged from probation and ordered to pay costs and restitution of court appointed attorney fees immediately.
